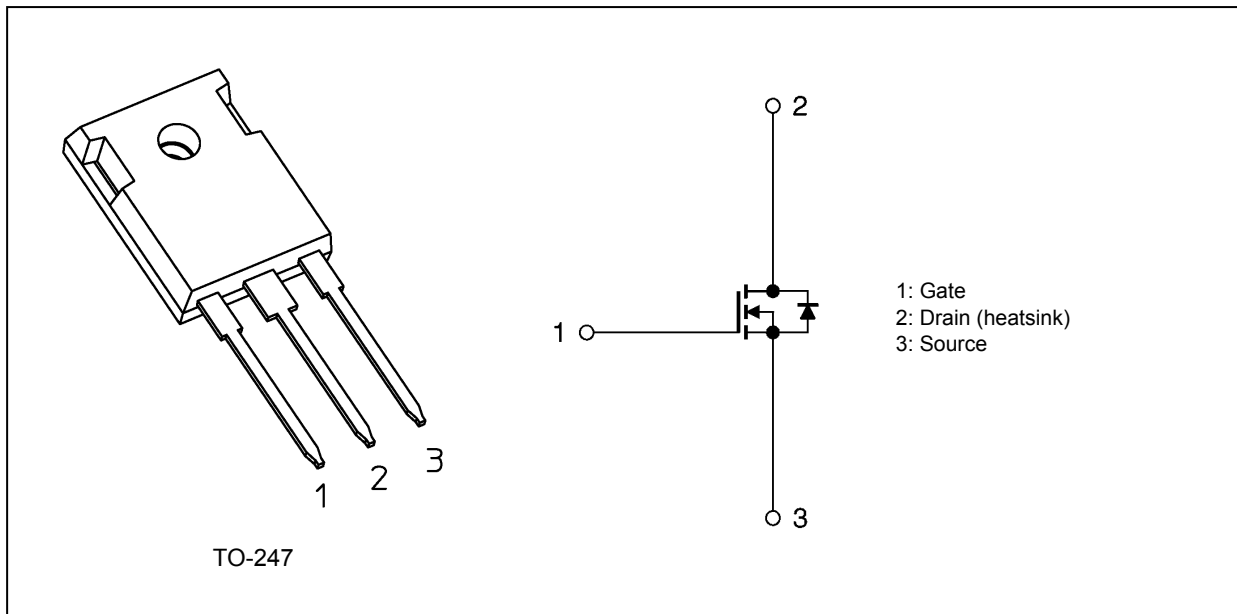

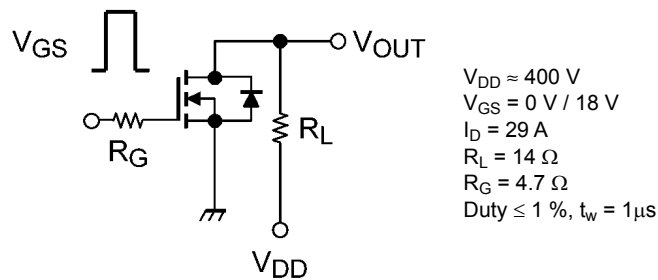


Fig. 6.2.1 Switching Time Test Circuit

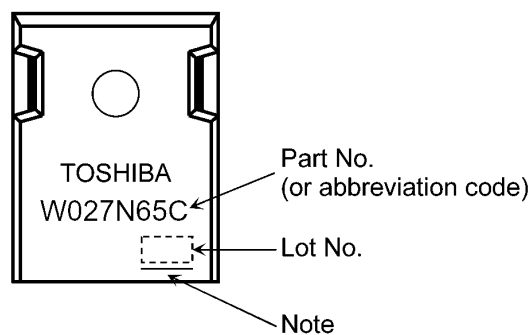

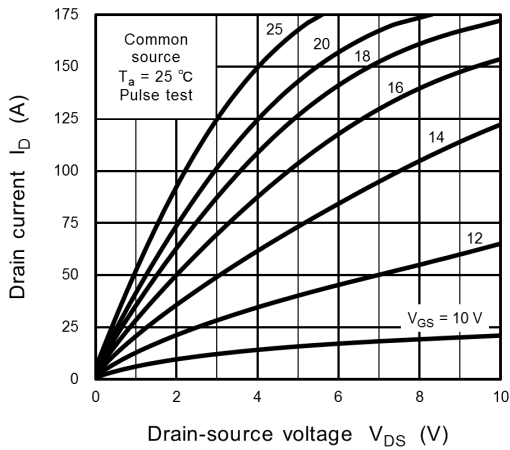


Fig. 8.1  $I_D - V_{DS}$

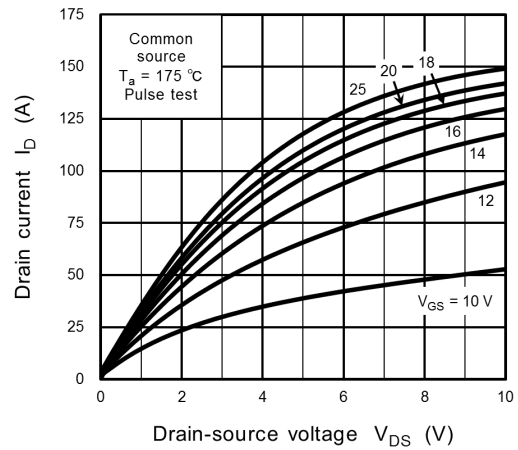


Fig. 8.2  $I_D - V_{DS}$

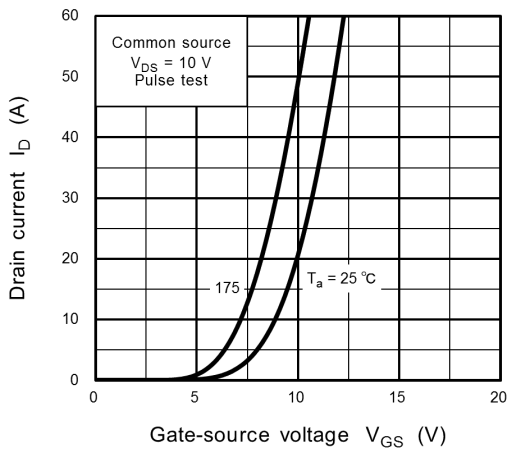


Fig. 8.3  $I_D - V_{GS}$

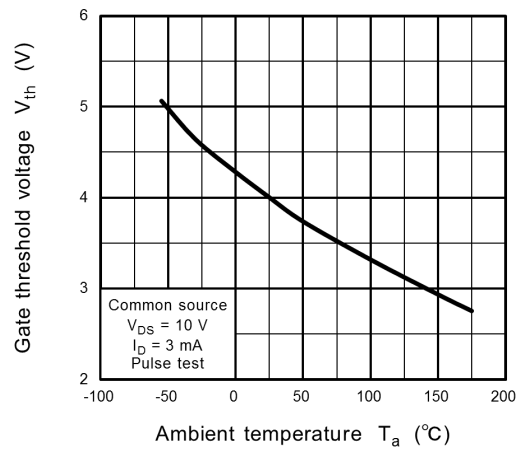


Fig. 8.4  $V_{th} - T_a$

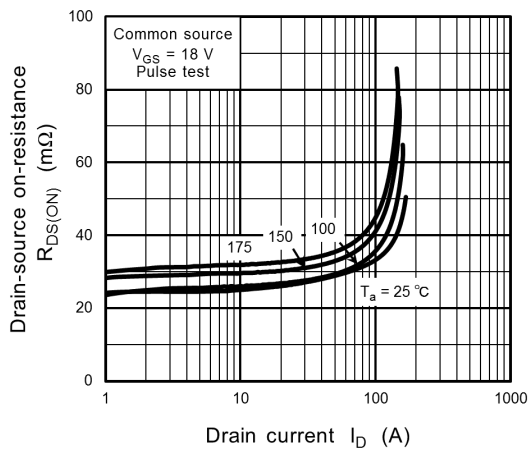


Fig. 8.5  $R_{DS(ON)} - I_D$

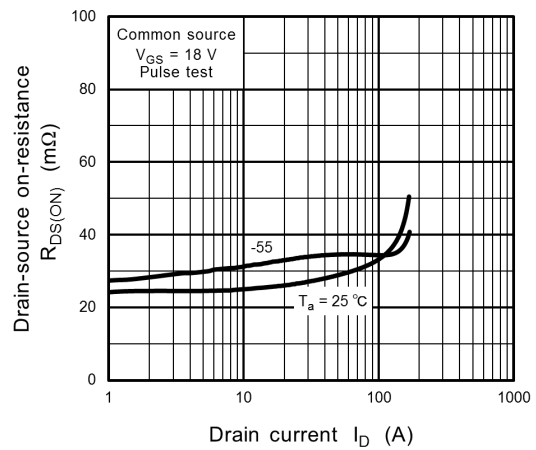
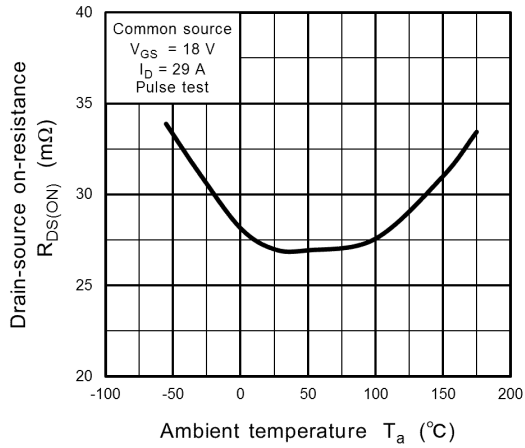
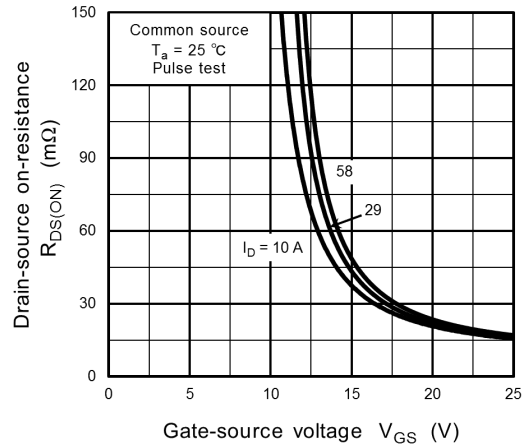


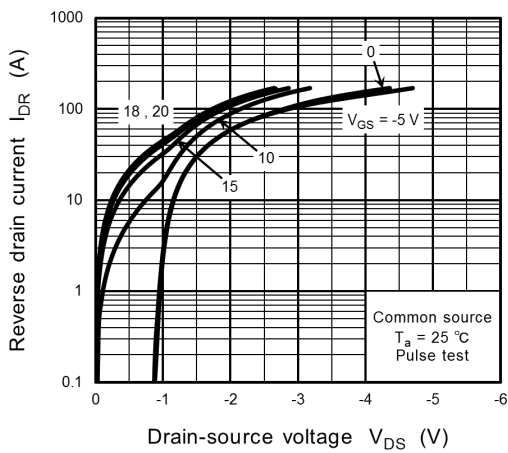
Fig. 8.6  $R_{DS(ON)} - I_D$



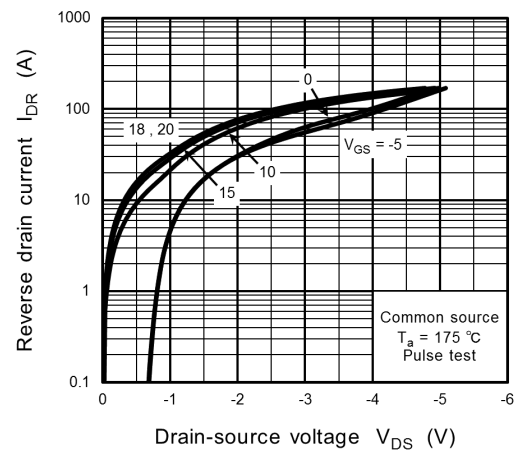
**Fig. 8.7  $R_{DS(ON)} - T_a$**



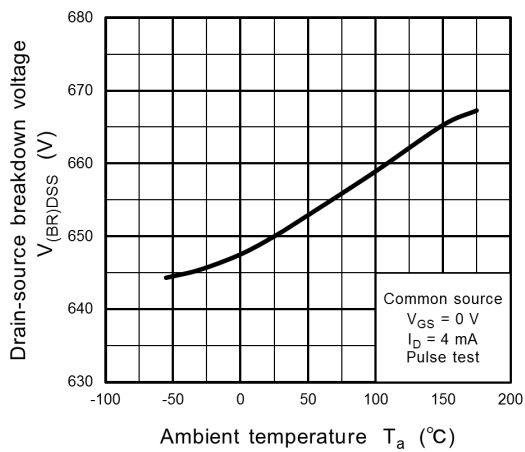
**Fig. 8.8  $R_{DS(ON)} - V_{GS}$**



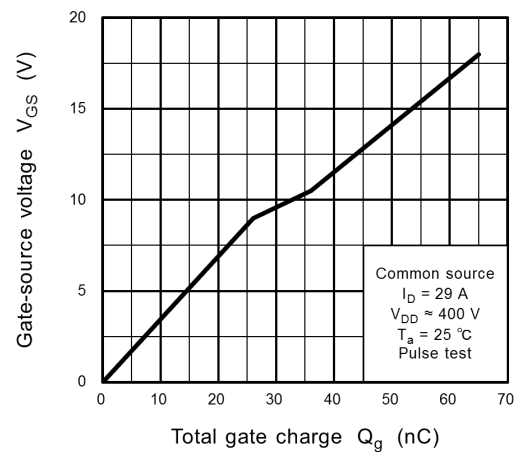
**Fig. 8.9  $I_{DR} - V_{DS}$**



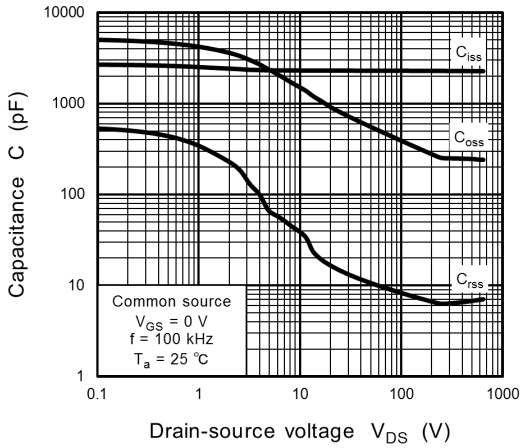
**Fig. 8.10  $I_{DR} - V_{DS}$**



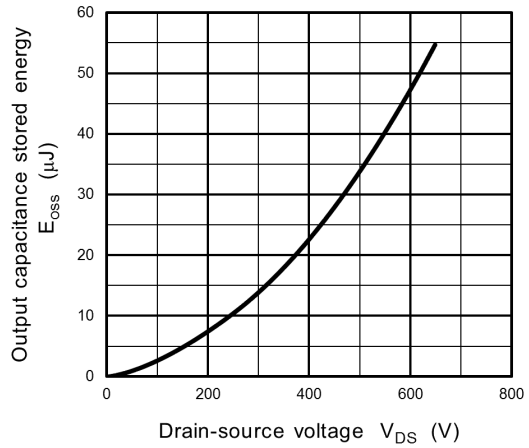
**Fig. 8.11  $V_{DSS} - T_a$**



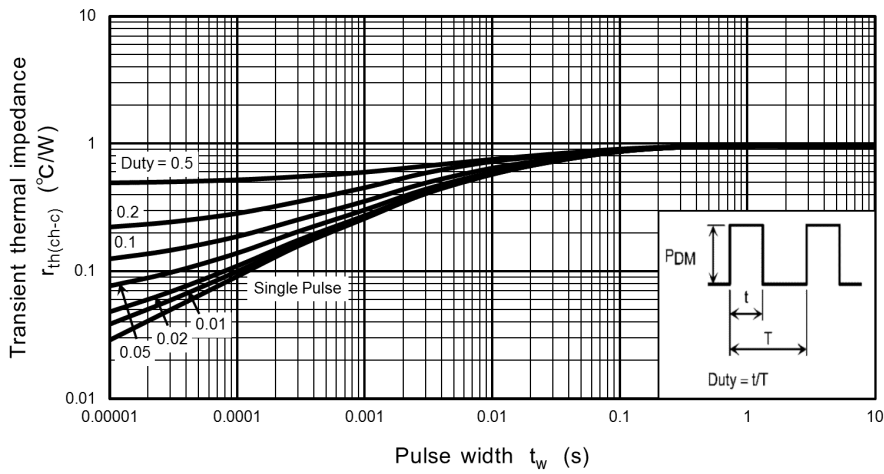
**Fig. 8.12 Dynamic Input Characteristics**



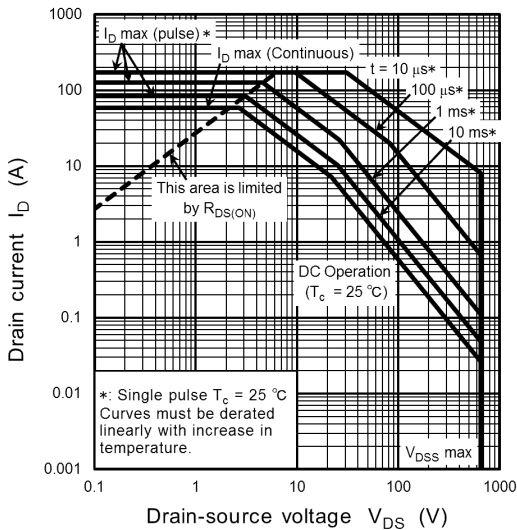
**Fig. 8.13 C - V<sub>DS</sub>**



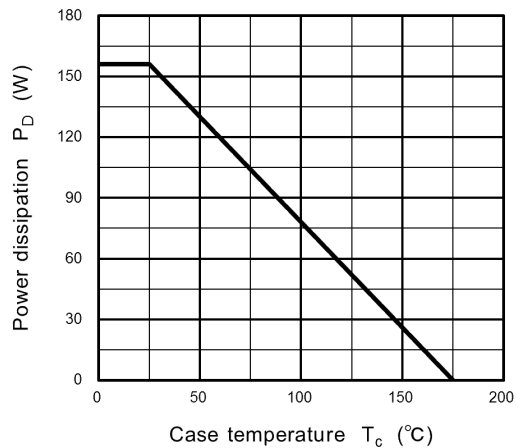
**Fig. 8.14 E<sub>OSS</sub> - V<sub>DS</sub>**

(Guaranteed Maximum)**



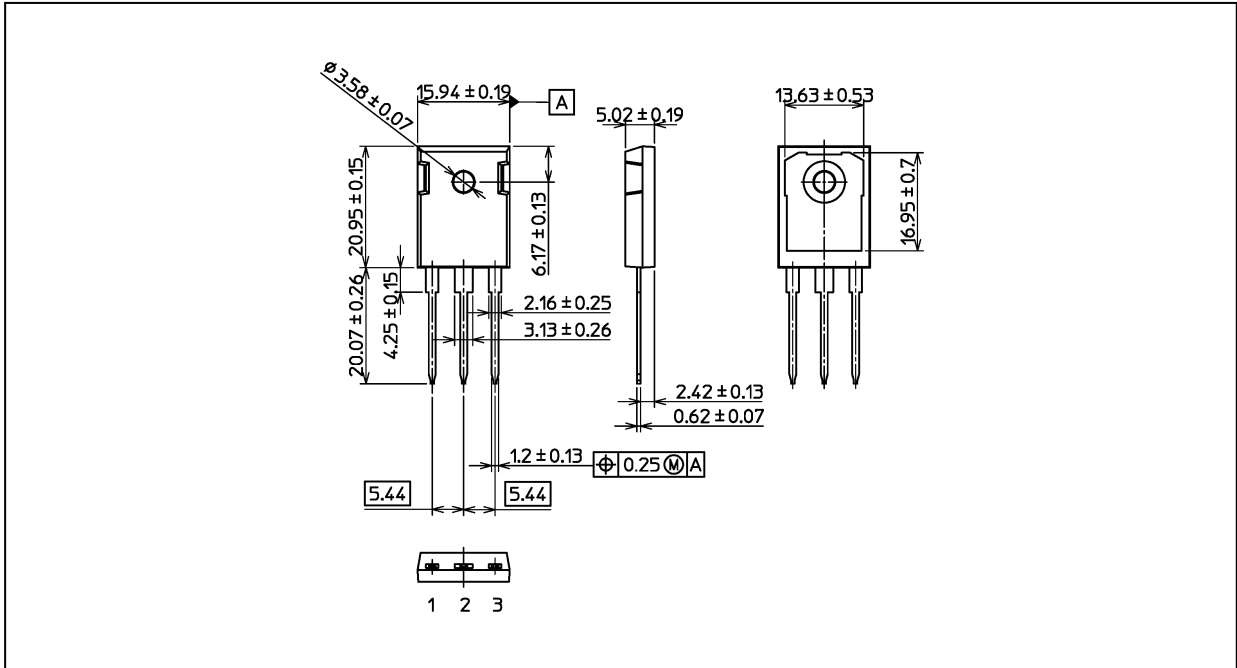
**Fig. 8.17 P<sub>D</sub> - T<sub>c</sub>
