











On-Resistance vs. Junction Temperature THERMAL RATINGS

Source-Drain Diode Forward Voltage






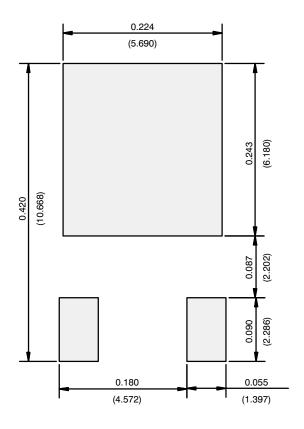
