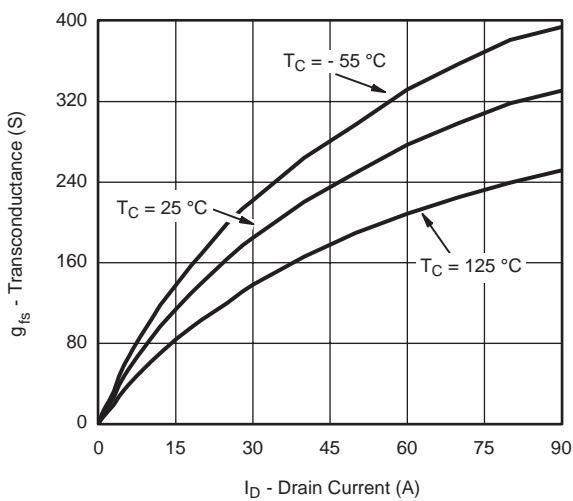

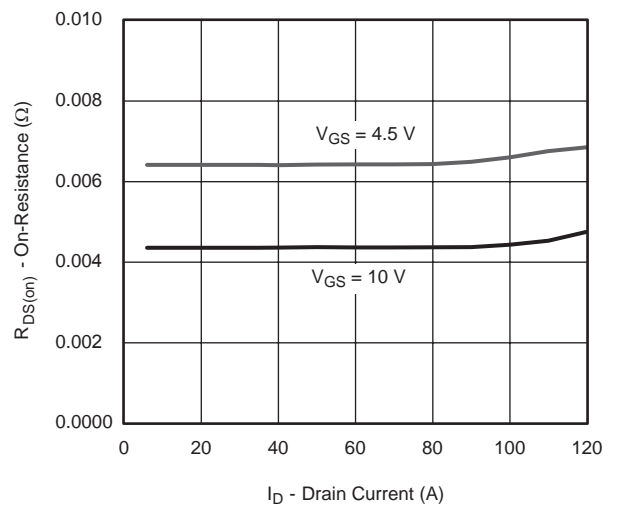

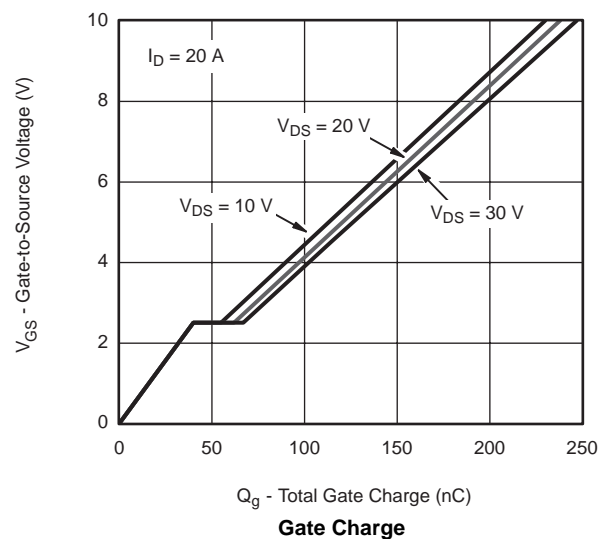
**Transconductance**



**On-Resistance vs. Drain Current**

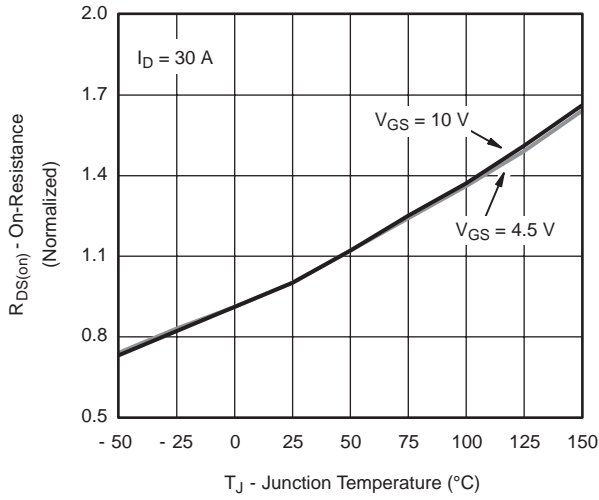


**Capacitance**

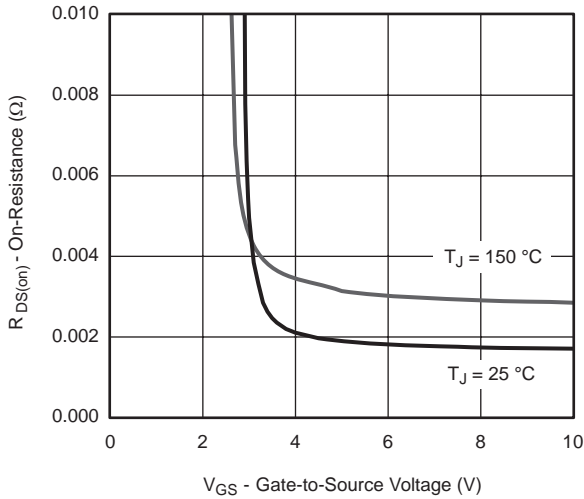

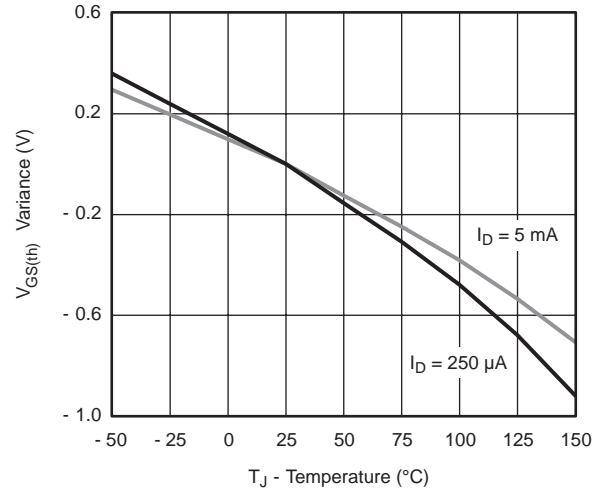
**On-Resistance vs. Junction Temperature**

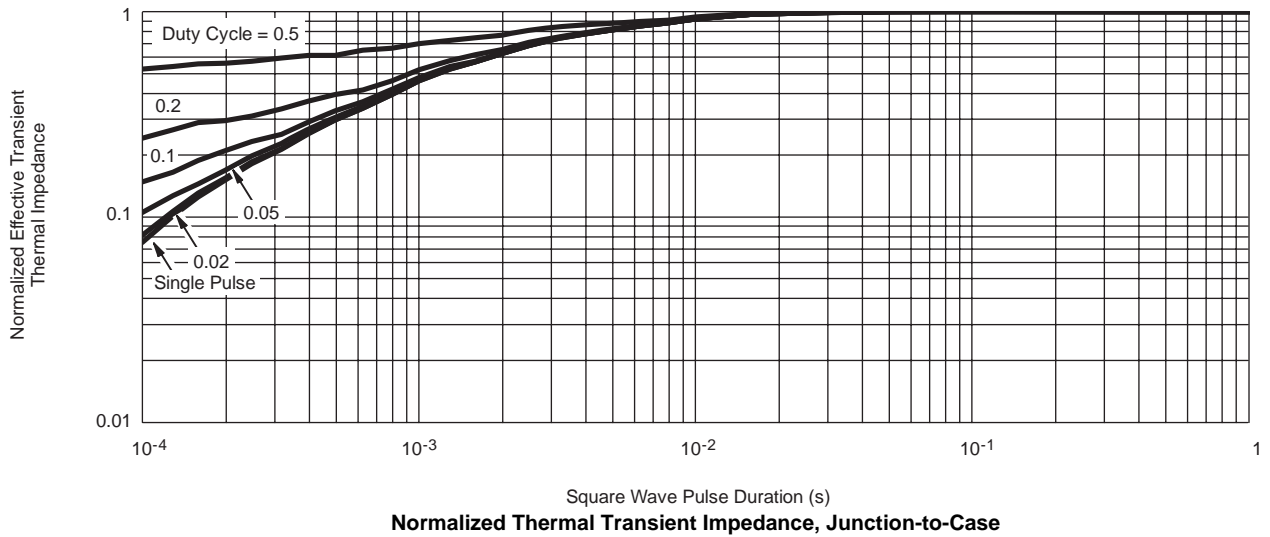
