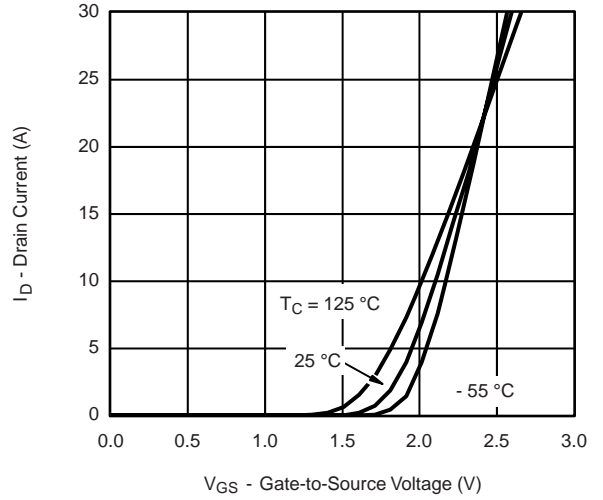

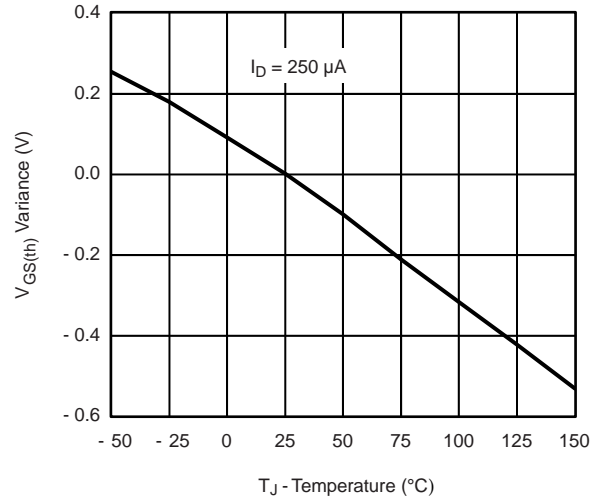

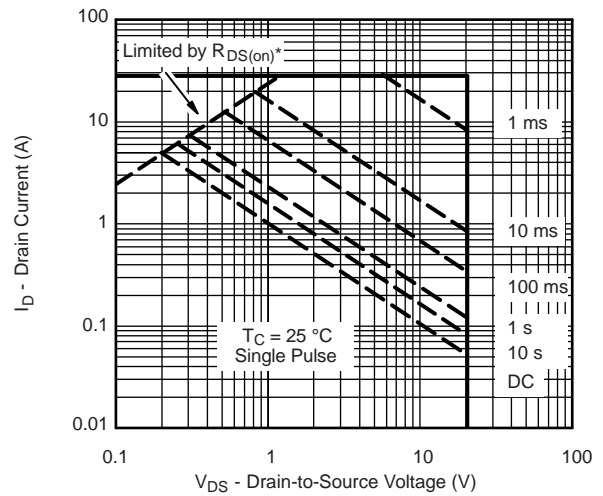
**On-Resistance vs. Gate-to-Source Voltage**

**Single Pulse Power**

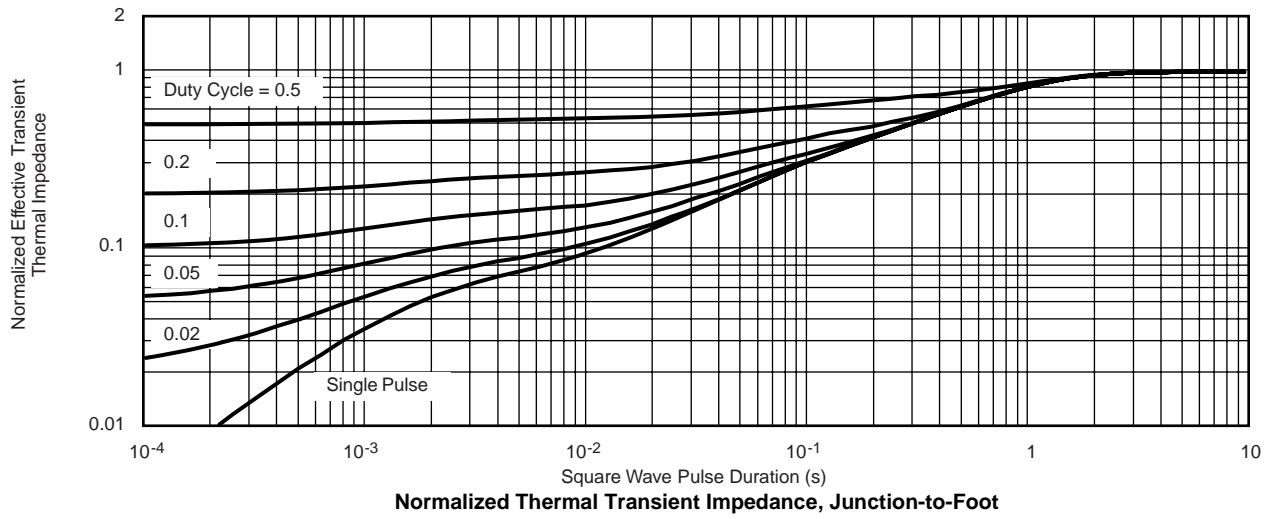


**Safe Operating Area, Junction-to-Case**



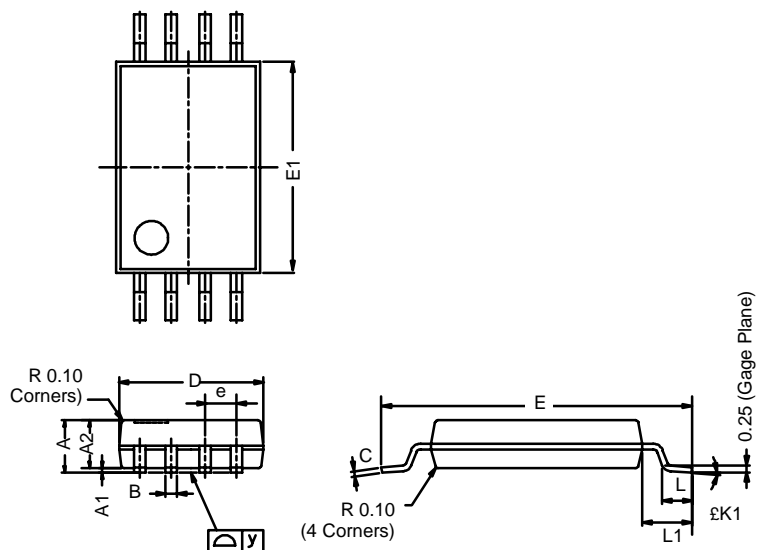
**Normalized Thermal Transient Impedance, Junction-to-Ambient**

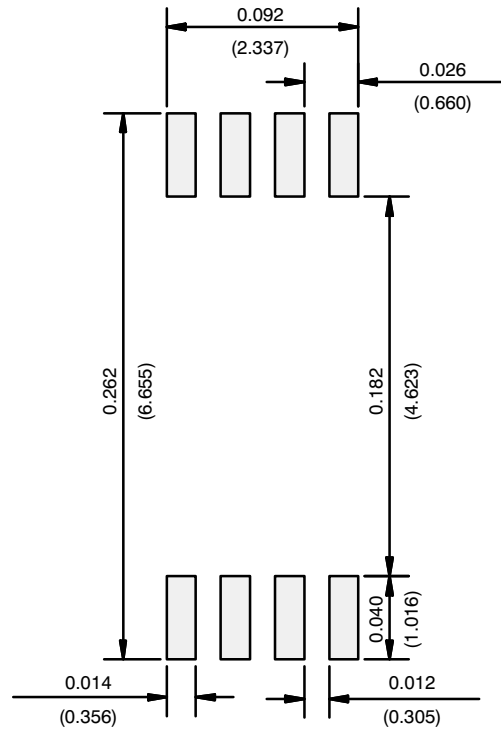
