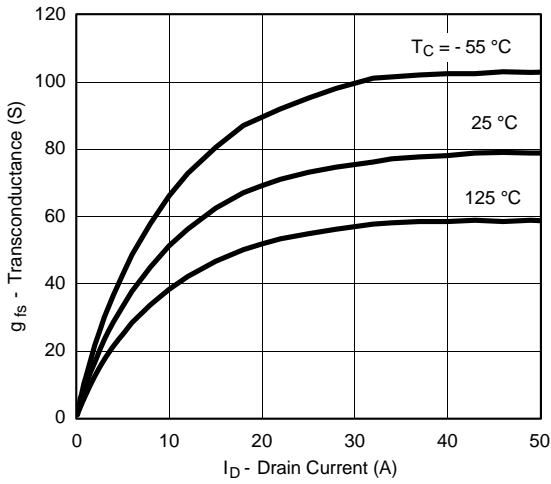

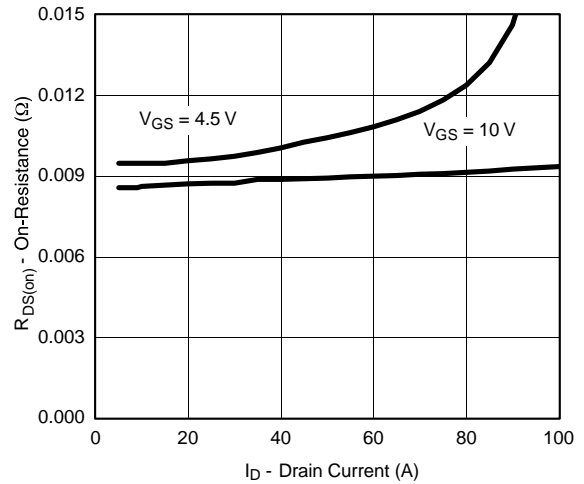

**Transfer Characteristics**



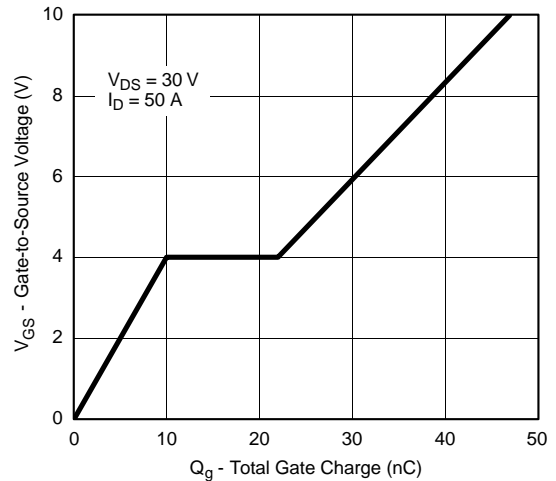
**Transconductance**

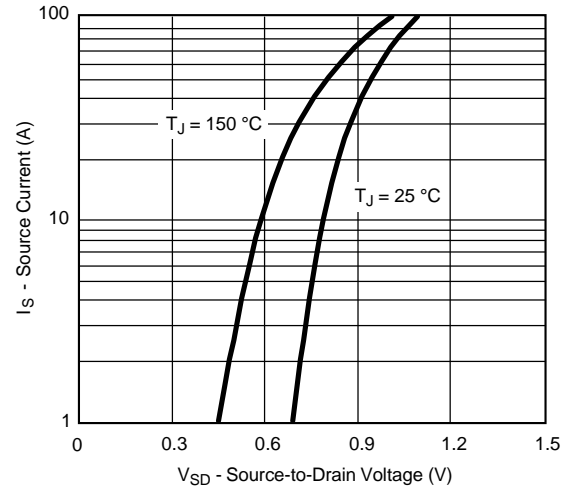

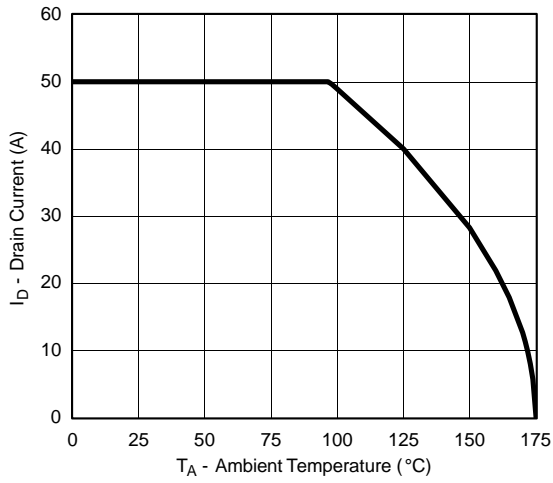


**On-Resistance vs. Junction Temperature**



**Source-Drain Diode Forward Voltage**

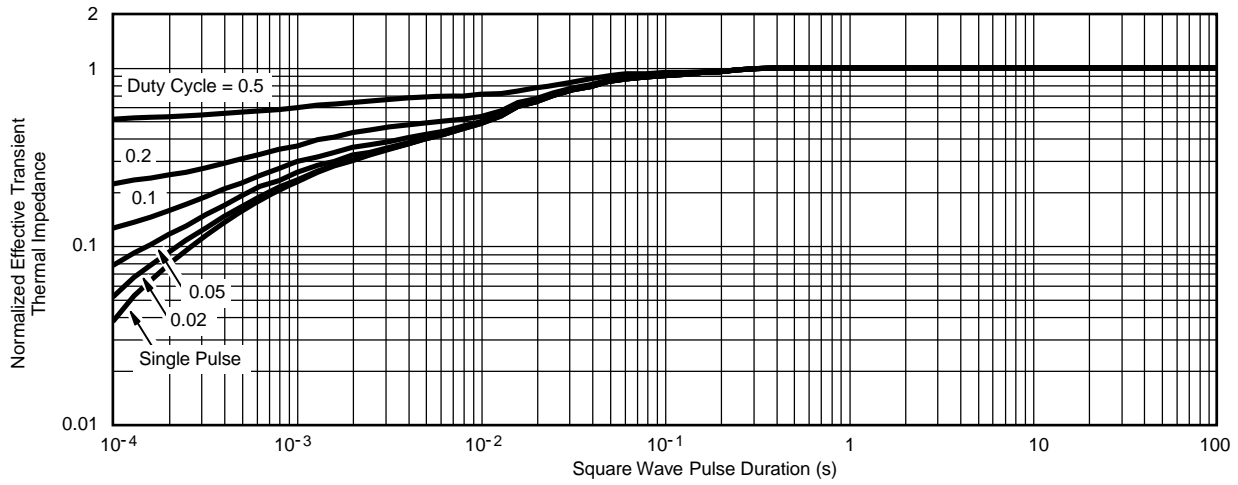
