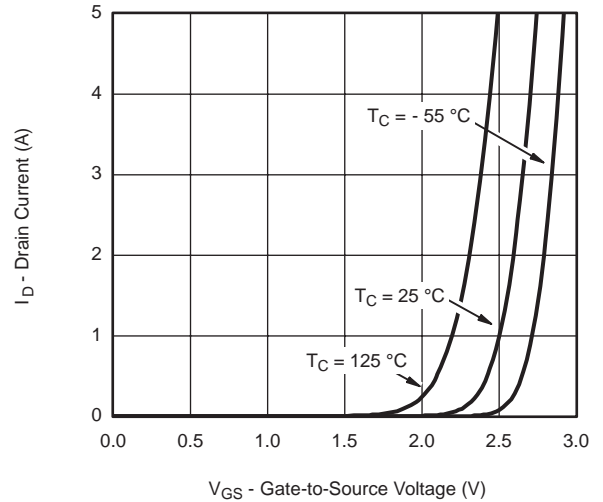

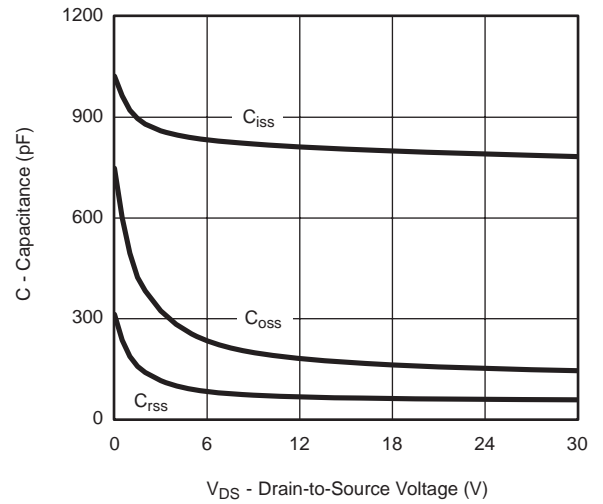

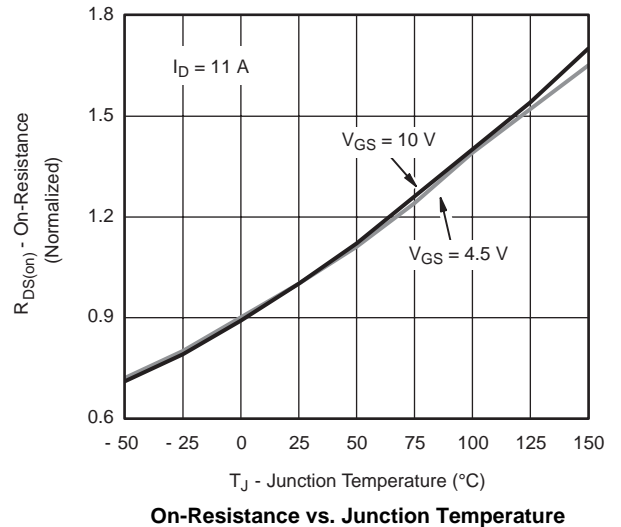
**On-Resistance vs. Drain Current and Gate Voltage**



**Capacitance**

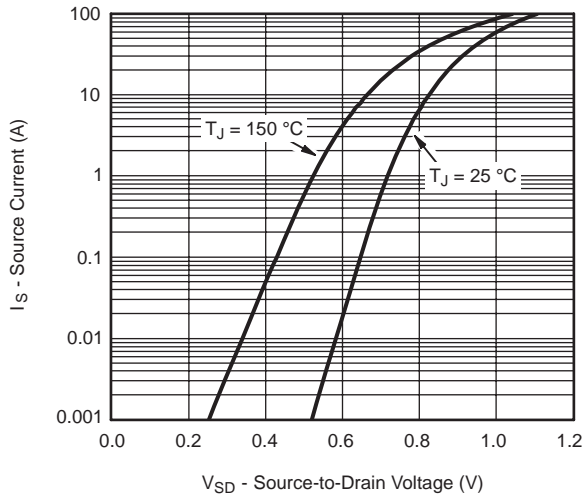


**Gate Charge**

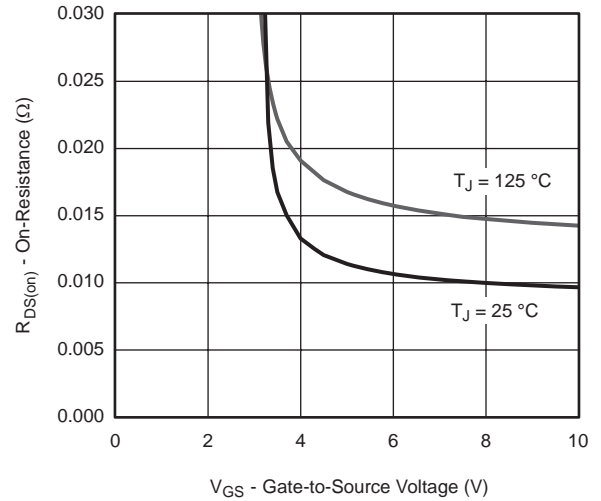


**On-Resistance vs. Junction Temperature**

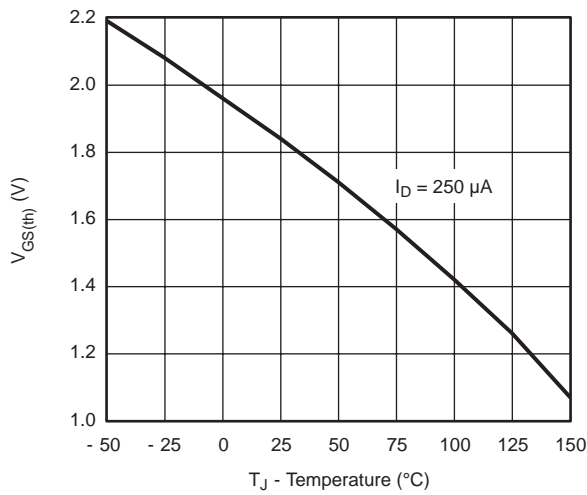

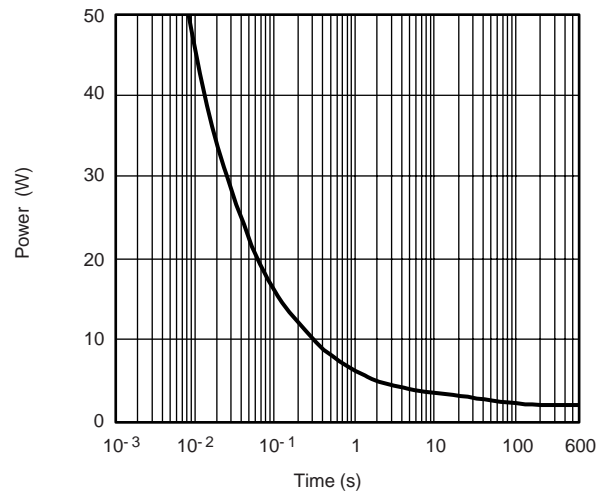
Source-Drain Diode Forward Voltage

Threshold Voltage



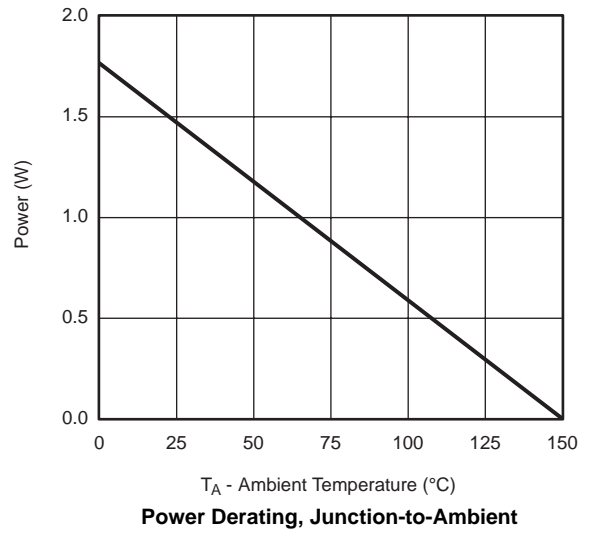
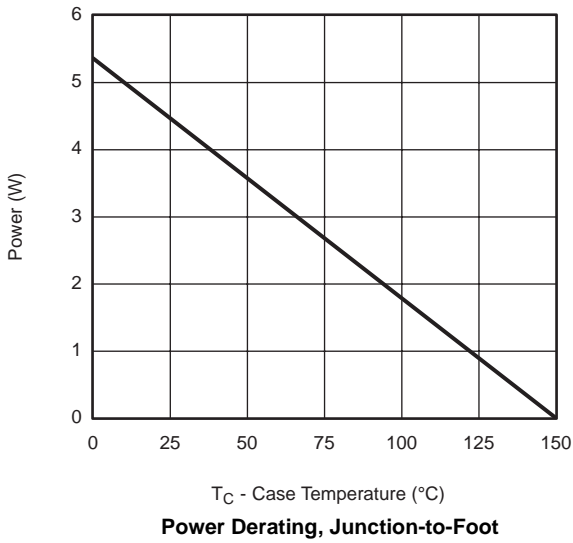
Single Pulse Power, Junction-to-Ambient
