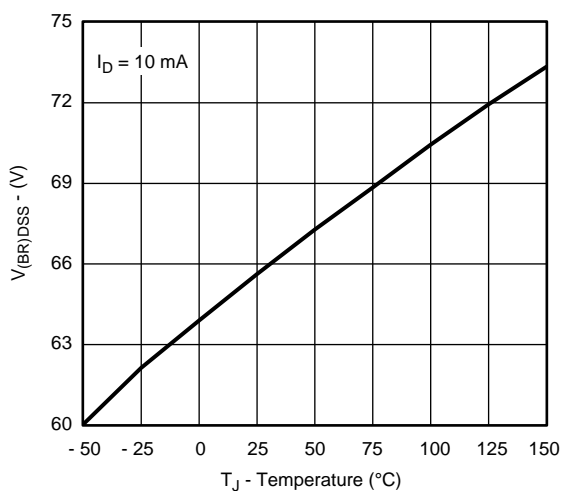
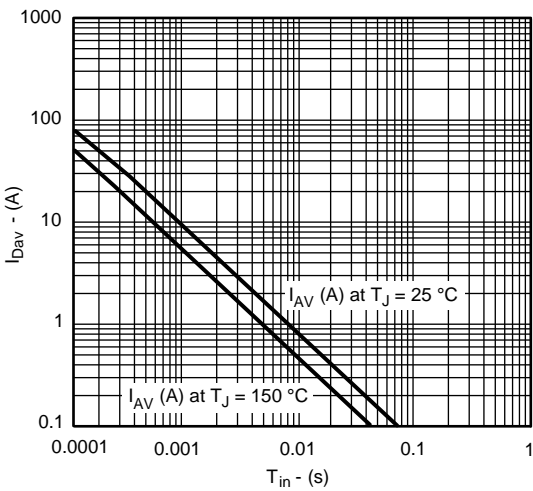
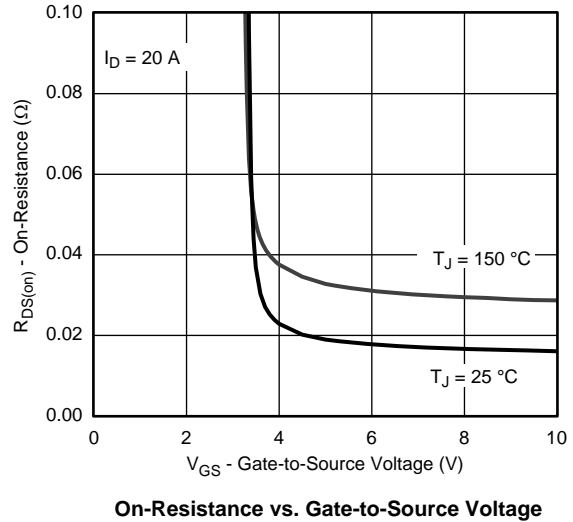
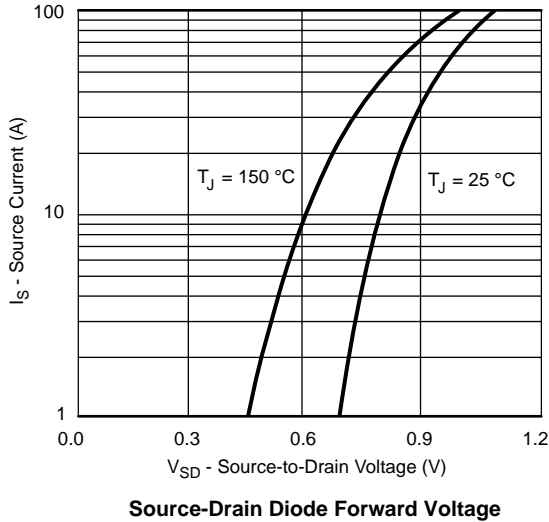
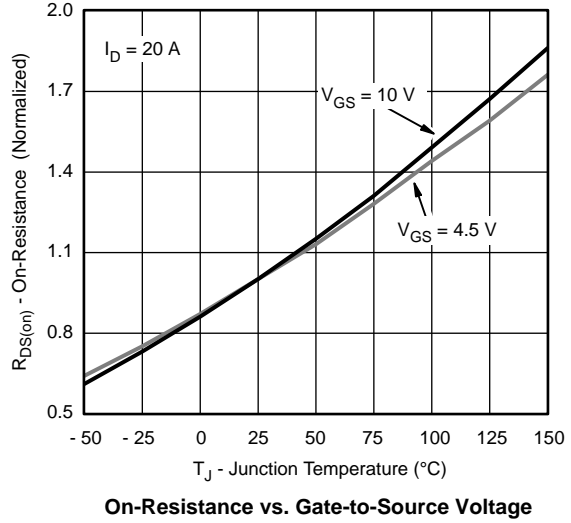
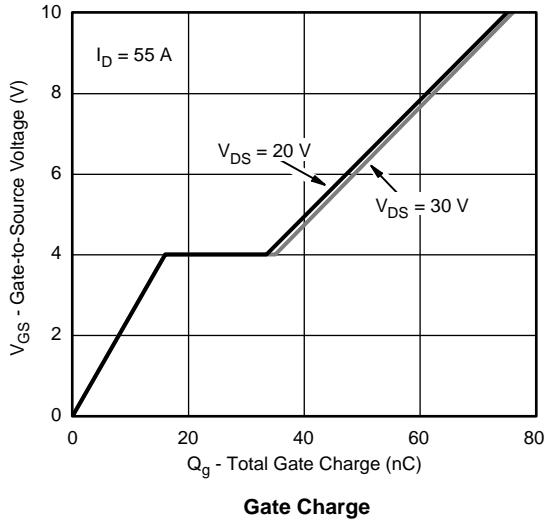


On-Resistance vs. Drain Current



Capacitance

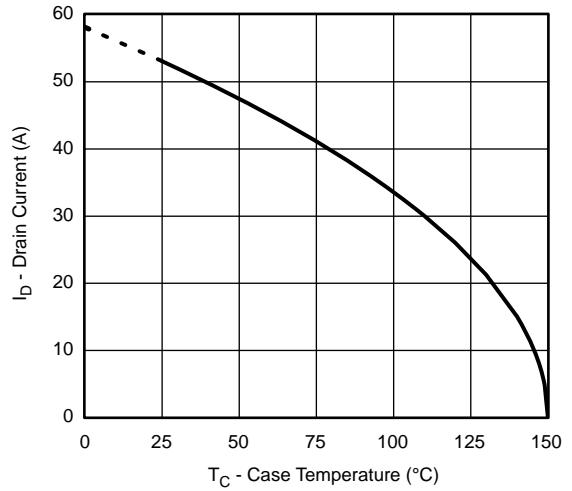

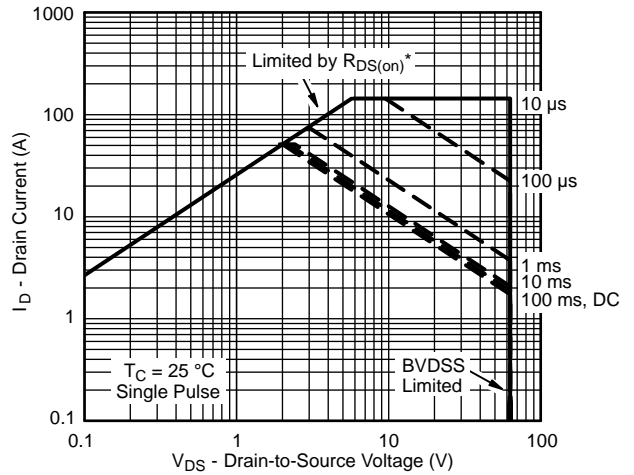
Threshold Voltage

Power Derating, Junction-to-Case



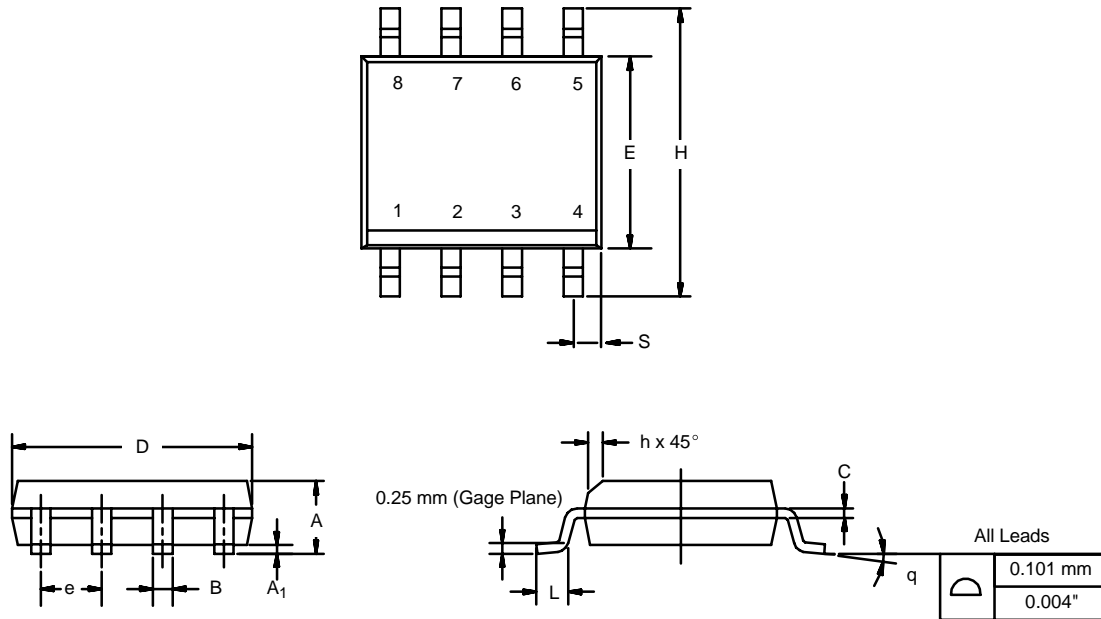
Safe Operating Area, Junction-to-Case
