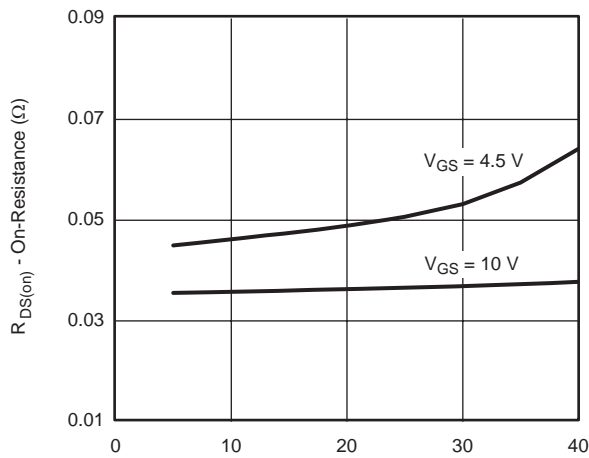

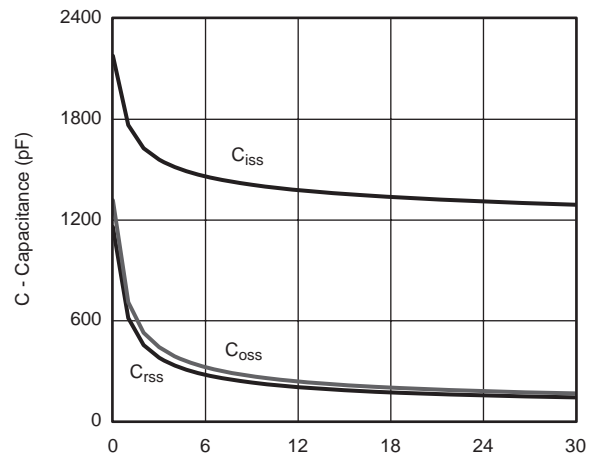
$V_{DS}$  - Drain-to-Source Voltage (V)

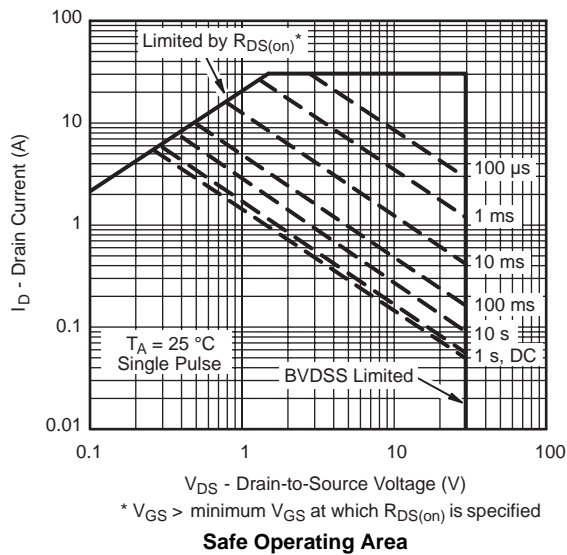
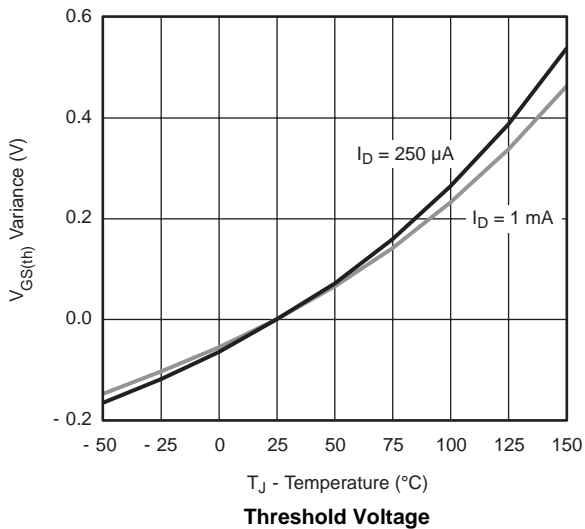
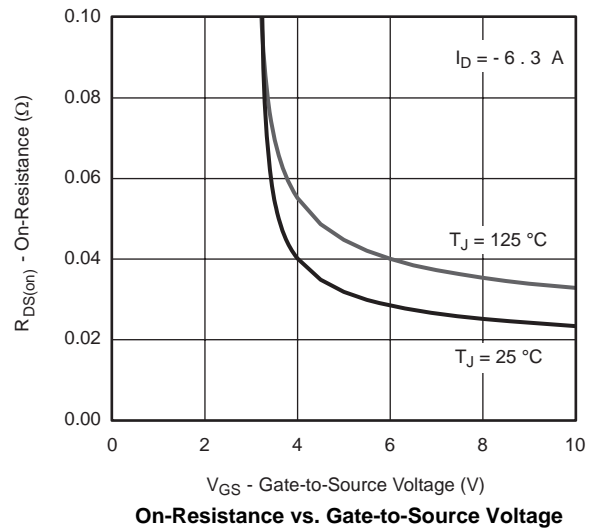


$Q_g$  - Total Gate Charge (nC)

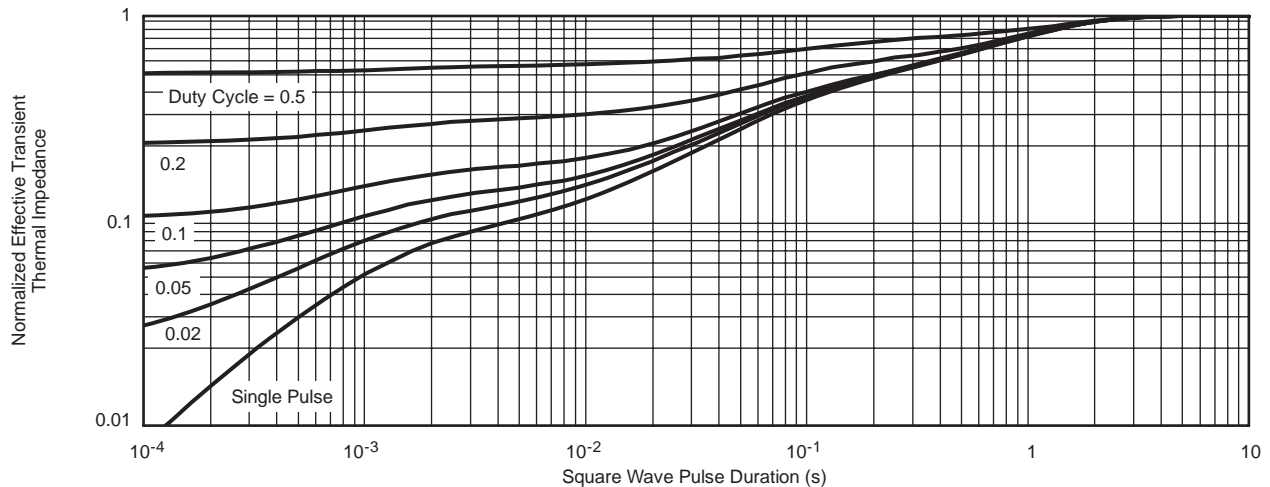
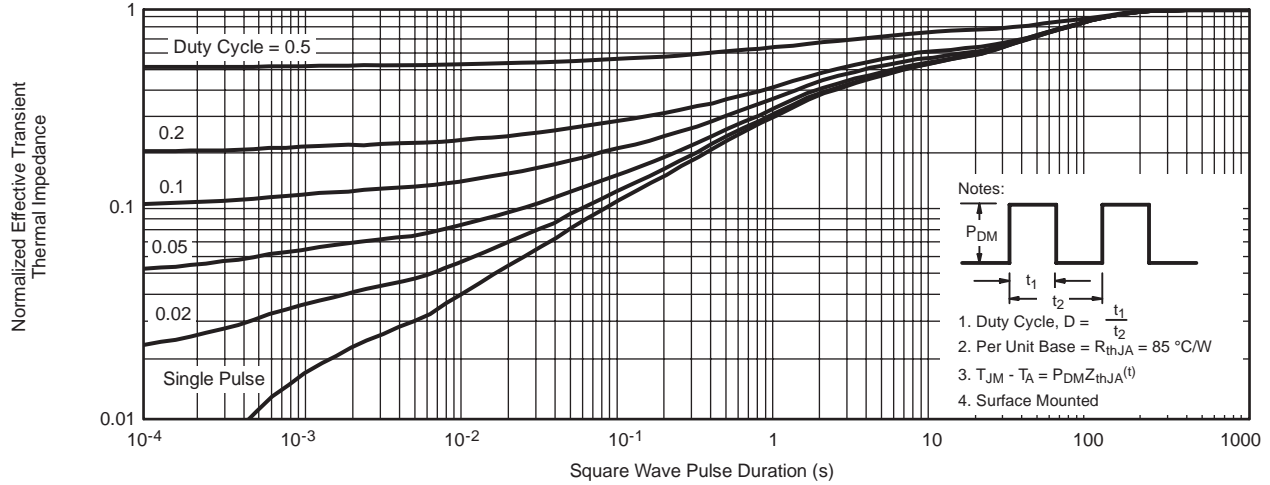
**Power, Junction-to-Foot**
