



TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)







TO-252AA CASE OUTLINE





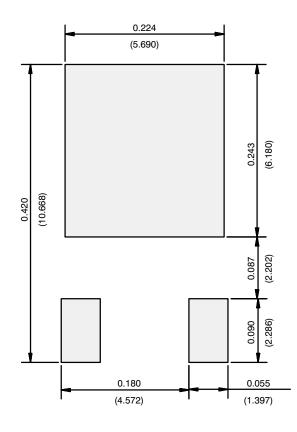
