

















On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient








 $T_{\mbox{\scriptsize C}}$  - Case Temperature (°C)









Normalized Thermal Transient Impedance, Junction-to-Foot




