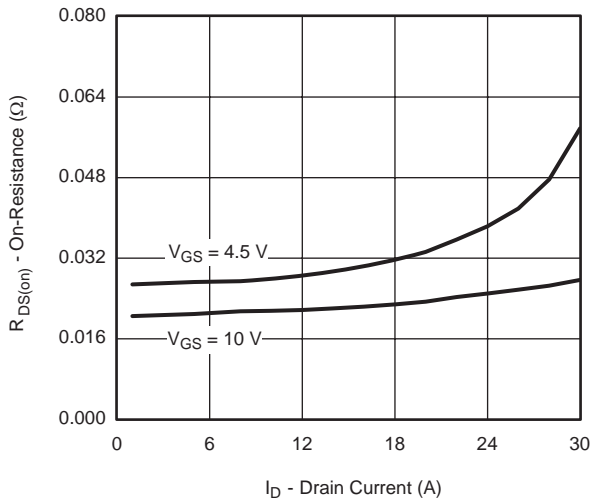

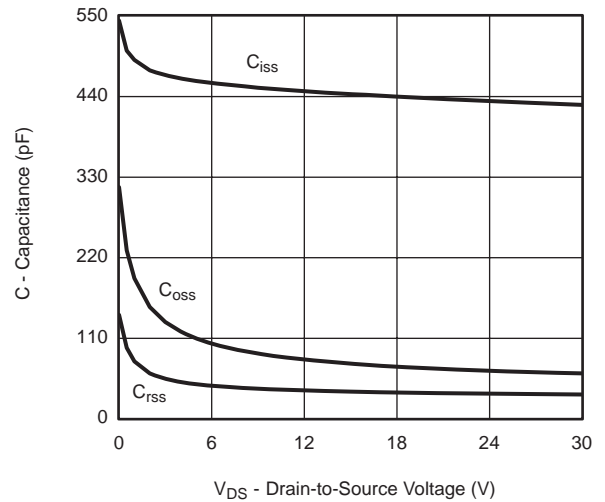

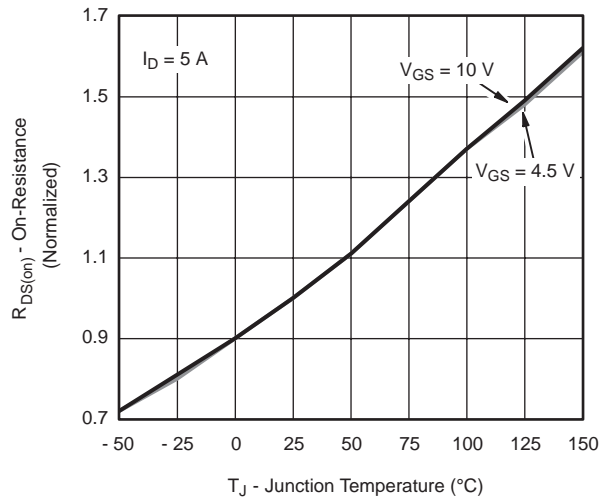
On-Resistance vs. Drain Current

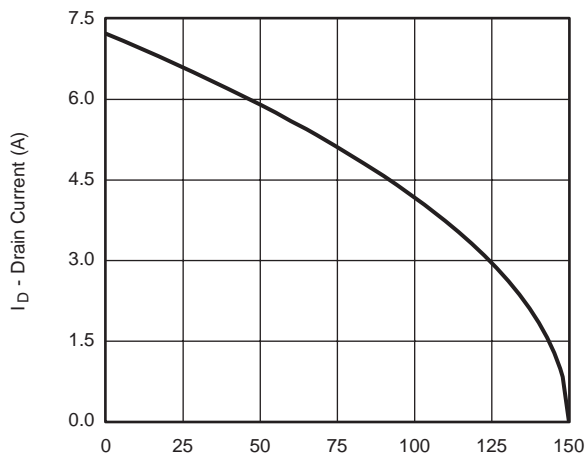
On-Resistance vs. Junction Temperature

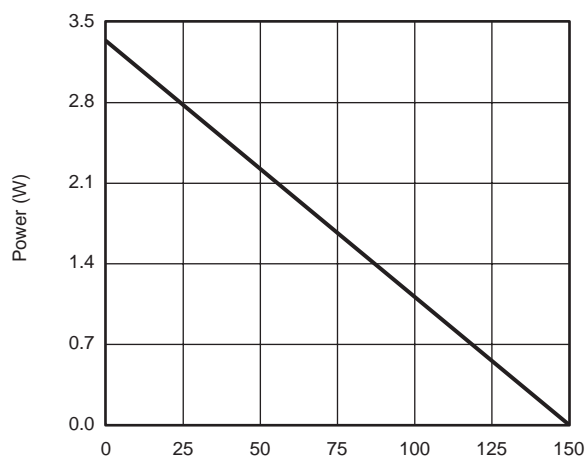

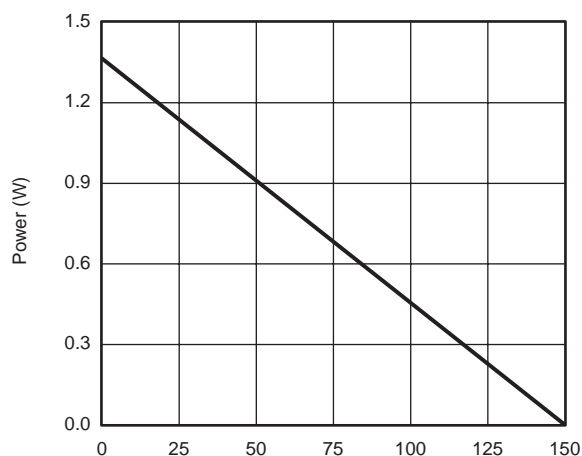

Current Derating*



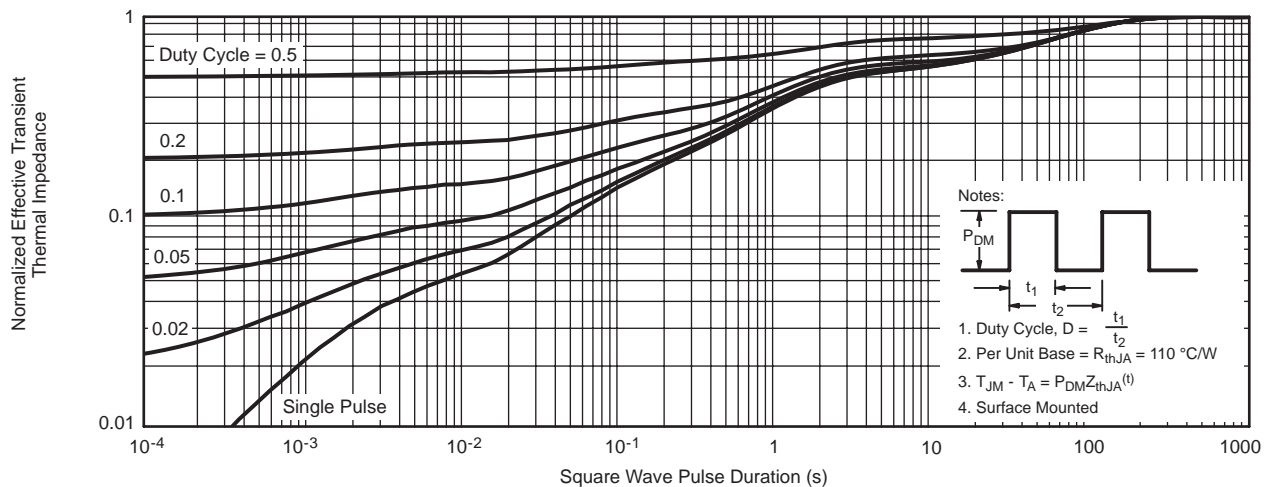
T_C - Case Temperature (°C)
Power, Junction-to-Foot



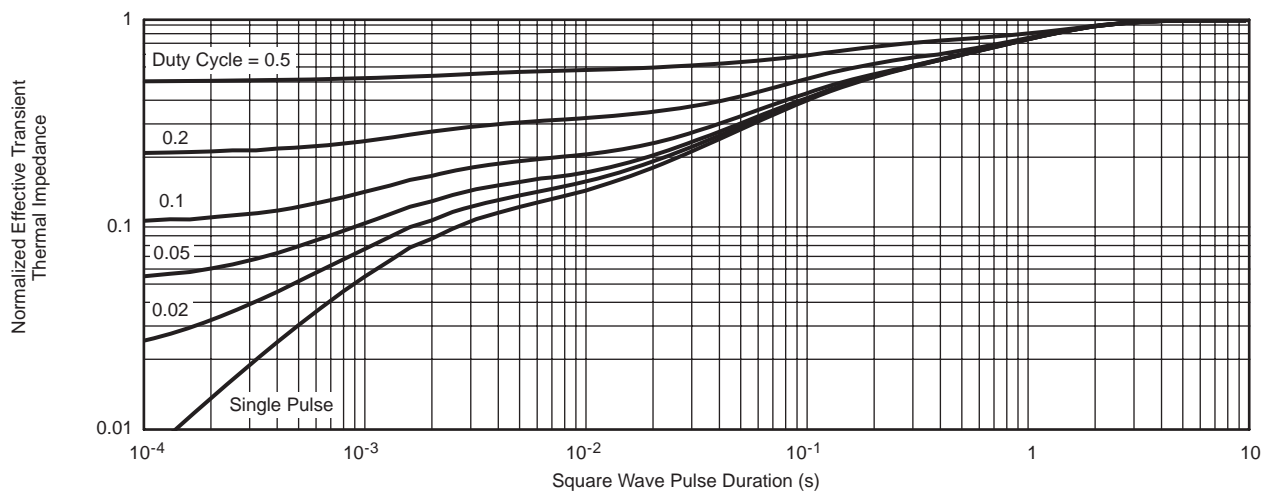
