



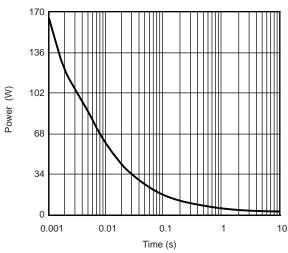
#### Source-Drain Diode Forward Voltage




#### **Threshold Voltage**

Single Pulse Power, Junction-to-Ambient








