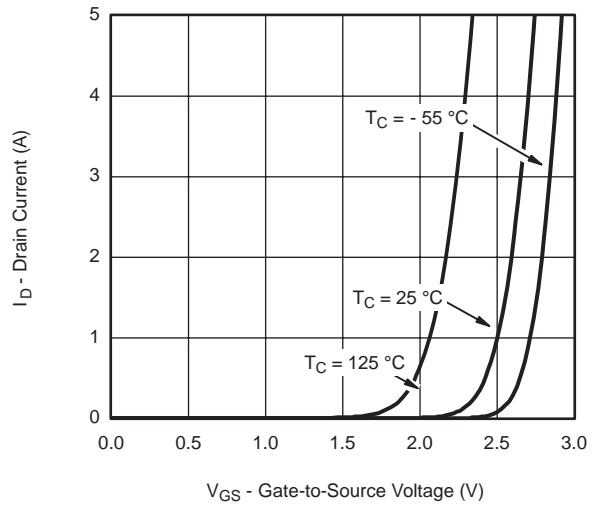

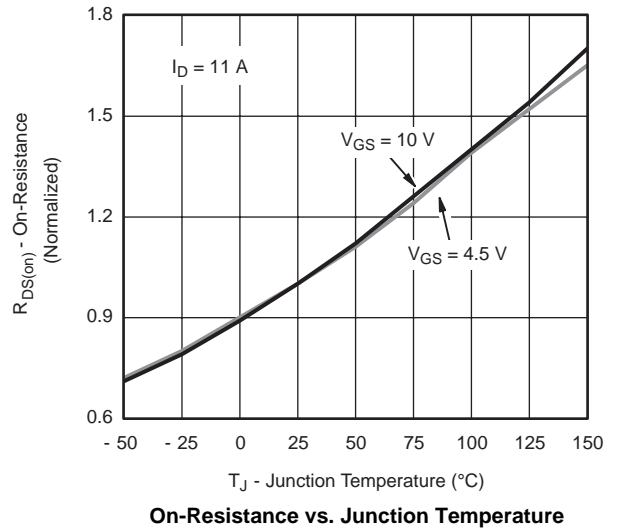
**On-Resistance vs. Drain Current and Gate Voltage**

**Normalized Thermal Transient Impedance, Junction-to-Ambient**



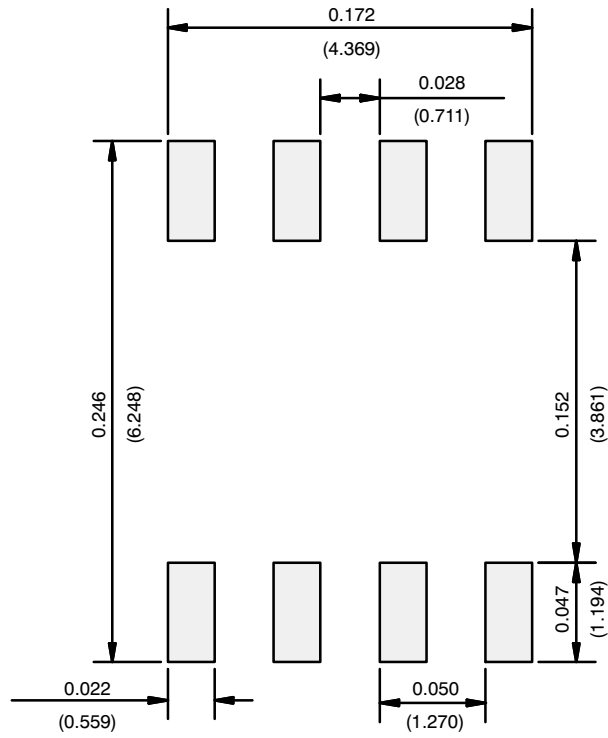
**Normalized Thermal Transient Impedance, Junction-to-Foot**
