




I_D - Drain Current (A) On-Resistance vs. Drain Current



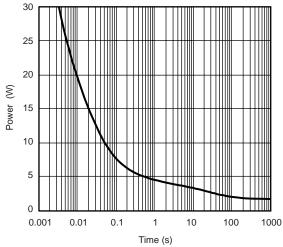


On-Resistance vs. Junction Temperature



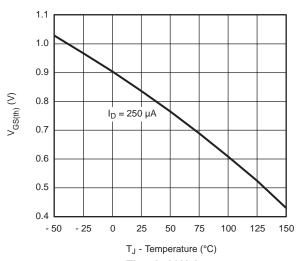
On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient

Threshold Voltage









Normalized Effective Transient Thermal Impedance
