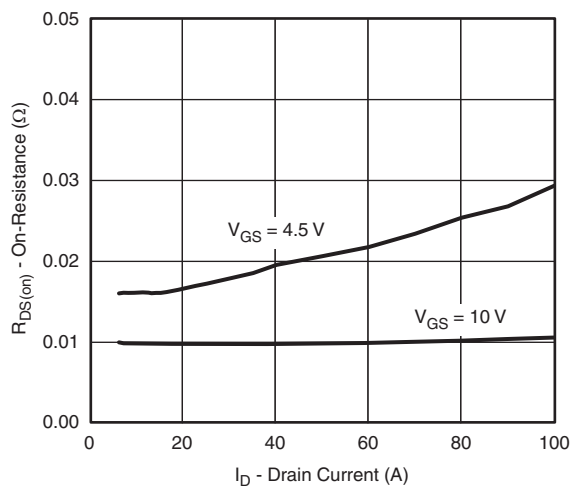

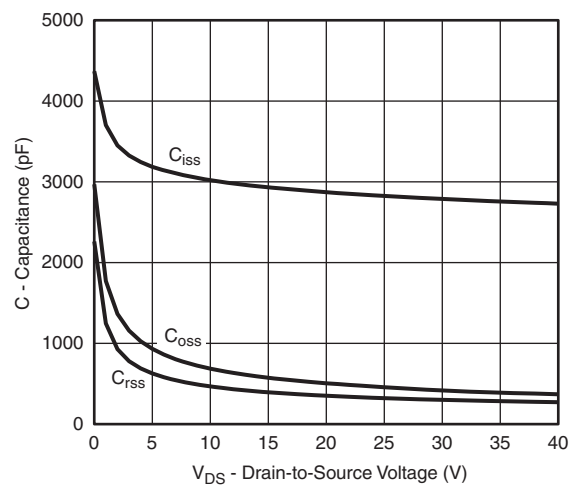

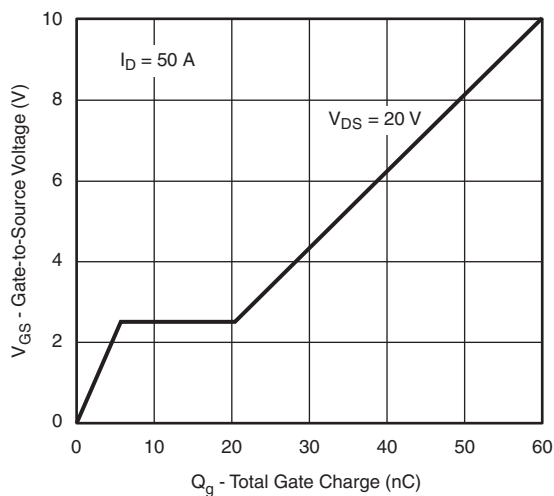

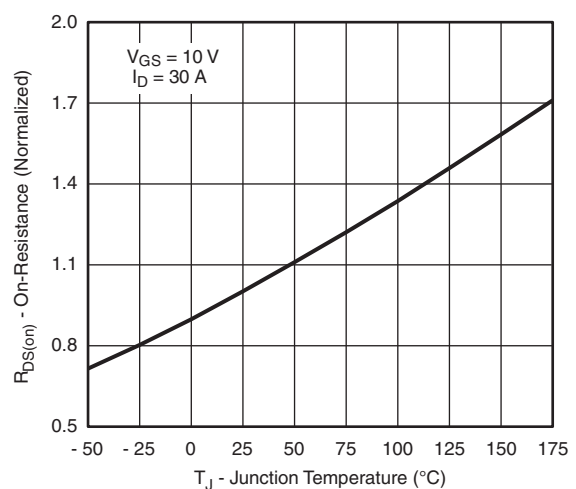
**On-Resistance vs. Drain Current**

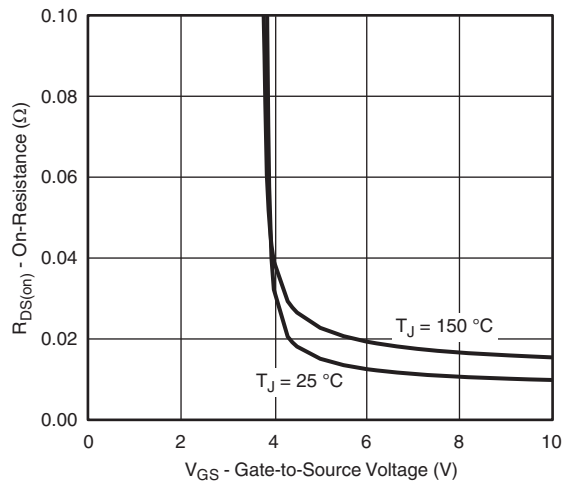


**On-Resistance vs. Junction Temperature**

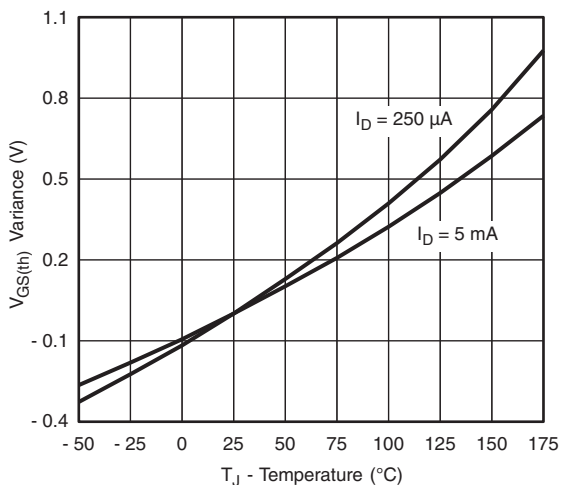

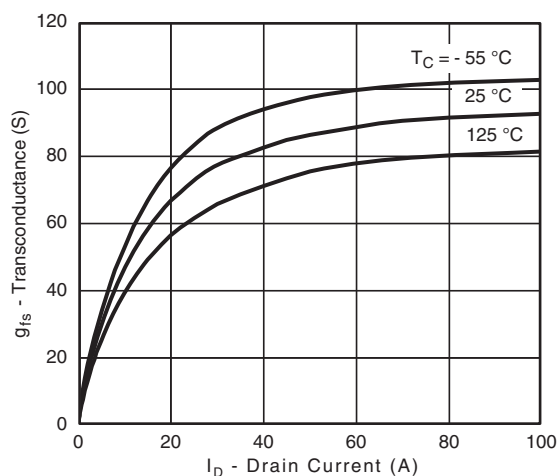
**Source Drain Diode Forward Voltage**



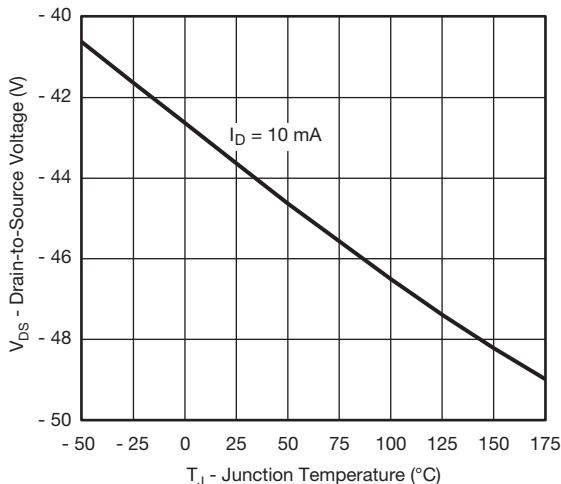
**On-Resistance vs. Gate-to Source Voltage**

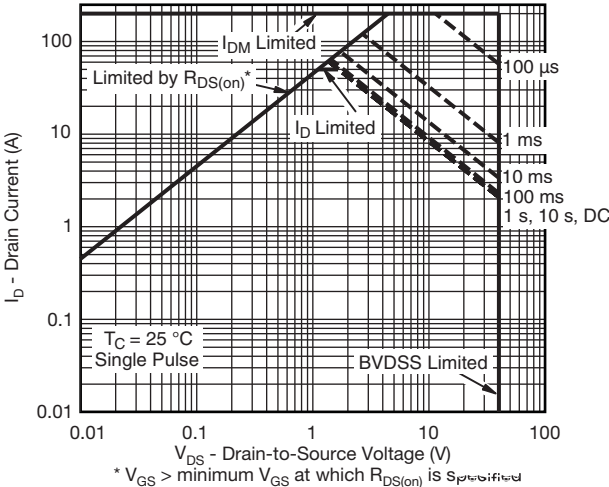

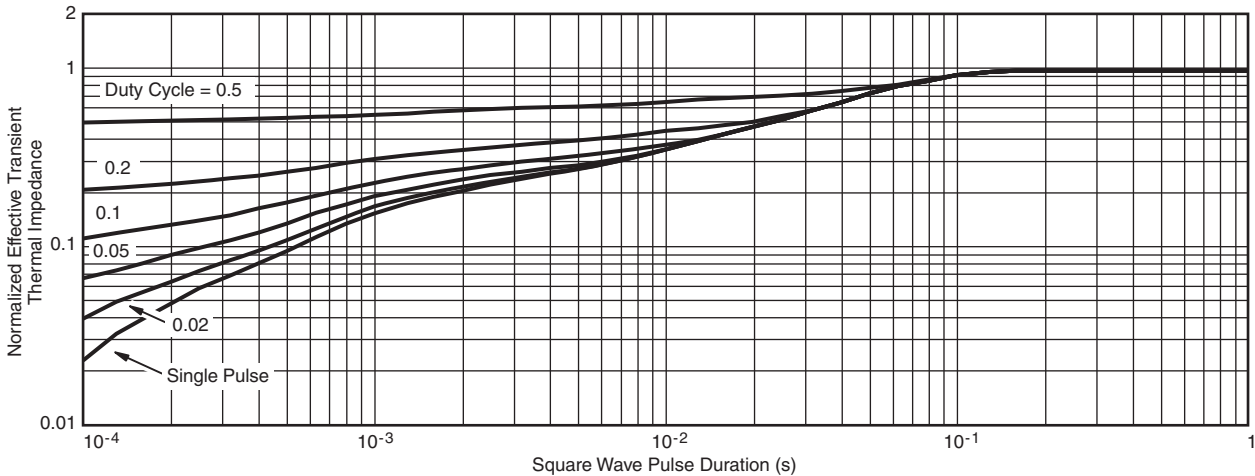


**Drain Source Breakdown vs. Junction Temperature**
