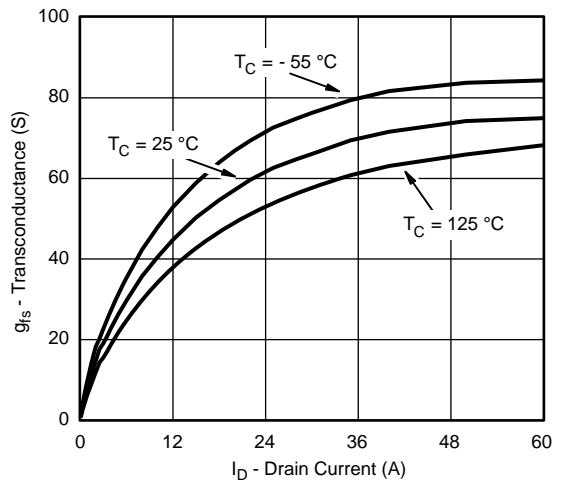

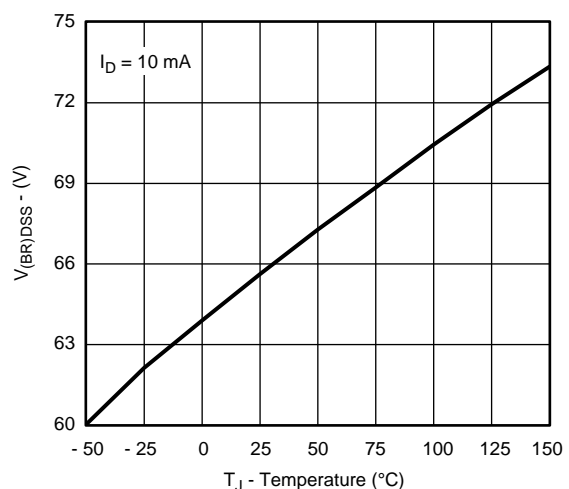
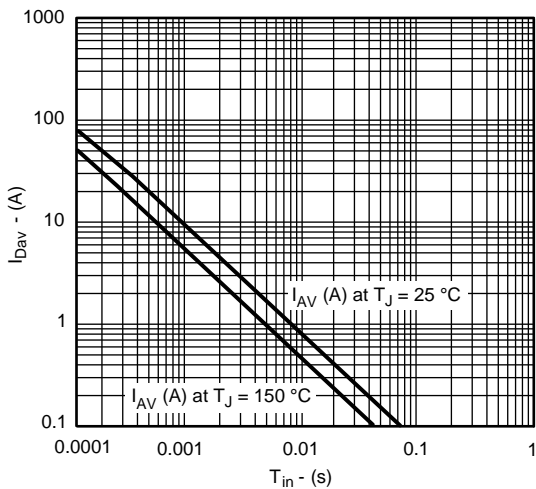
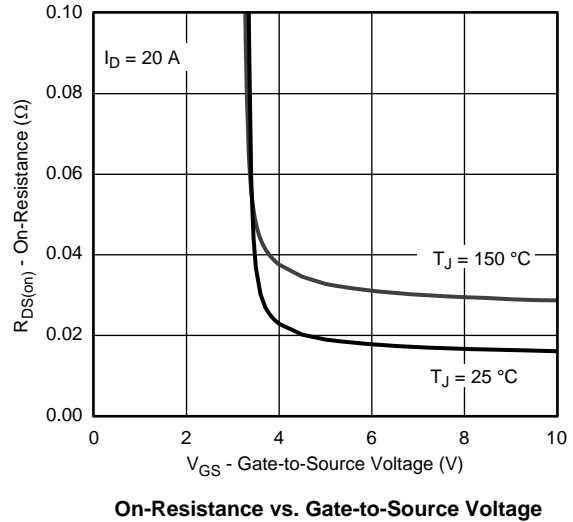
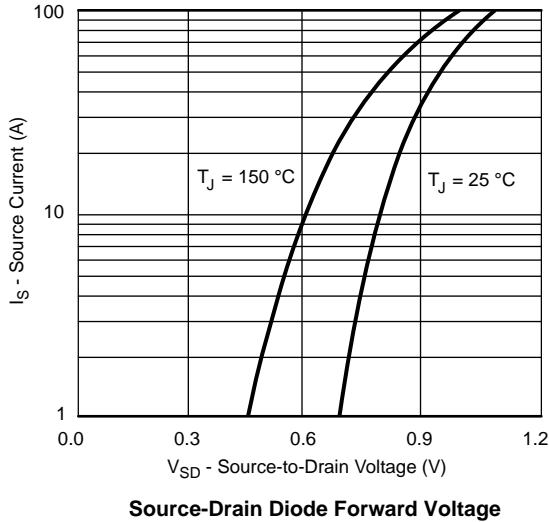
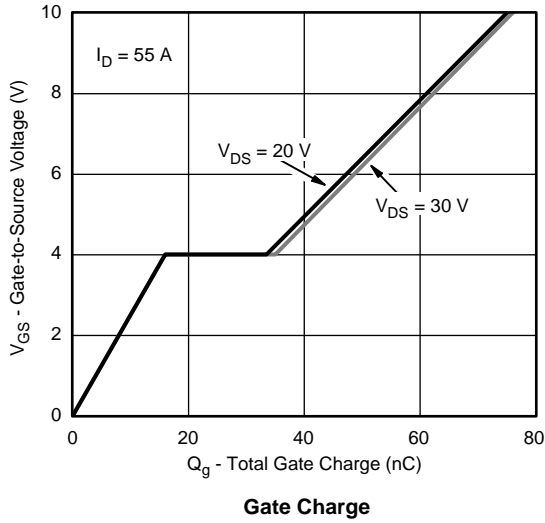


On-Resistance vs. Drain Current



Capacitance

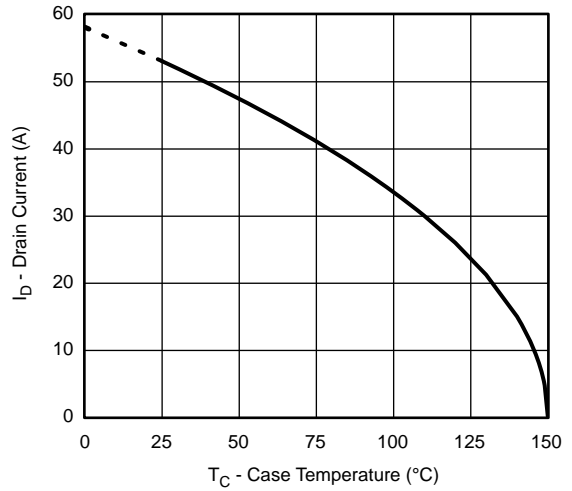

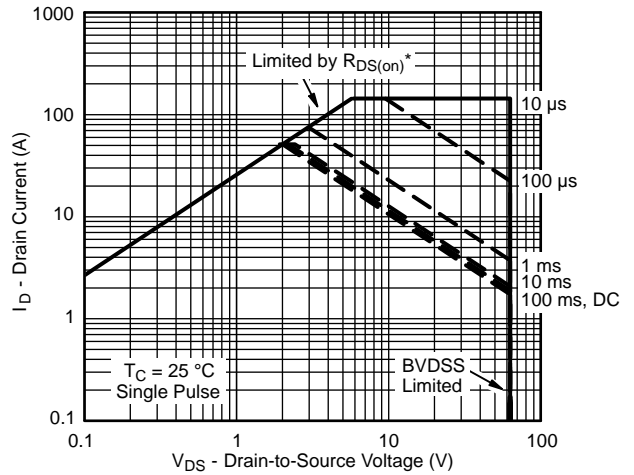
Threshold Voltage



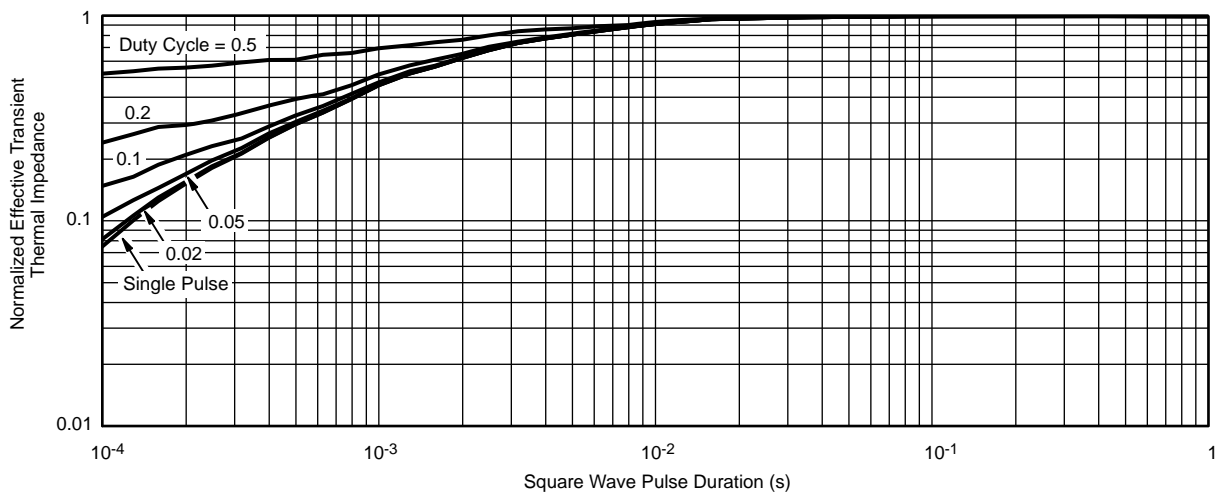
Max. Drain Current vs. Case Temperature



Power Derating, Junction-to-Case

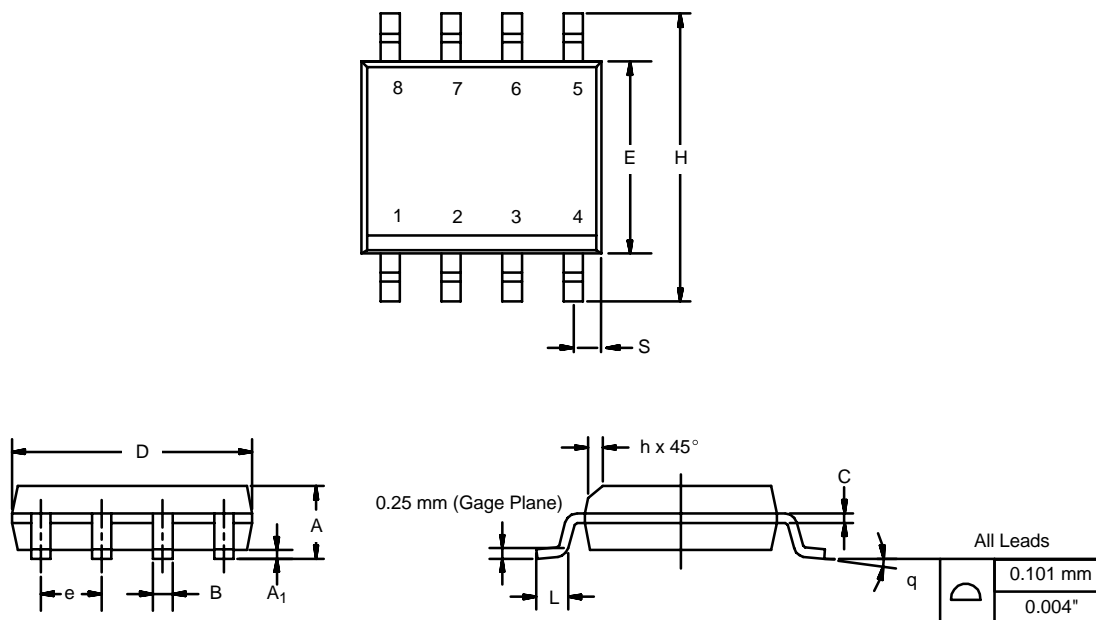


Safe Operating Area, Junction-to-Case
