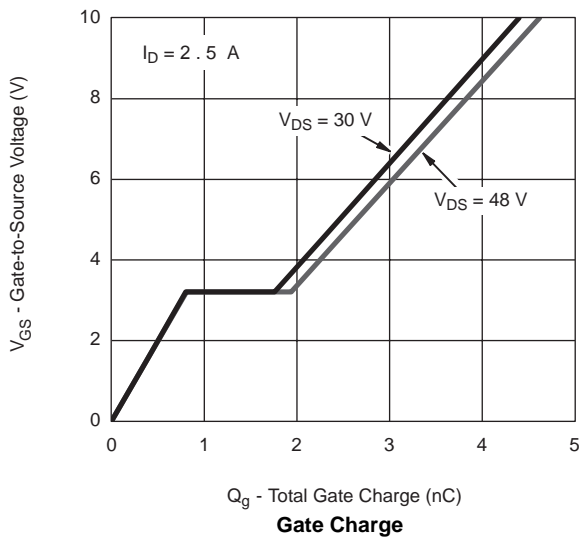

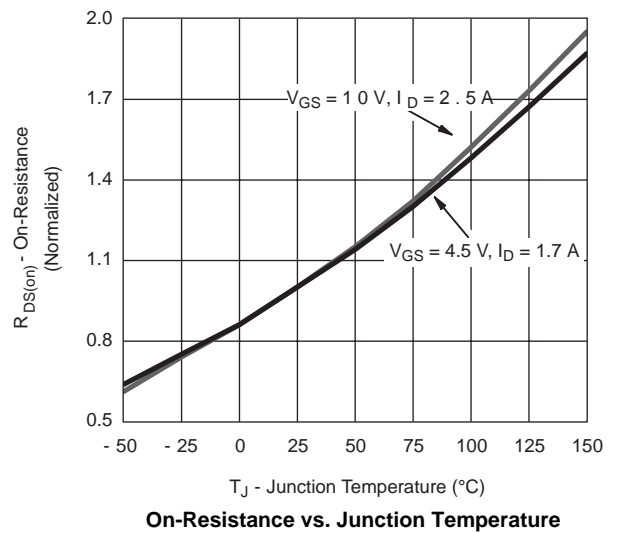
**On-Resistance vs. Drain Current and Gate Voltage**

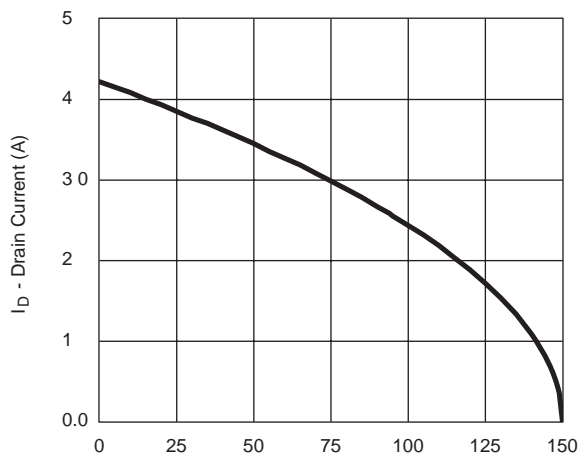


**On-Resistance vs. Junction Temperature**

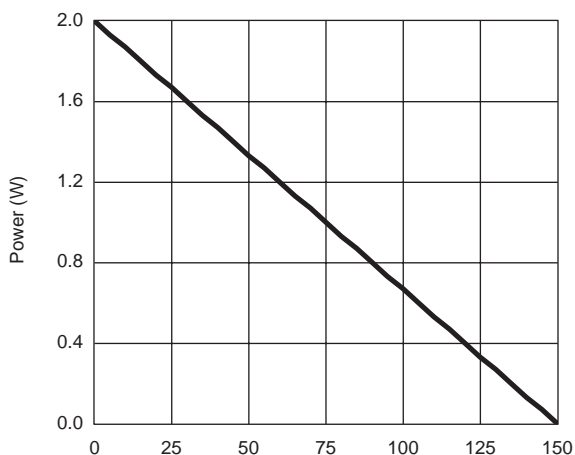

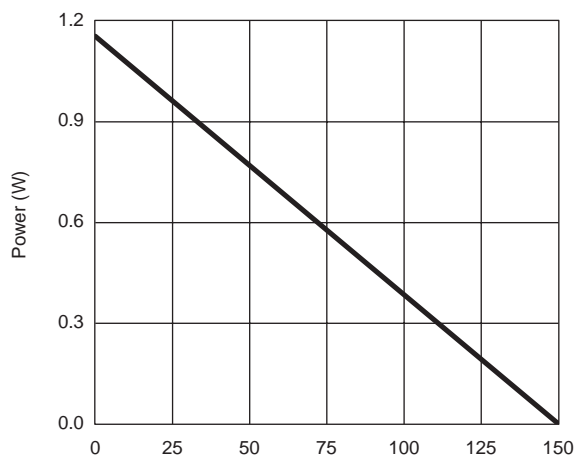
T<sub>C</sub> - Case Temperature (°C)

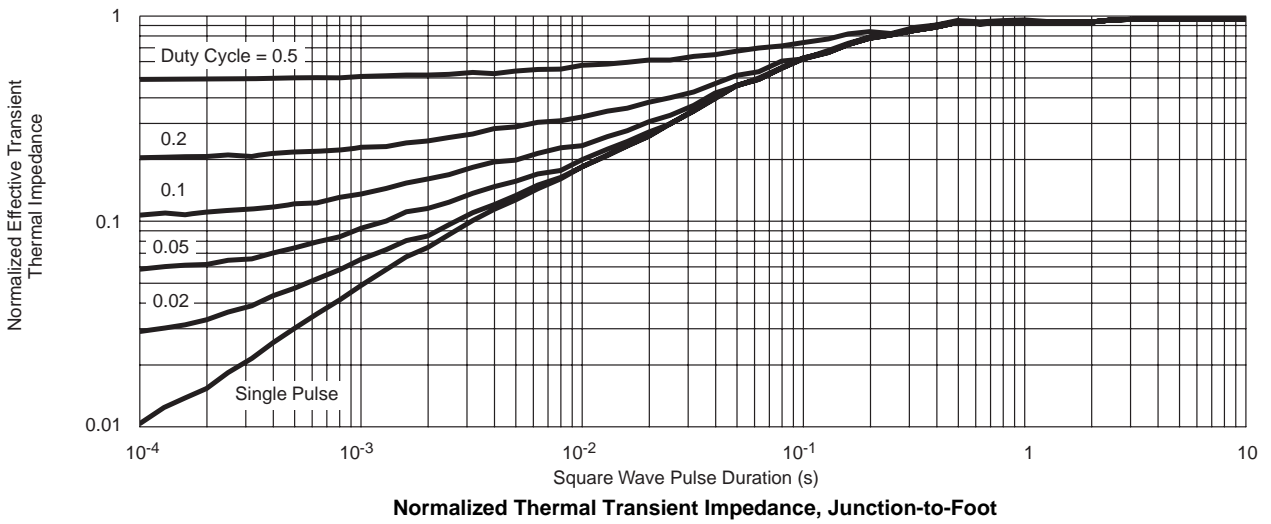
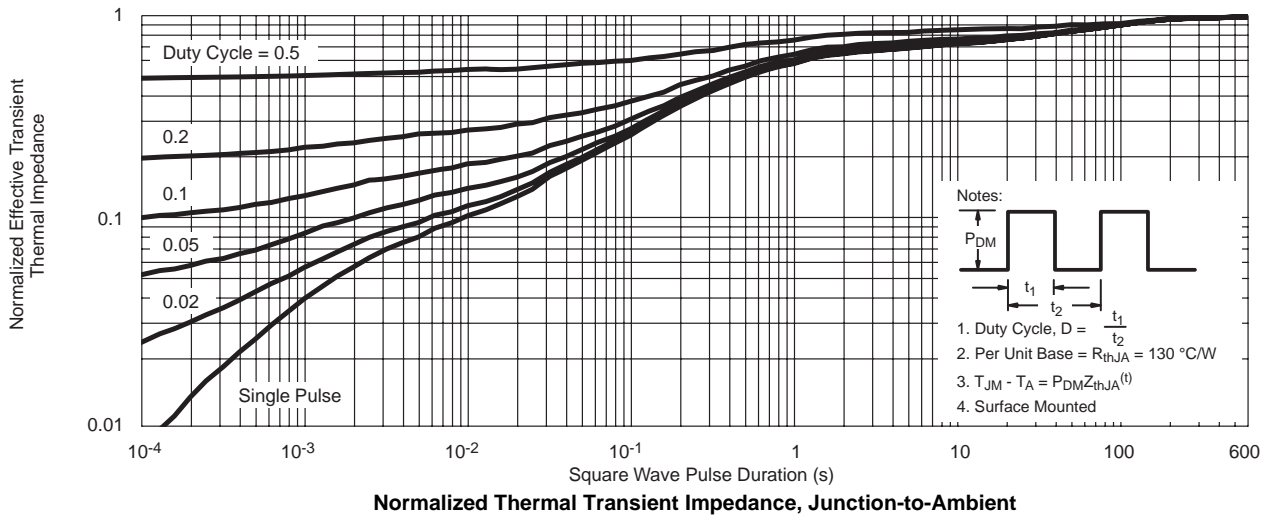


T<sub>A</sub> - Ambient Temperature (°C)
