







Transconductance






Transfer Characteristics




R_{DS(on)} vs. Drain Current









On-Resistance vs. Junction Temperature






 $R_{DS(on)}\, vs. \, V_{GS}\, vs. \, Temperature$




Threshold Voltage




Safe Operating Area, Junction-to-Ambient







Normalized Thermal Transient Impedance, Junction-to-Case




DFN5x6_8L_EP1_P PACKAGE OUTLIN




