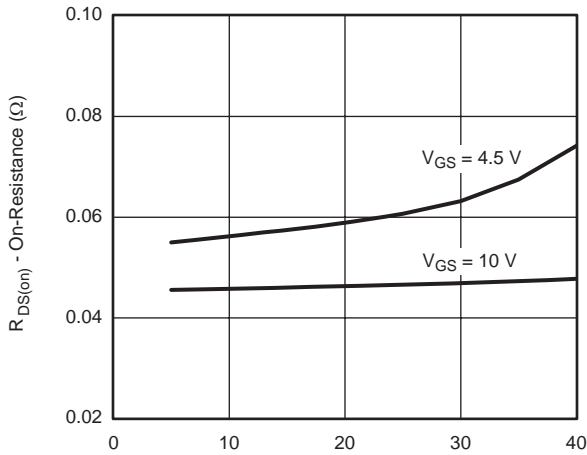

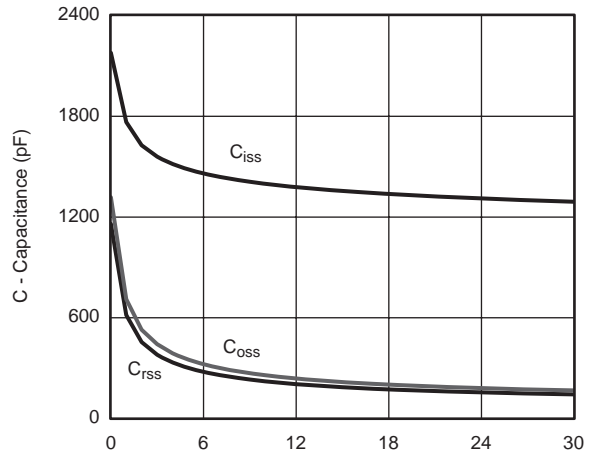

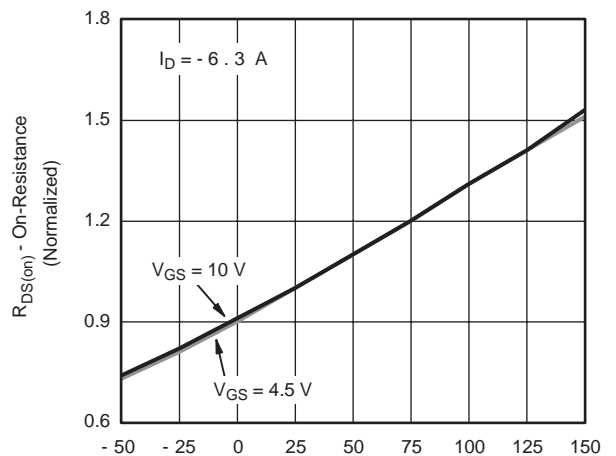
**On-Resistance vs. Drain Current**

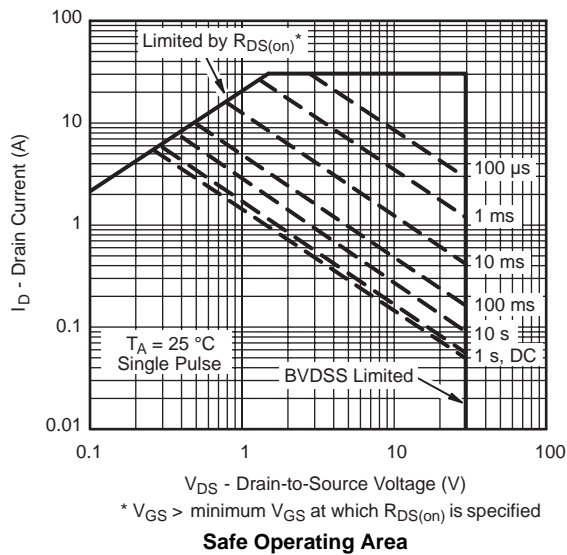
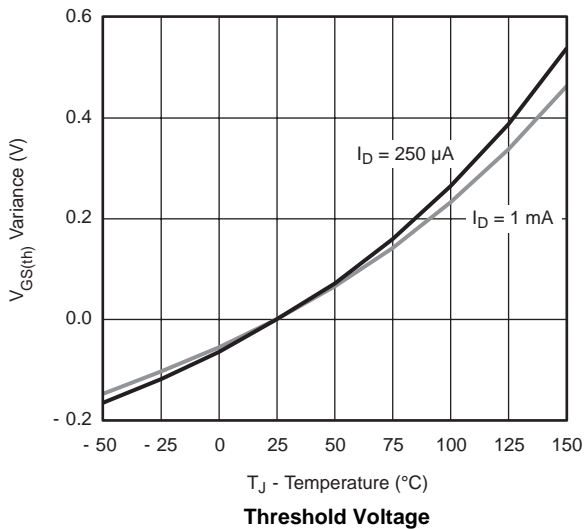
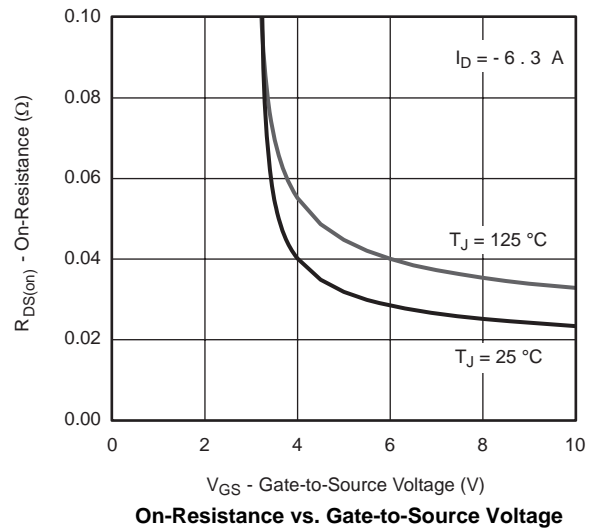


**Gate Charge**

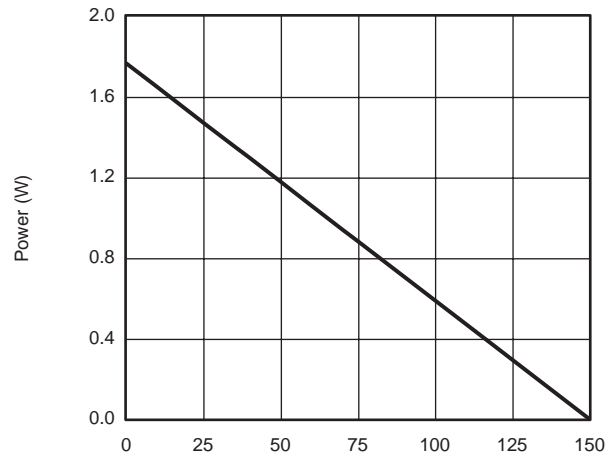

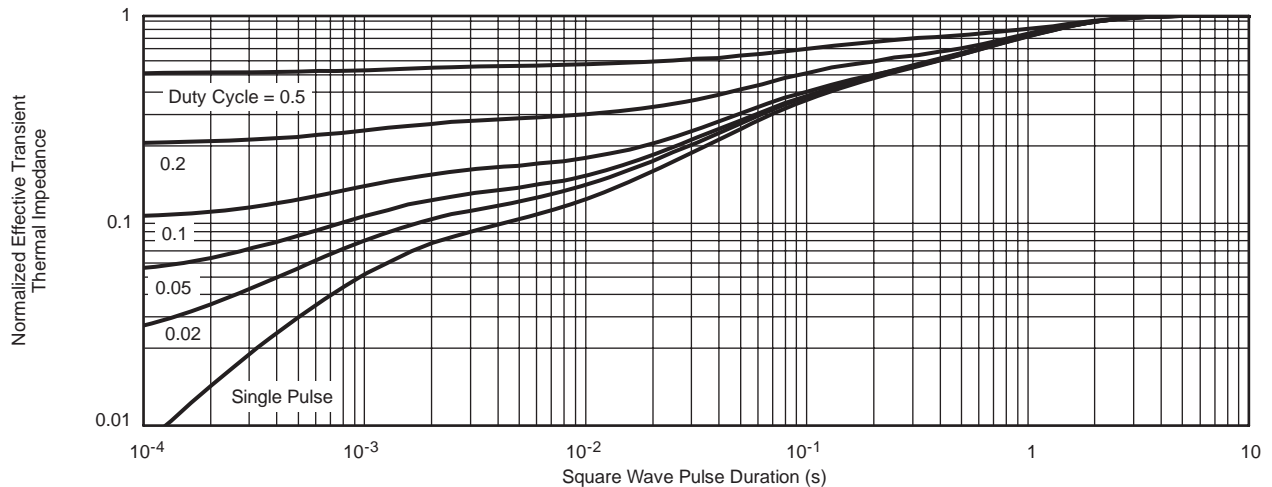
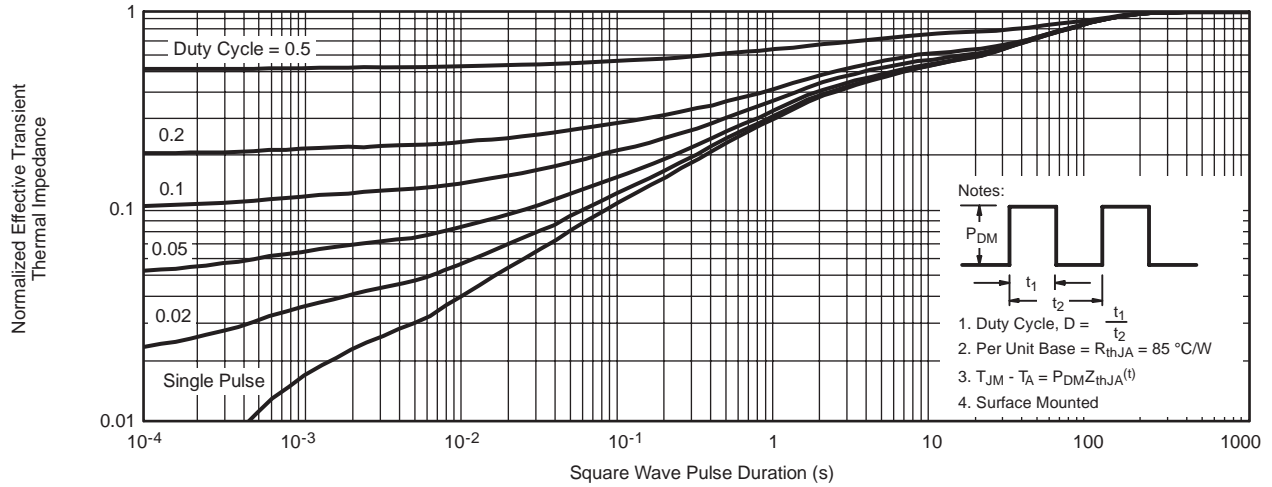
**Power, Junction-to-Foot**
