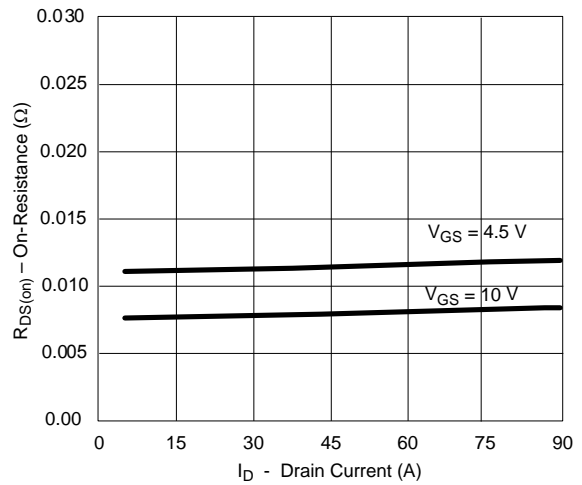

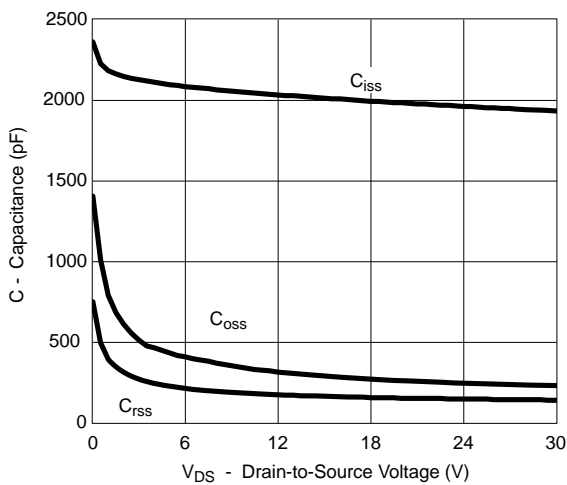

**$R_{DS(on)}$  vs. Drain Current**

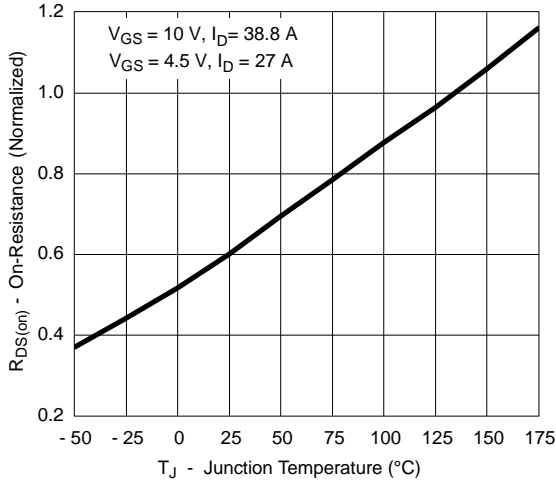

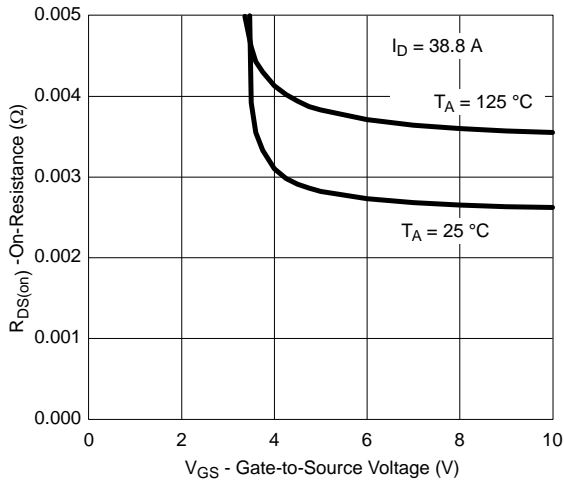

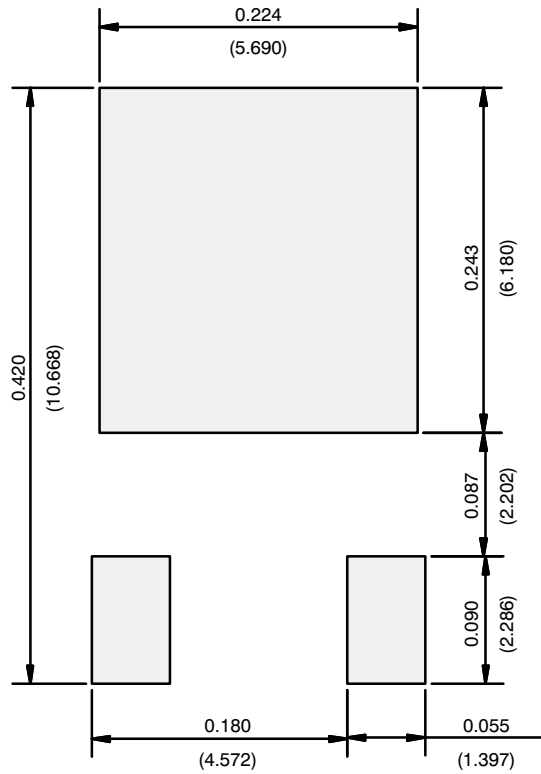
