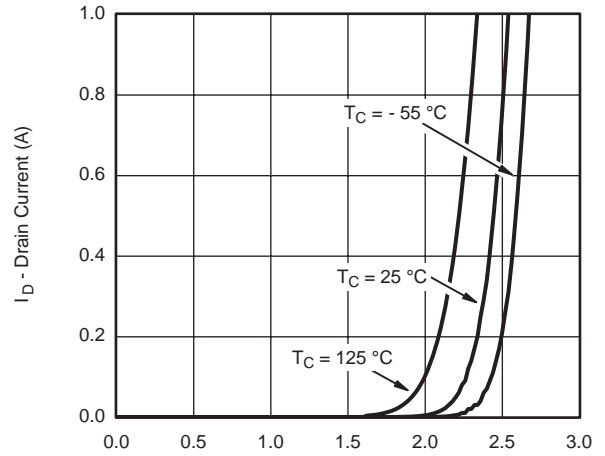

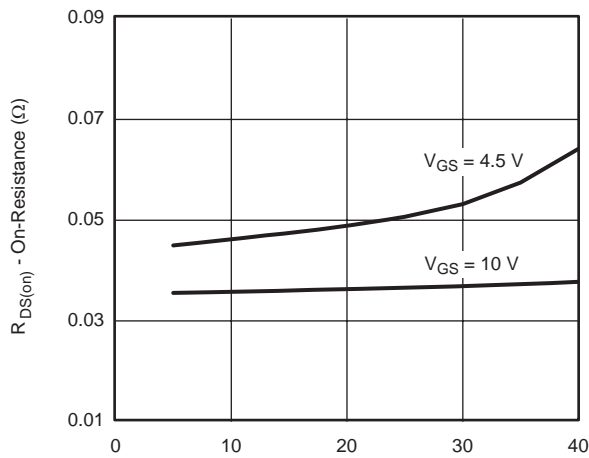

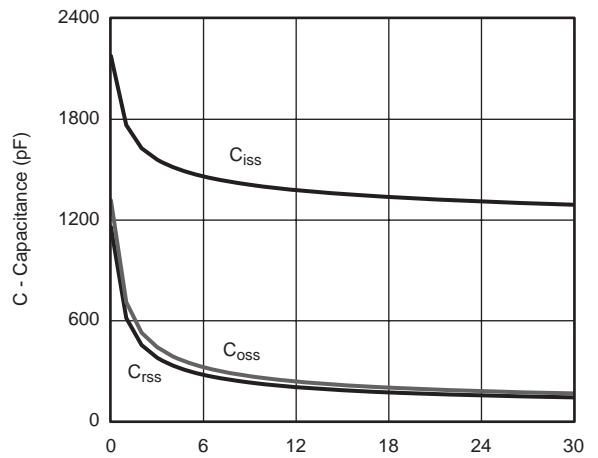

**Transfer Characteristics**



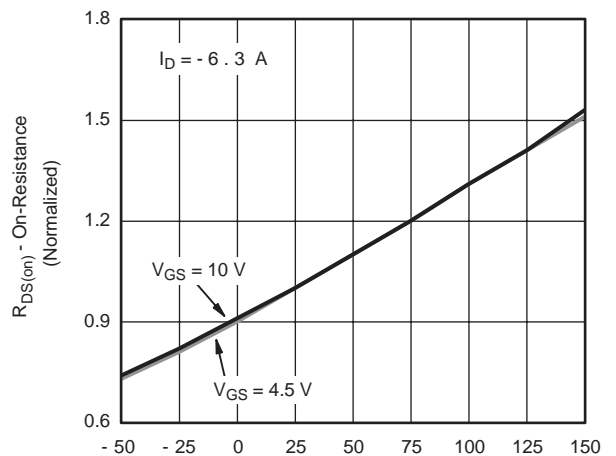
**On-Resistance vs. Drain Current**



**Capacitance**

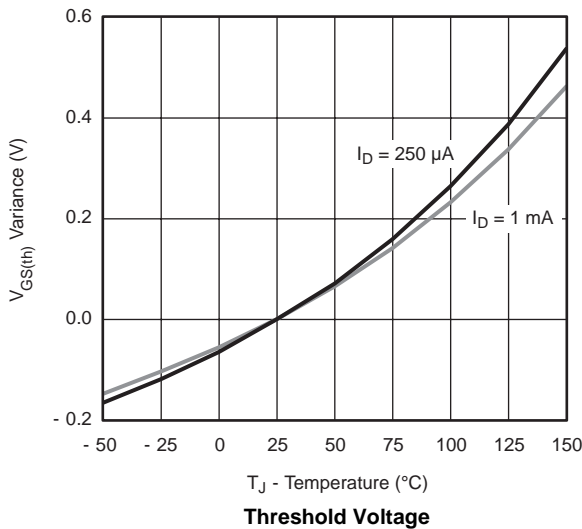
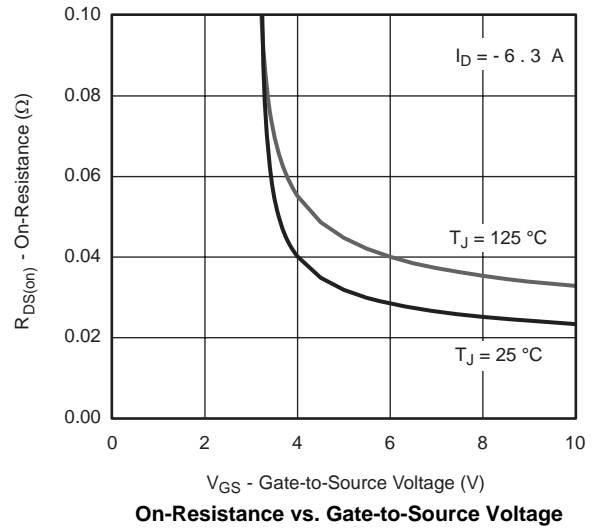


**Gate Charge**

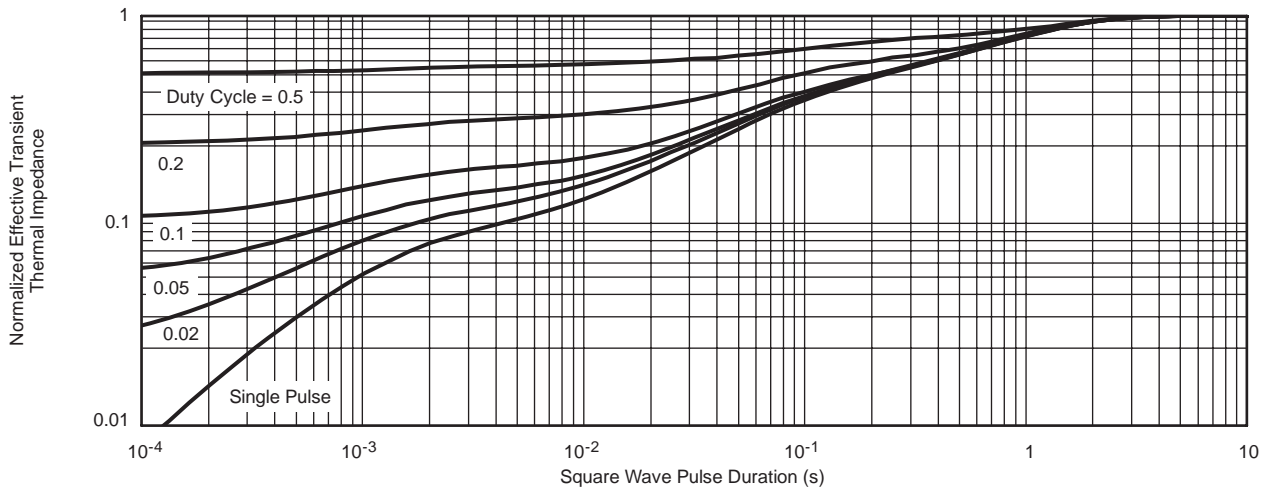
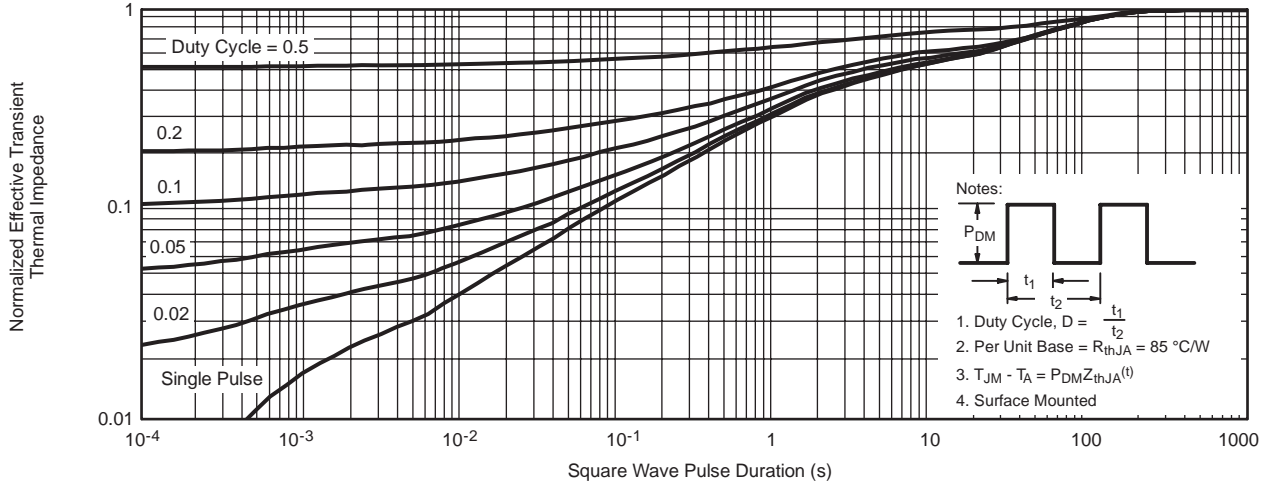
**Power, Junction-to-Foot**



**Power Derating, Junction-to-Ambient**

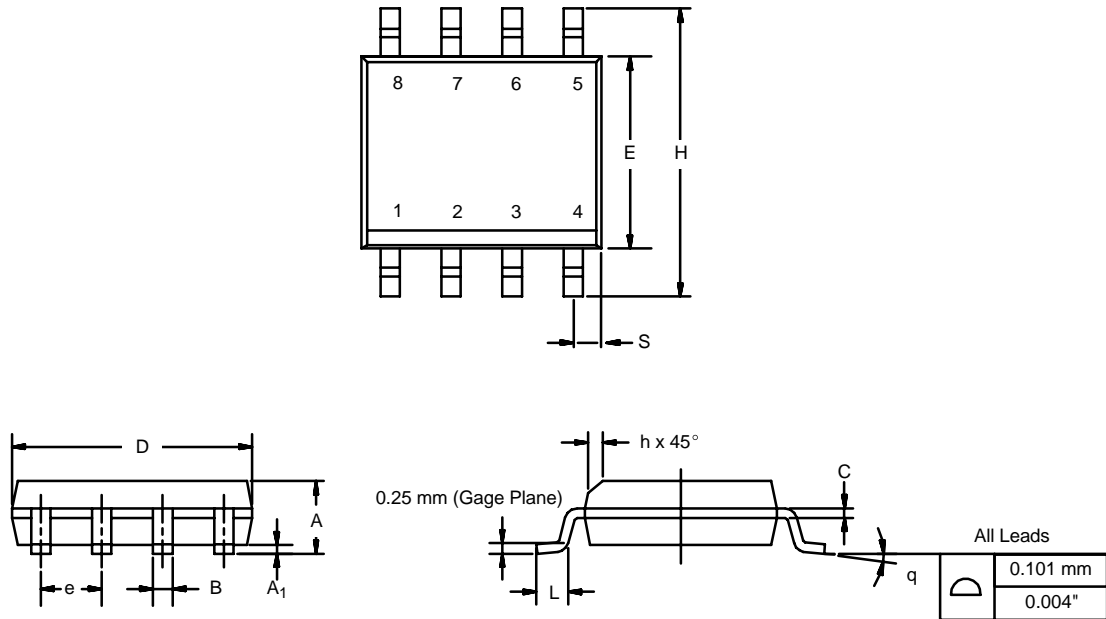
