


#### On-Resistance vs. Drain Current






Source-Drain Diode Forward Voltage



Capacitance




On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage





**Threshold Voltage** 


Single Pulse Power
