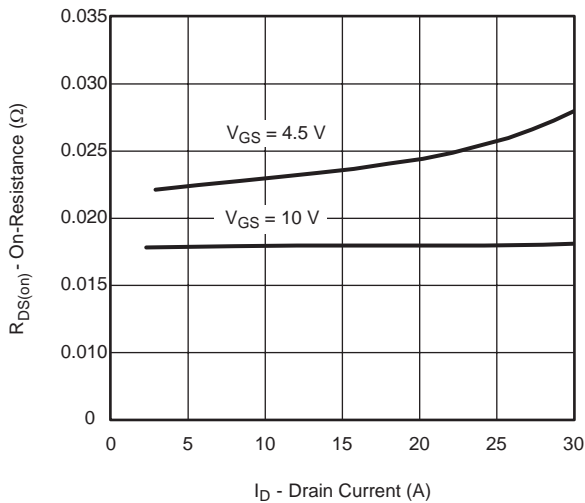

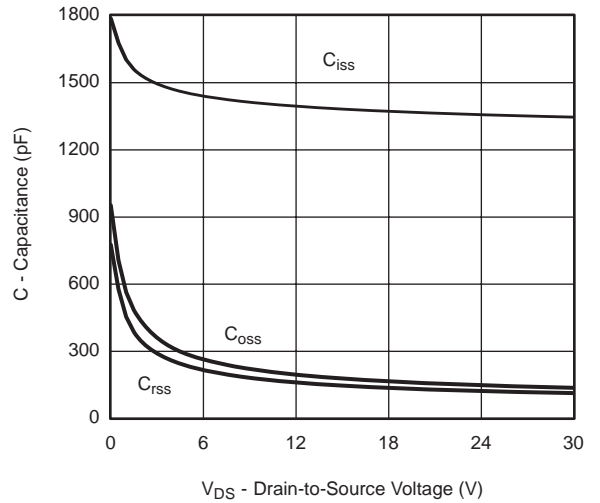
**Output Characteristics**



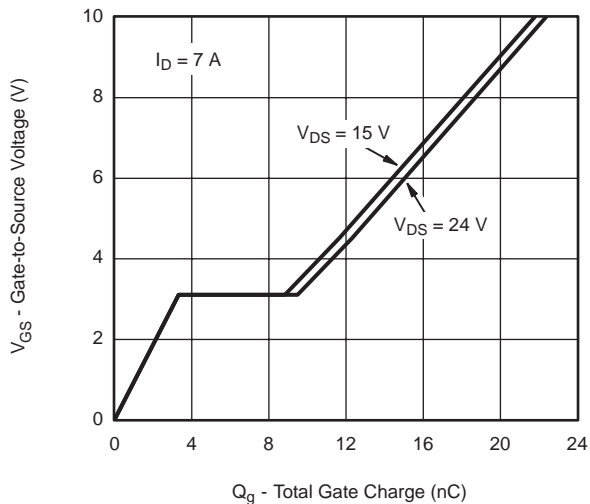

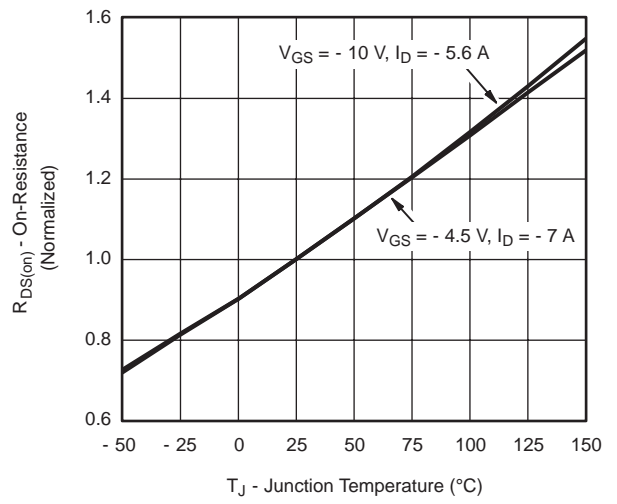
**On-Resistance vs. Drain Current**

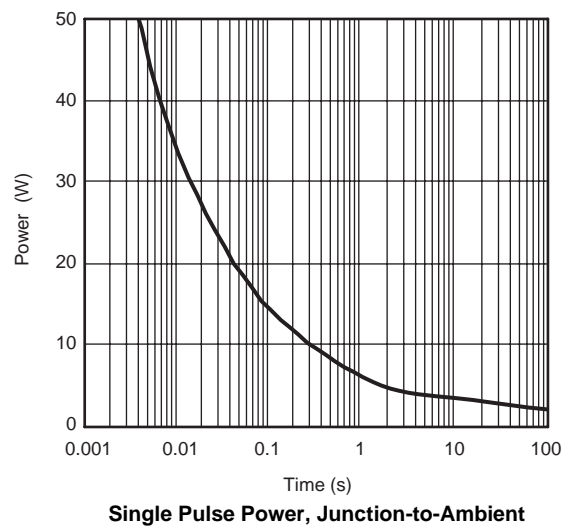
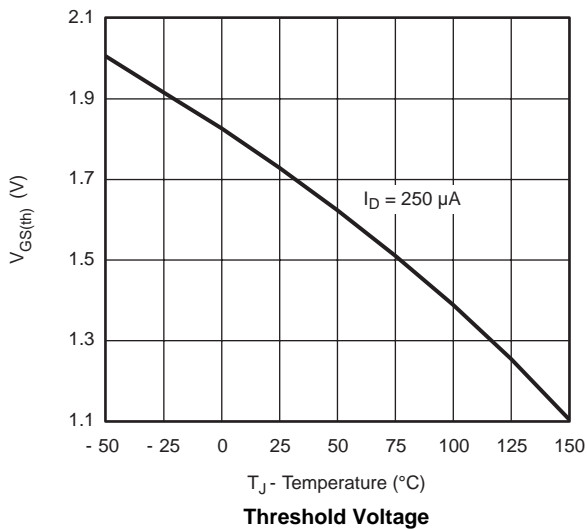
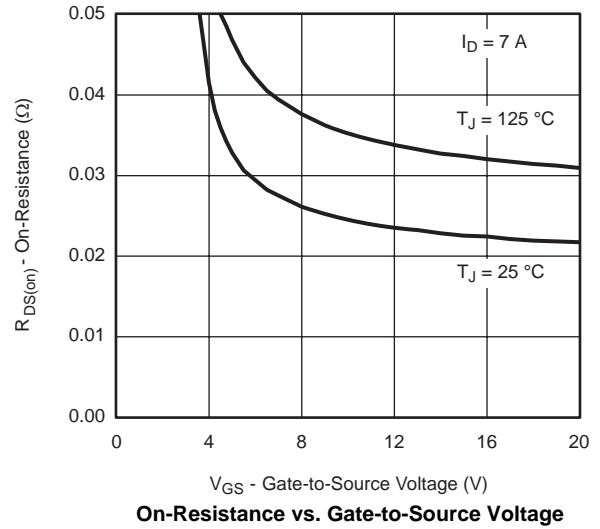


**Gate Charge**

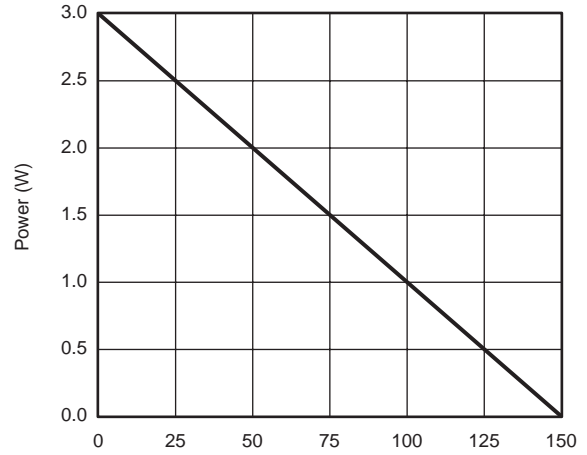

**Current Derating\***



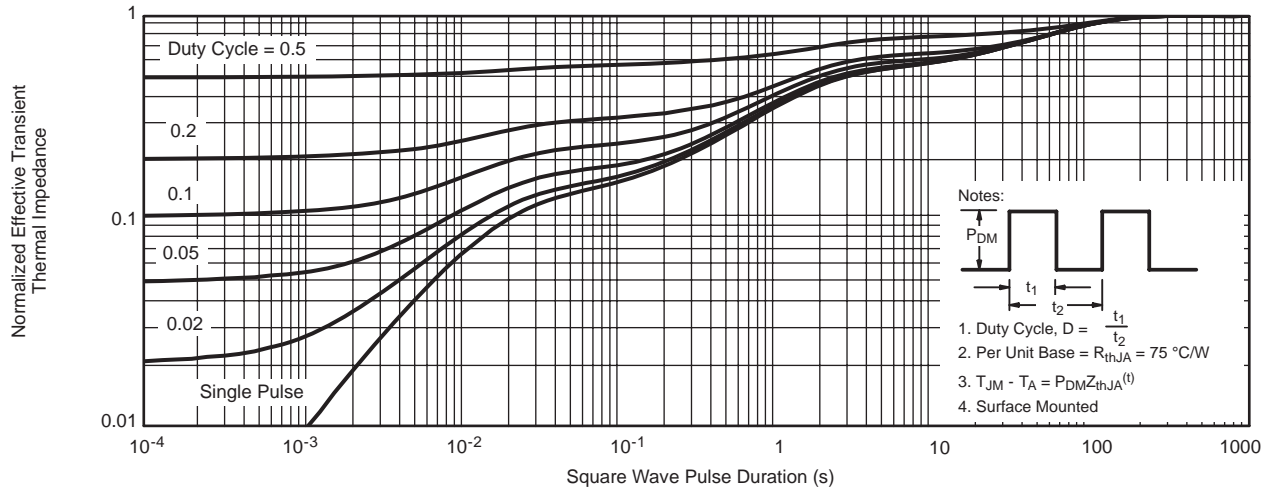
