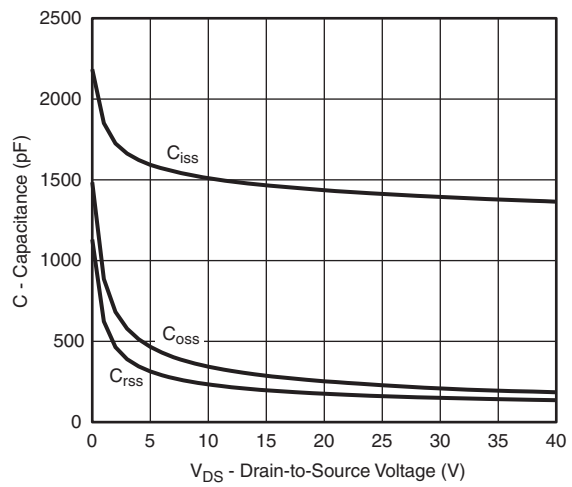

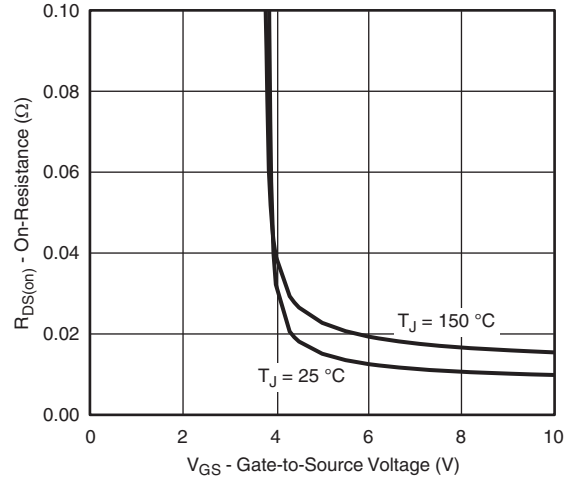

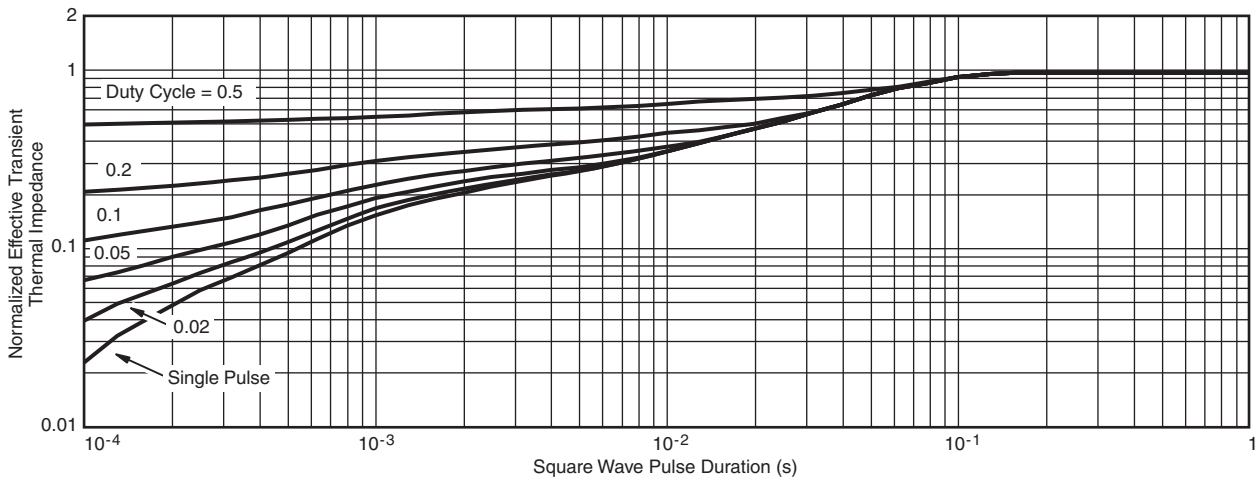


**Drain Source Breakdown vs. Junction Temperature**

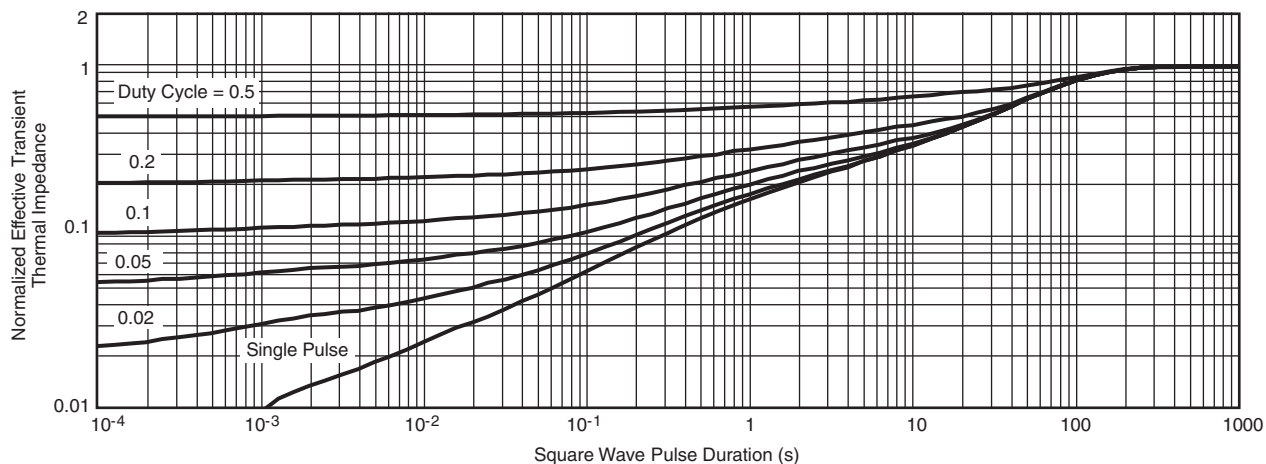

**Normalized Thermal Transient Impedance, Junction-to-Case**

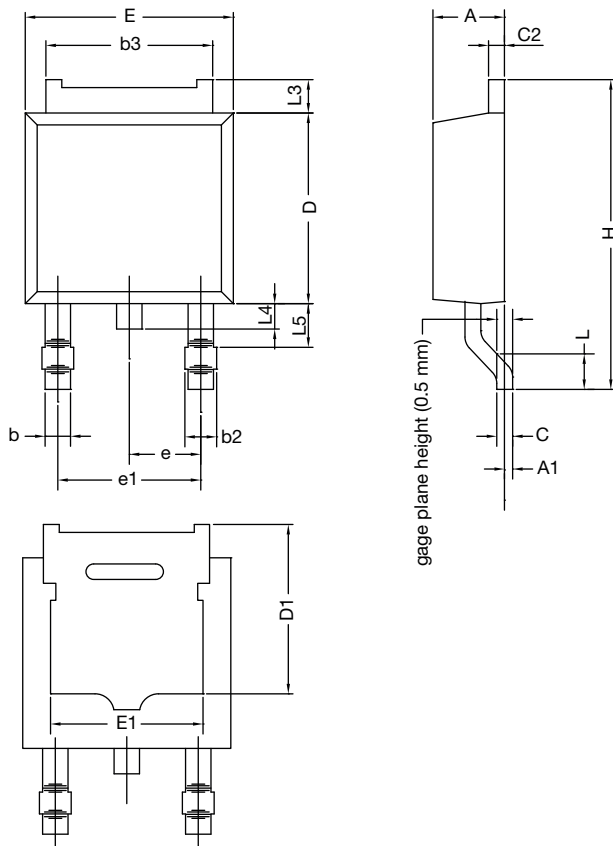


**Normalized Thermal Transient Impedance, Junction-to-Ambient**
