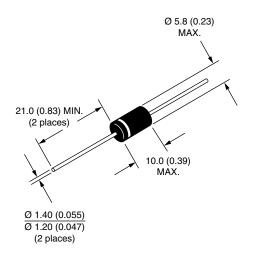

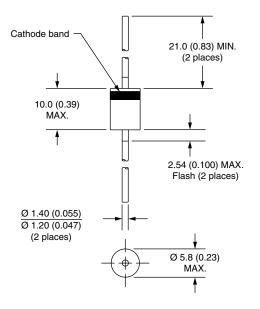




Axial DO-201AD (C-16)
