
TYPICAL CHARACTERISTICS ($T_A = 25$ °C, unless otherwise noted)

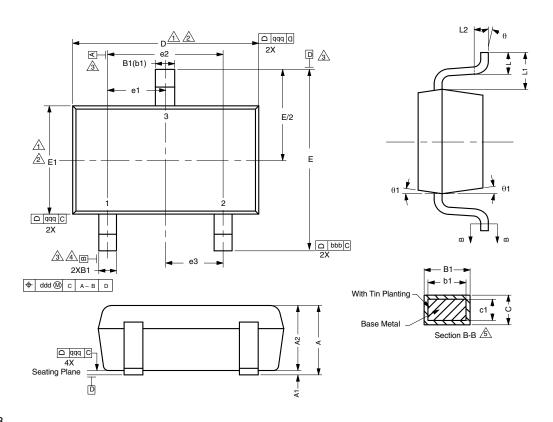
