




Transconductance







On-Resistance vs. Drain Current











On-Resistance vs. Junction Temperature

On-Resistance vs. Gate-to-Source Voltage




T_J - Junction Temperature (°C)


Drain Source Breakdown vs. Junction Temperature



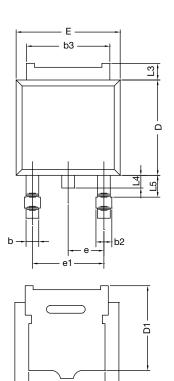

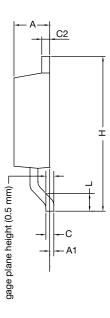
