



Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Relative Luminous Intensity vs. Angular Displacement




Fig. 3 - Forward Current vs. Forward Voltage




Fig. 4 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 5 - Relative Luminous Intensity vs. Forward Current/Duty Cycle




Fig. 6 - Relative Luminous Intensity vs. Forward Current




Fig. 7 - Relative Intensity vs. Wavelength




Fig. 8 - Forward Current vs. Forward Voltage




Fig. 9 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 10 - Relative Luminous Intensity vs. Forward Current/Duty Cycle




Fig. 11 - Relative Luminous Intensity vs. Forward Current




Fig. 12 - Relative Intensity vs. Wavelength




Fig. 13 - Forward Current vs. Forward Voltage

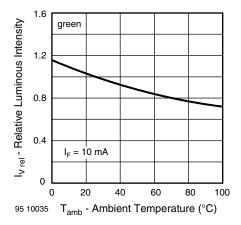


Fig. 14 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 15 - Specific Luminous Intensity vs. Forward Current




Fig. 16 - Relative Luminous Intensity vs. Forward Current




Fig. 17 - Relative Intensity vs. Wavelength




Fig. 18 - TDS.51..


