DESCRIPTION

This device has been designed to meet the increasing demand for white SMD LED.

The package of the VLMW45R1S1-5K6L-08 is the PLCC-2.

It consists of a lead frame which is embedded in a white thermoplast. The reflector inside this package is filled with a mixture of epoxy and TAG phosphor.

The TAG phosphor converts the blue emission partially to yellow, which mixes with the remaining blue to give white.




Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Relative Luminous Intensity vs. Angular Displacement




Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Relative Luminous Intensity vs. Forward Current




Fig. 6 - Chromaticity Coordinate Shift vs. Forward Current




Fig. 7 - Relative Luminous Intensity vs. Ambient Temperature




Fig. 8 - Forward Voltage vs. Ambient Temperature




Fig. 9 - Chromaticity Coordinate Shift vs. Ambient Temperature





Fig. 10 - Coordinates of Colorgroups






METHOD OF TAPING / POLARITY AND TAPE AND REEL




Fig. 11 - Tape Dimensions in mm for PLCC-2

REEL PACKAGE DIMENSION IN MILLIMETERS FOR SMD LEDS, TAPE OPTION GS08 (= 1500 PCS.)





Fig. 12 - Reel Dimensions - GS08

IR Reflow Soldering Profile for Lead (Pb)-free Soldering Preconditioning acc. to JEDEC level 2a




Fig. 14 - Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020)




Fig. 15 - Double Wave Soldering of Opto Devices (all Packages)





DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity \leq 60 % RH max.

After more than 672 h under these conditions moisture content will be too high for reflow soldering.

In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 $^\circ\text{C}$ + 5 $^\circ\text{C}$ / - 0 $^\circ\text{C}$ and < 5 % RH (dry air / nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.
