



#### DESCRIPTION

Production is strictly controlled and follows an extensive set instructions established for reproducibility. A of homogeneous film of metal oxide is deposited on a high grade ceramic body and conditioned to achieve the desired temperature coefficient. Plated steel termination caps are firmly pressed on the metallized rods. Mostly, a special laser is used to achieve the target value by smoothly cutting a helical groove in the resistive layer without damaging the ceramics. Connecting wires of electrolytic copper plated with 100 % tin are welded to the termination caps. The resistor elements are covered by a green protective coating designed for electrical, mechanical and climatic protection. Four or five color code rings designate the resistance value and tolerance in accordance with IEC 60062 (1). WK2 and WR4 are color coded while WR5 and WK8 are print marked.

The result of the determined production is verified by an extensive testing procedure performed on 100 % of the individual resistors. Only accepted products are stuck directly on the adhesive tapes in accordance with **IEC 60286-1** <sup>(1)</sup>.
