### Total Power Dissipation vs. Ambient Temperature:



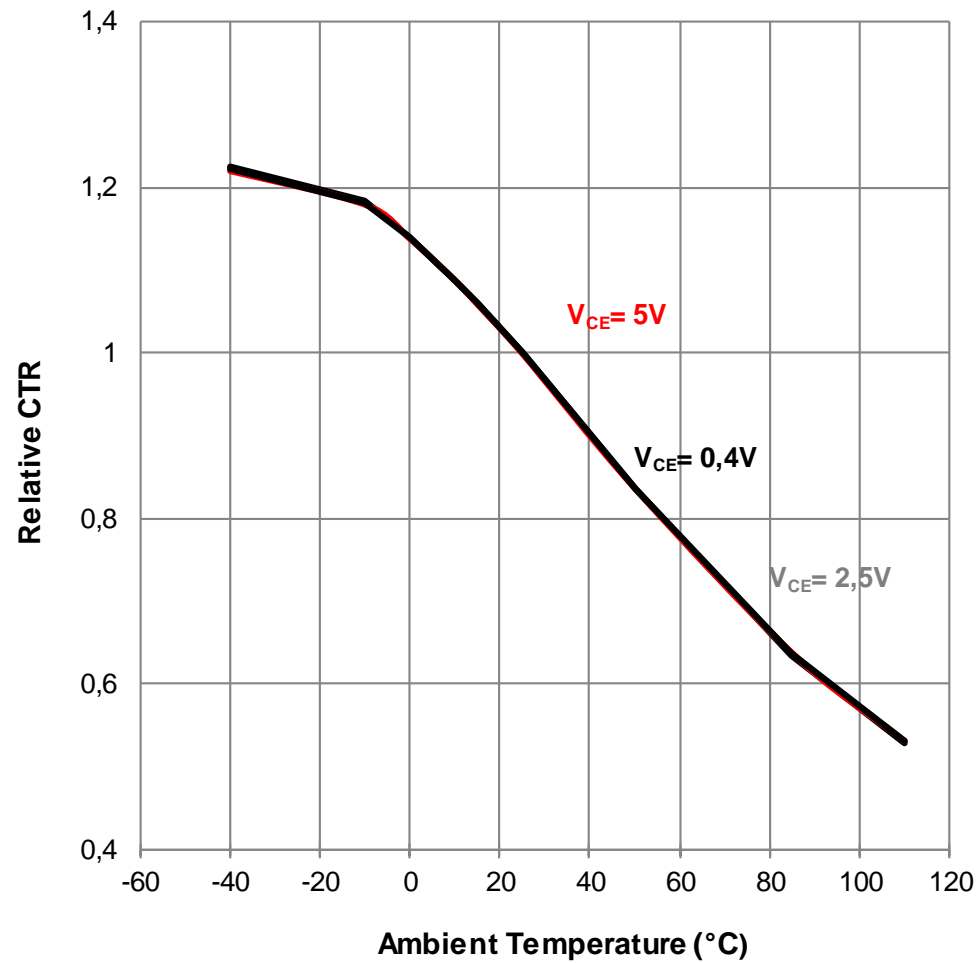

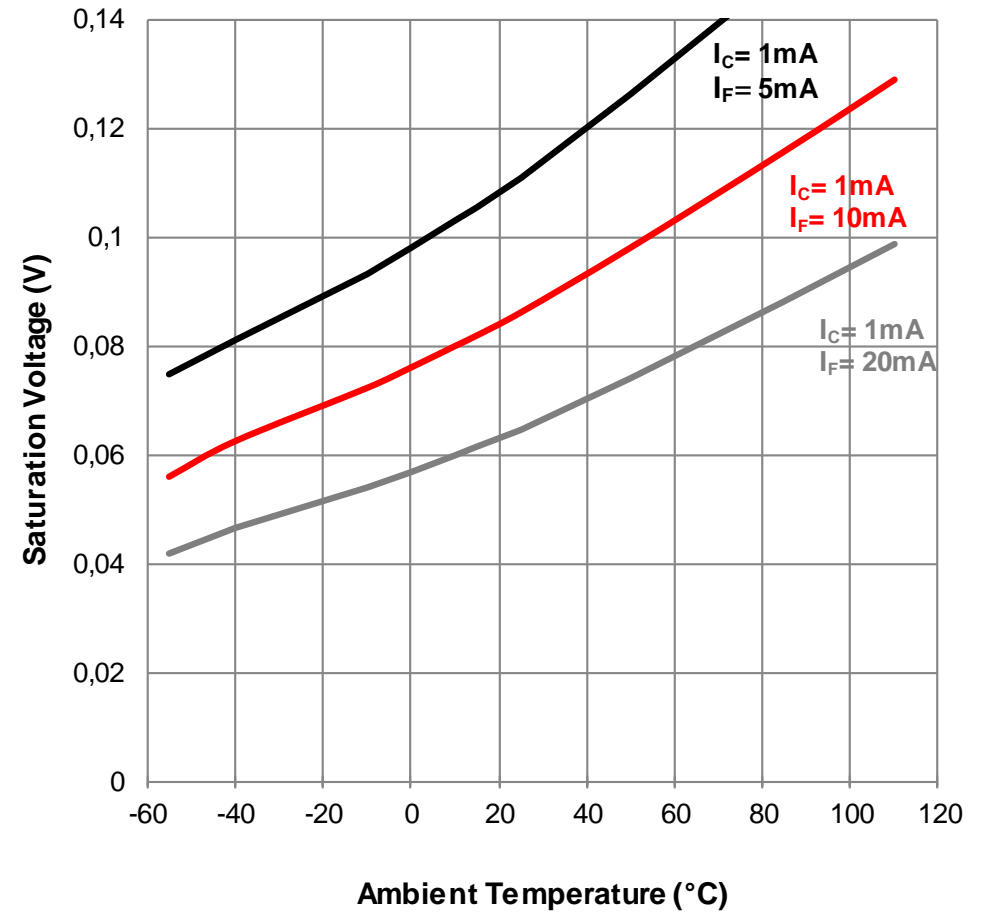

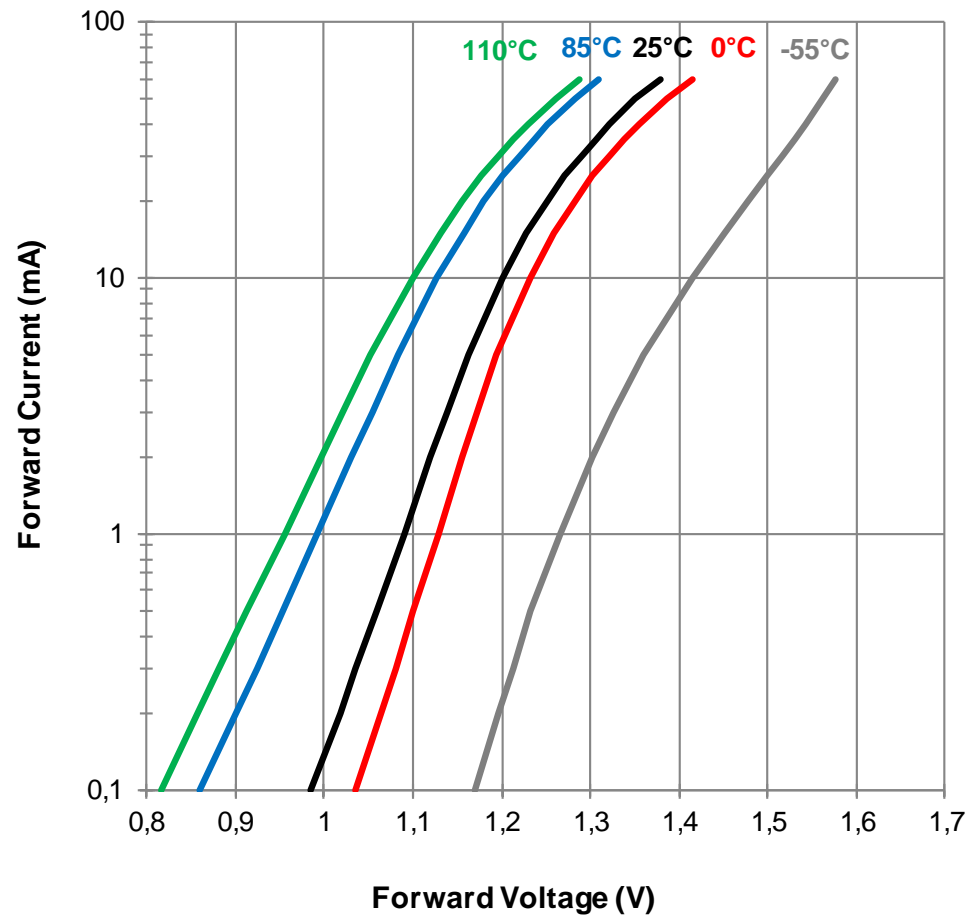
### Collector-Emitter Saturation Voltage vs. Ambient Temperature:



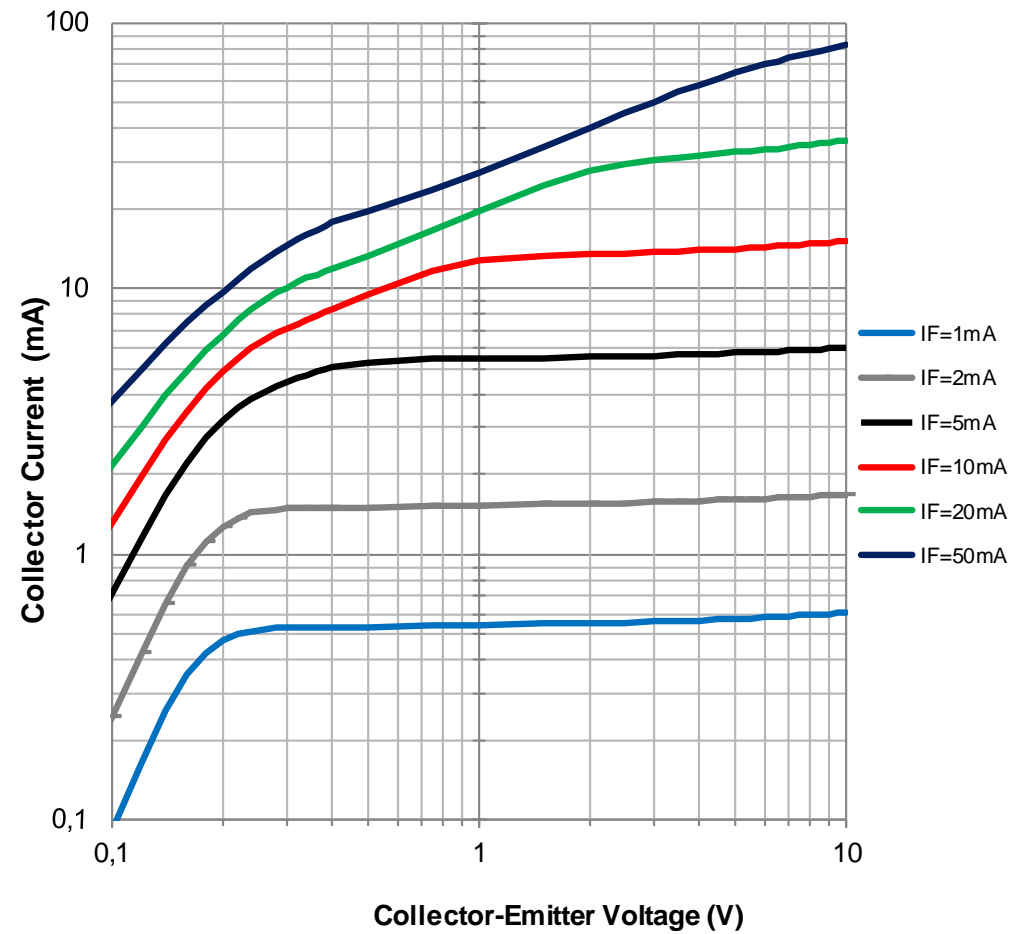

**Collector Current vs. Collector-Emitter Voltage:**

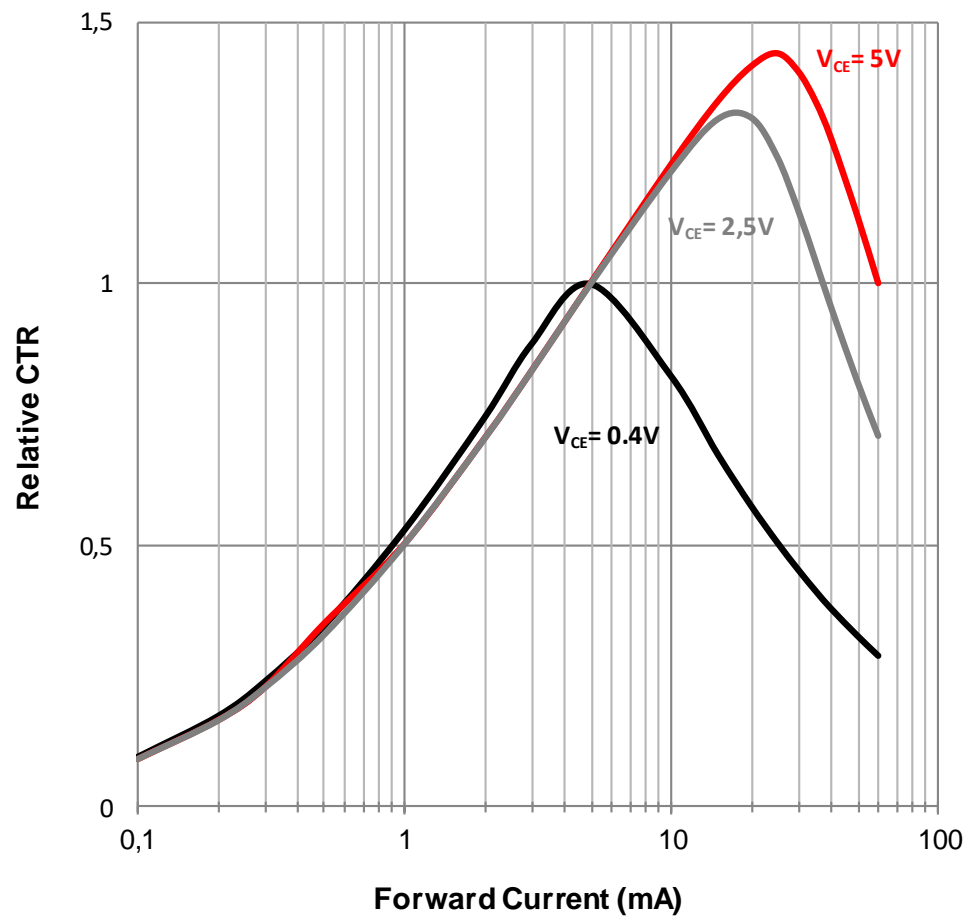

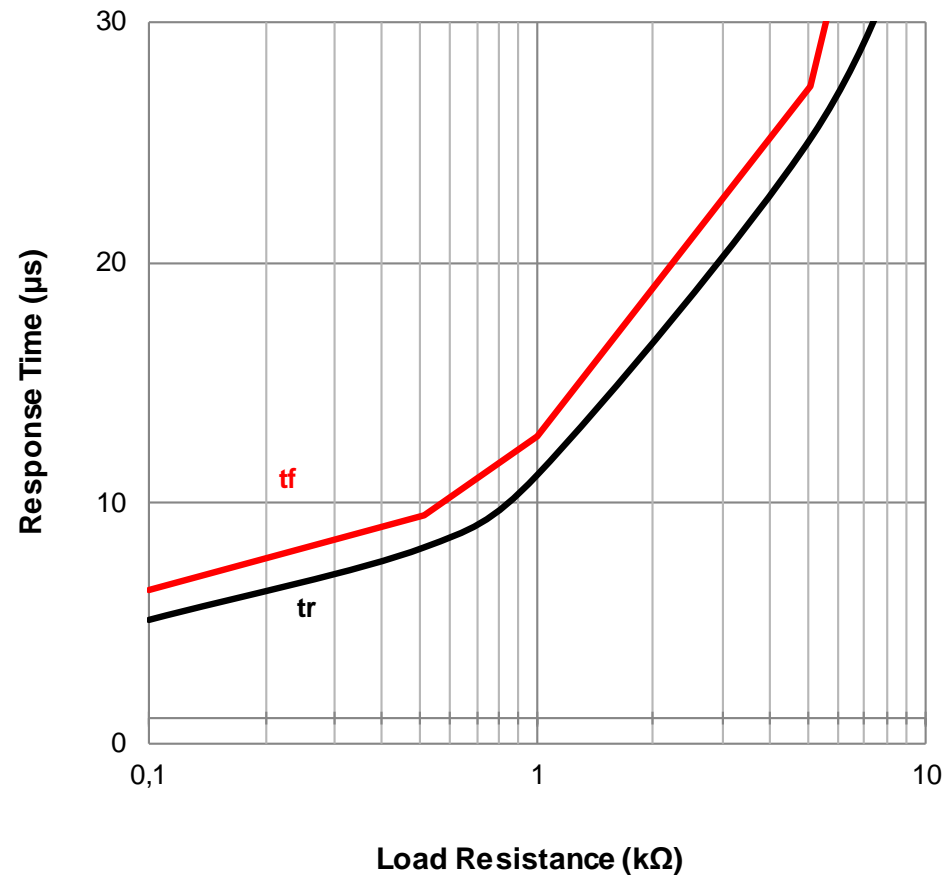

**Switching time vs. Load Resistance:**

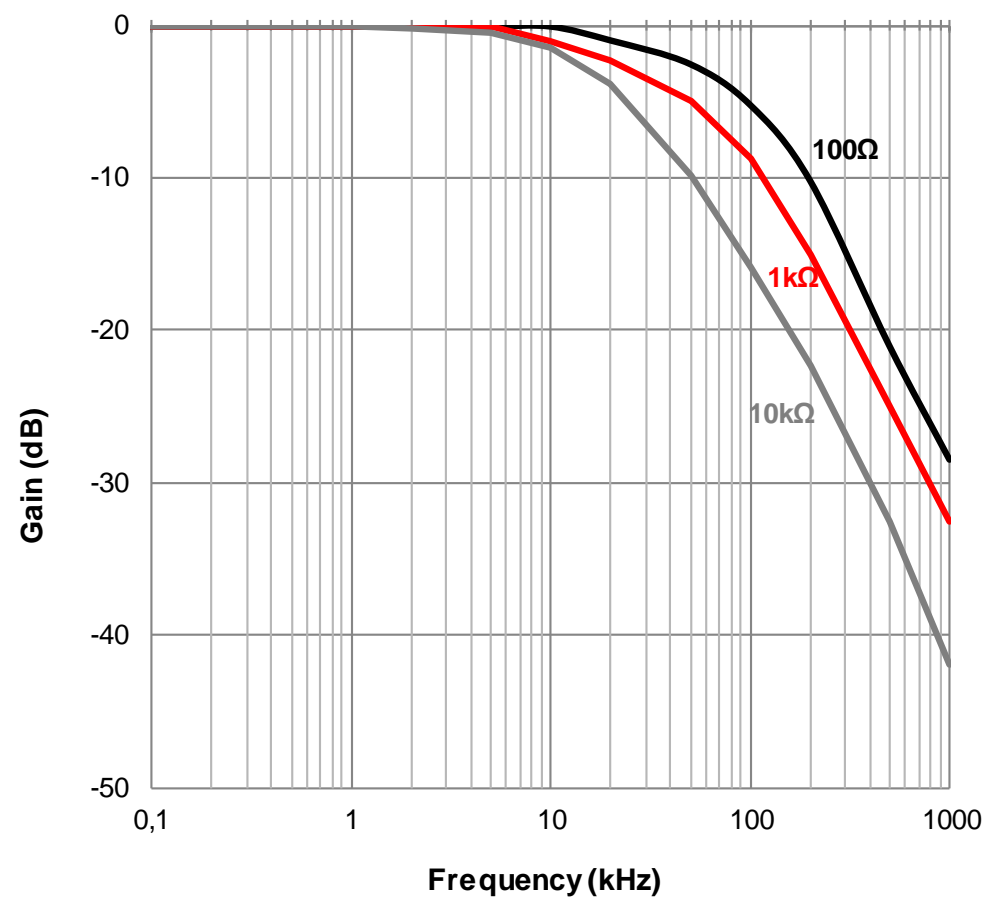
