


# **Total Power Dissipation vs. Ambient Temperature:**




### **Collector Dark Current vs. Ambient Temperature:**







# **Relative CTR vs. Ambient Temperature:**




# **Collector-Emitter Saturation Voltage vs. Ambient Temperature:**






# **Forward Current vs. Forward Voltage:**




# **Collector Current vs. Collector-Emitter Voltage:**





### **Relative CTR vs. Forward Current:**




# **Switching time vs. Load Resistance:**





# Gain vs. Frequency:





