Total Power Dissipation vs. Ambient Temperature:




Collector Dark Current vs. Ambient Temperature:






Relative CTR vs. Ambient Temperature:



Collector-Emitter Saturation Voltage vs. Ambient Temperature:






Forward Current vs. Forward Voltage:



Collector Current vs. Collector-Emitter Voltage:





Relative CTR vs. Forward Current:




Switching time vs. Load Resistance:





In case of further queries regarding the PCN, the field sales engineer or the internal sales person in charge should be contacted. 6. Product Life Cycle


