
### **Relative CTR vs. Ambient Temperature:**




### **Collector-Emitter Saturation Voltage vs. Ambient Temperature:**





### **Forward Current vs. Forward Voltage:**




### **Collector Current vs. Collector-Emitter Voltage:**






#### **Relative CTR vs. Forward Current:**



### **Switching time vs. Load Resistance:**


