### Forward Current vs. Forward Voltage:



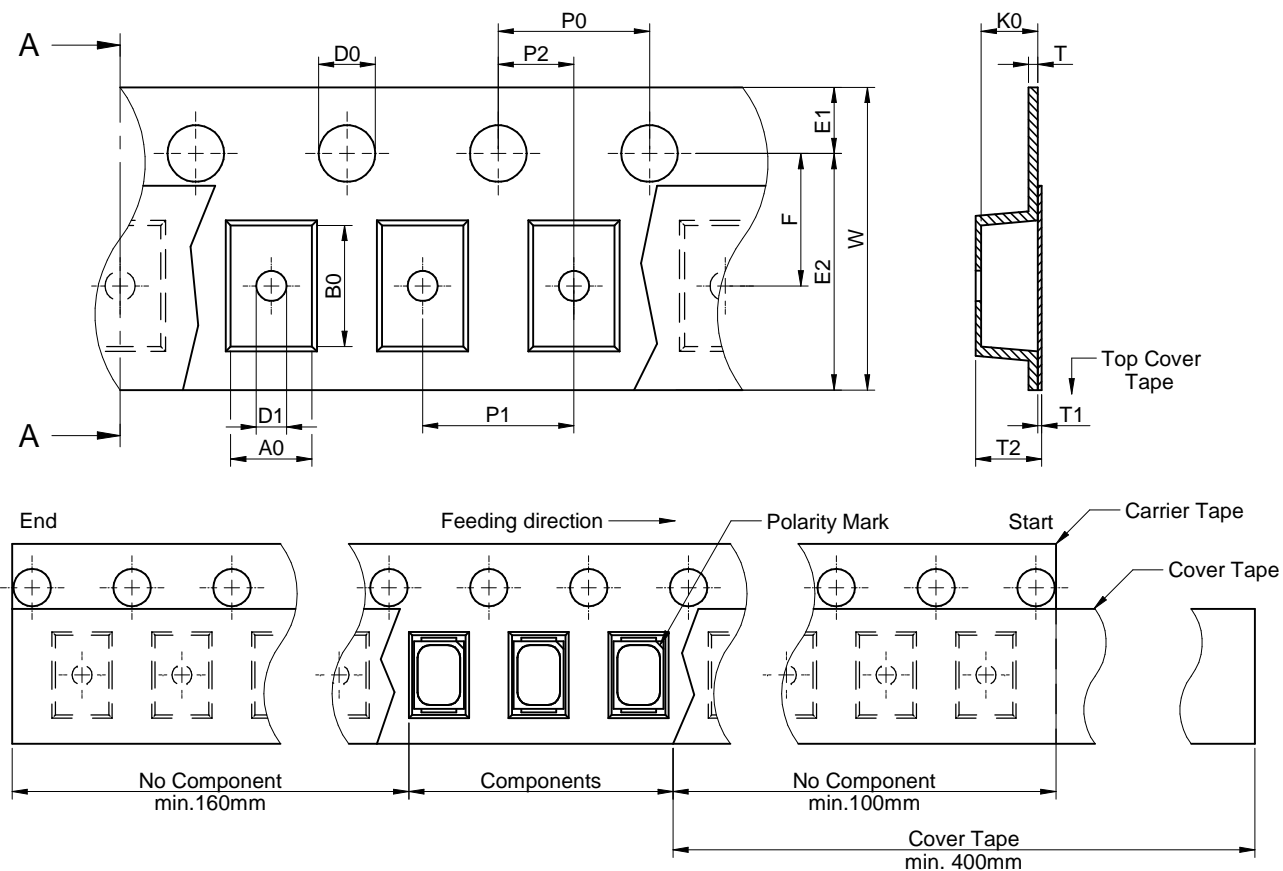

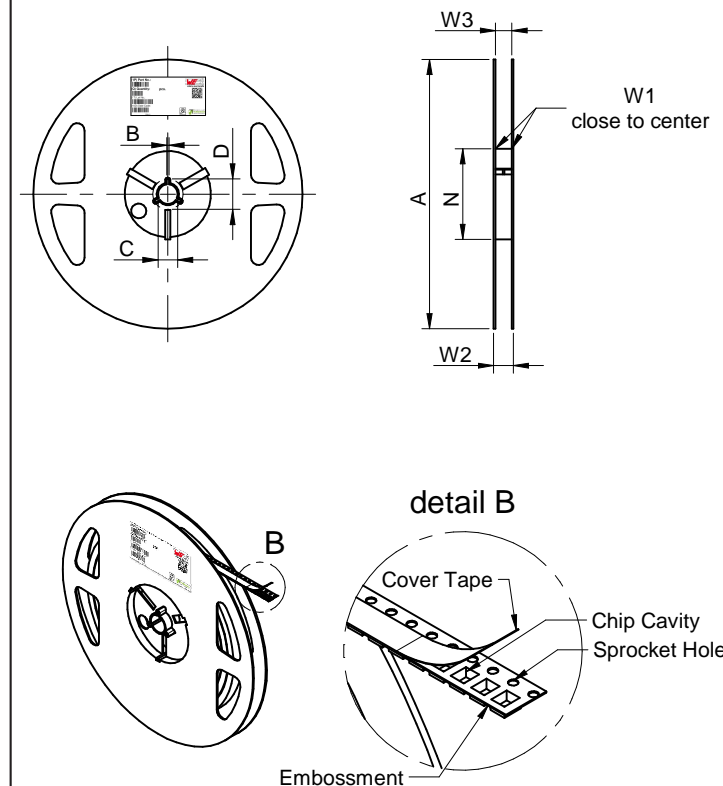

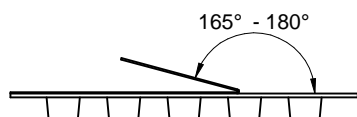

#### Soldering






