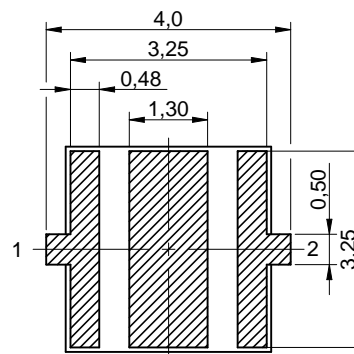


Polarity Mark (Cathode)



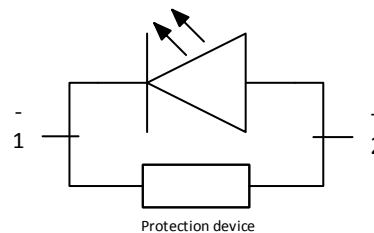

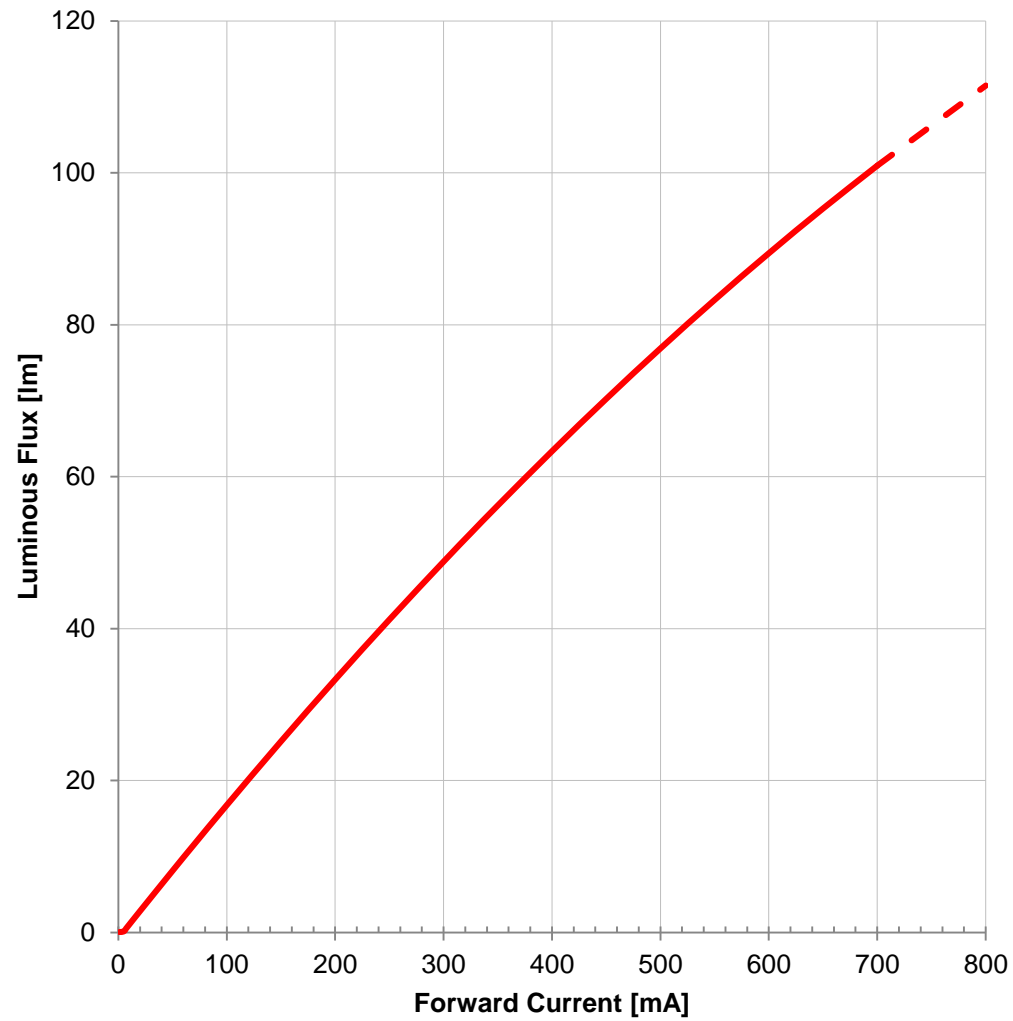
**Forward Current vs. Forward Voltage:**



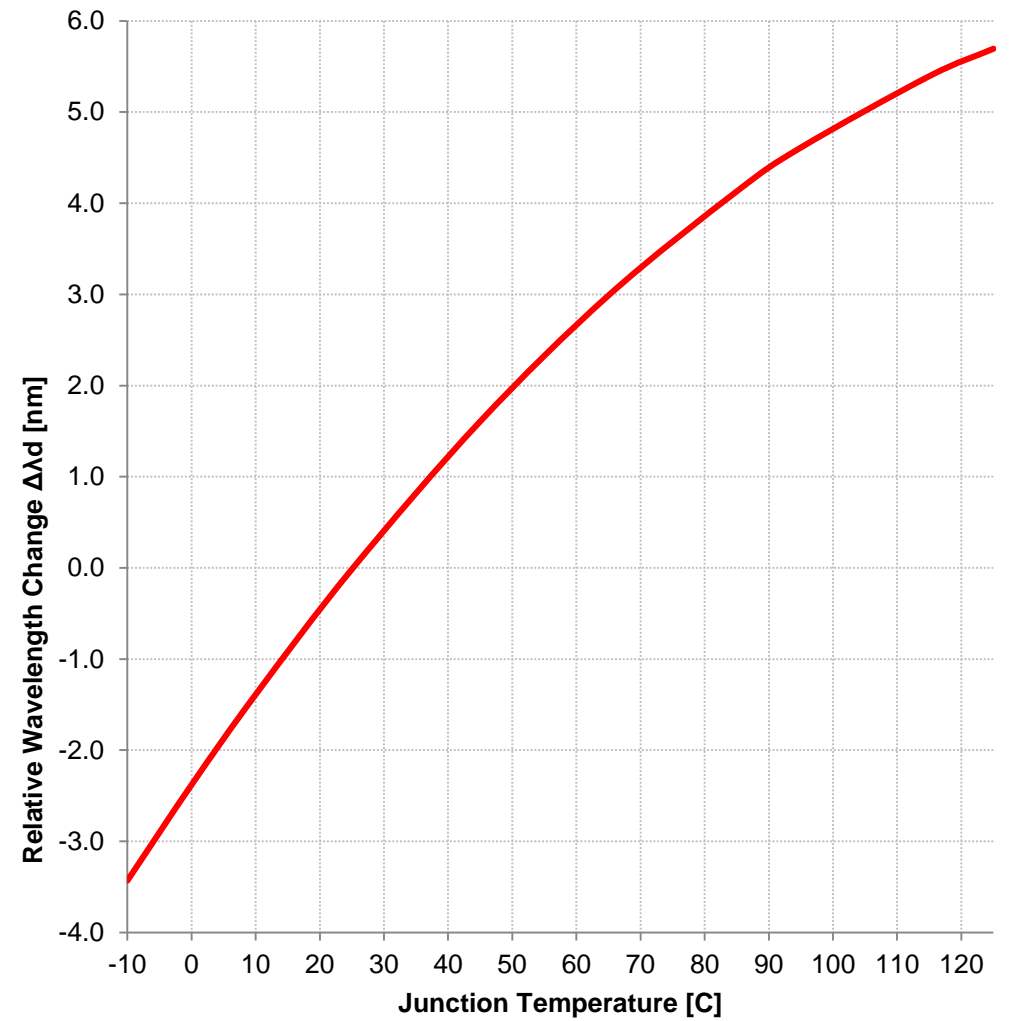

**Luminous Flux vs. Forward Current:**



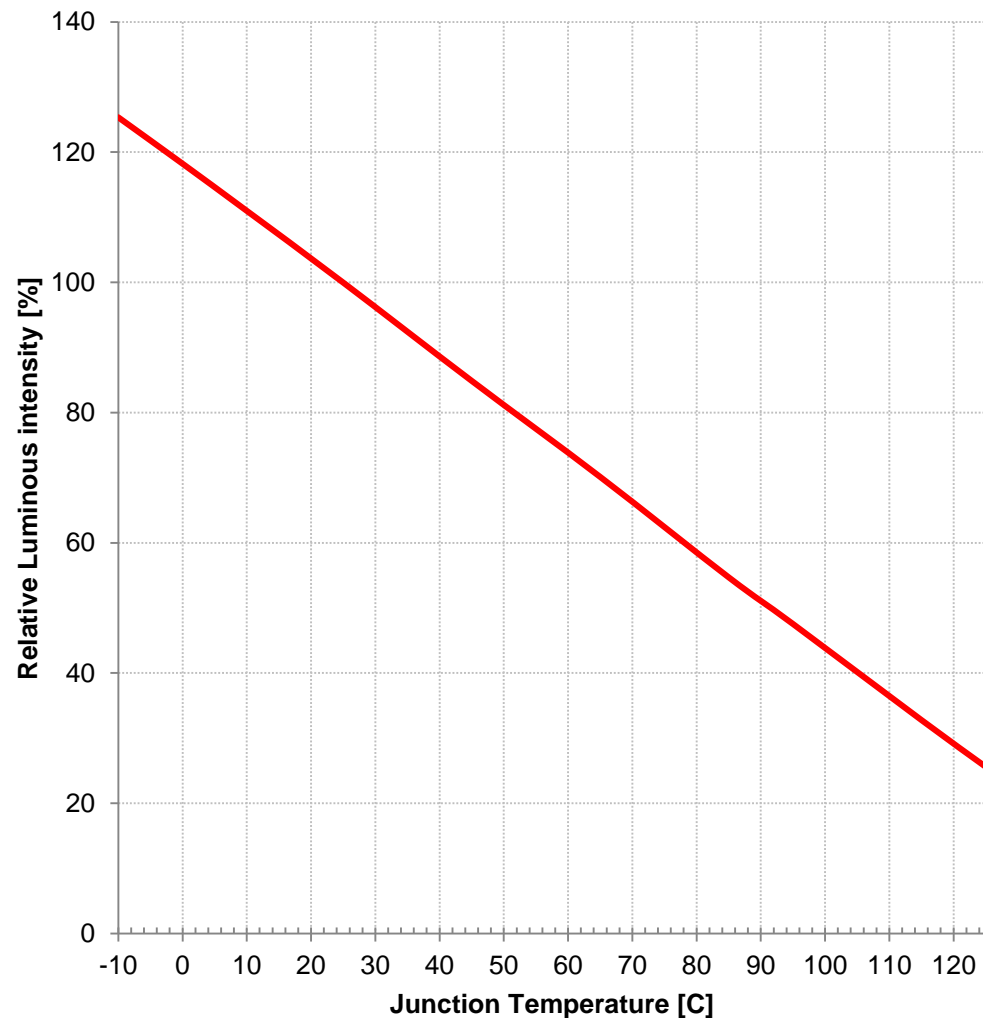
**Junction Temperature vs. Dominant Wavelength:**



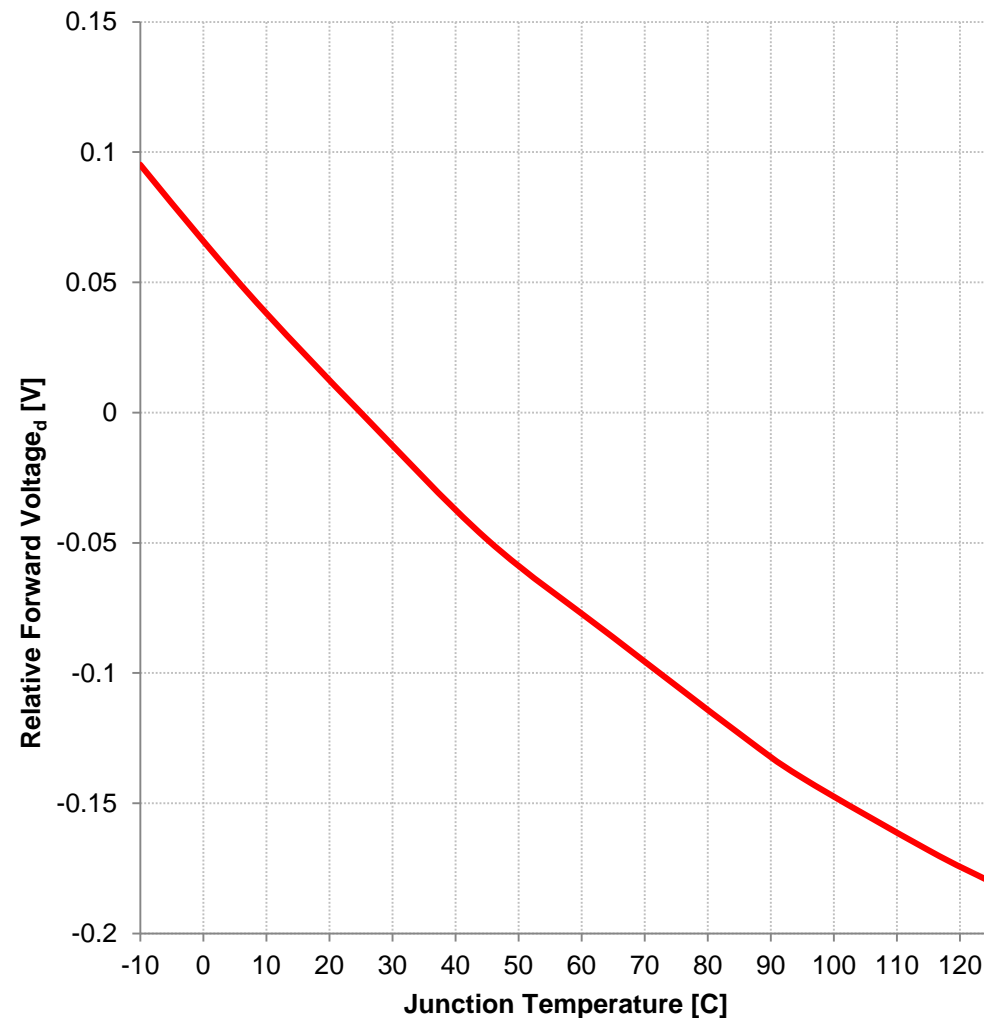

### Junction Temperature vs. Luminous Intensity:



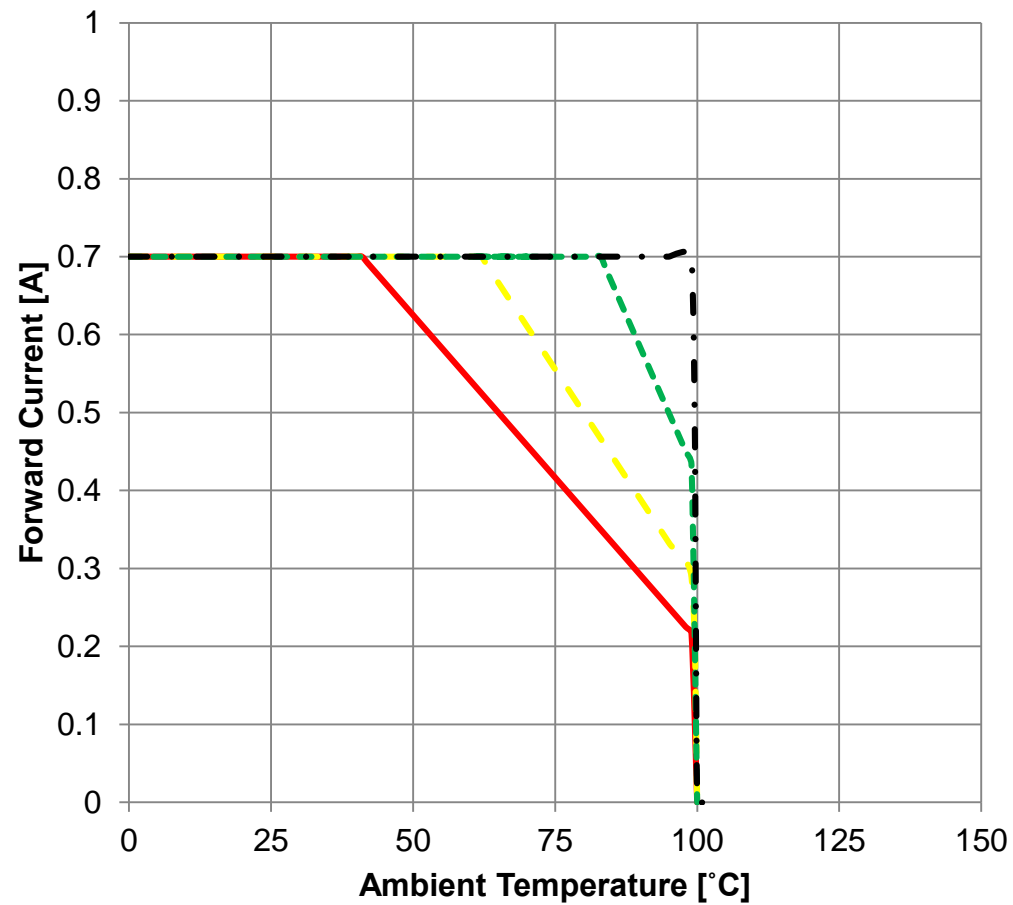
