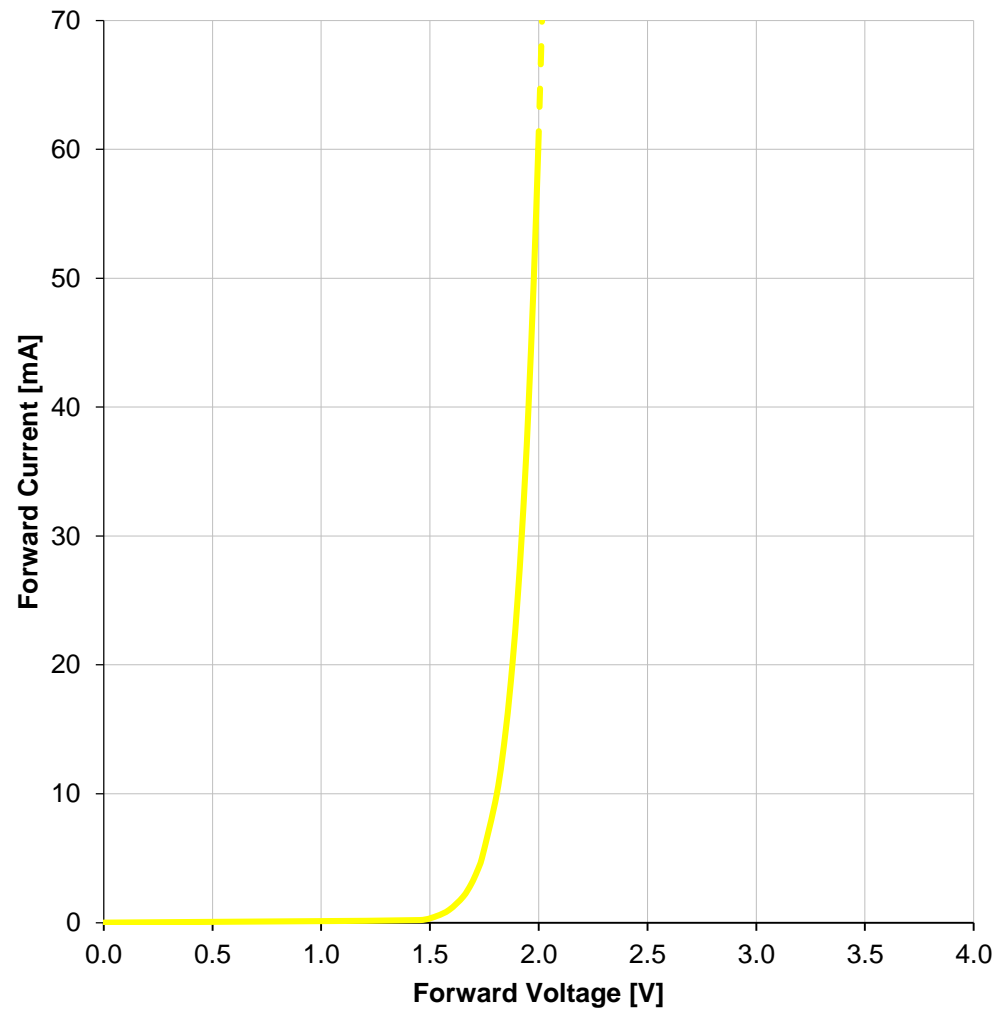


**Luminous Intensity vs. Forward Current:**

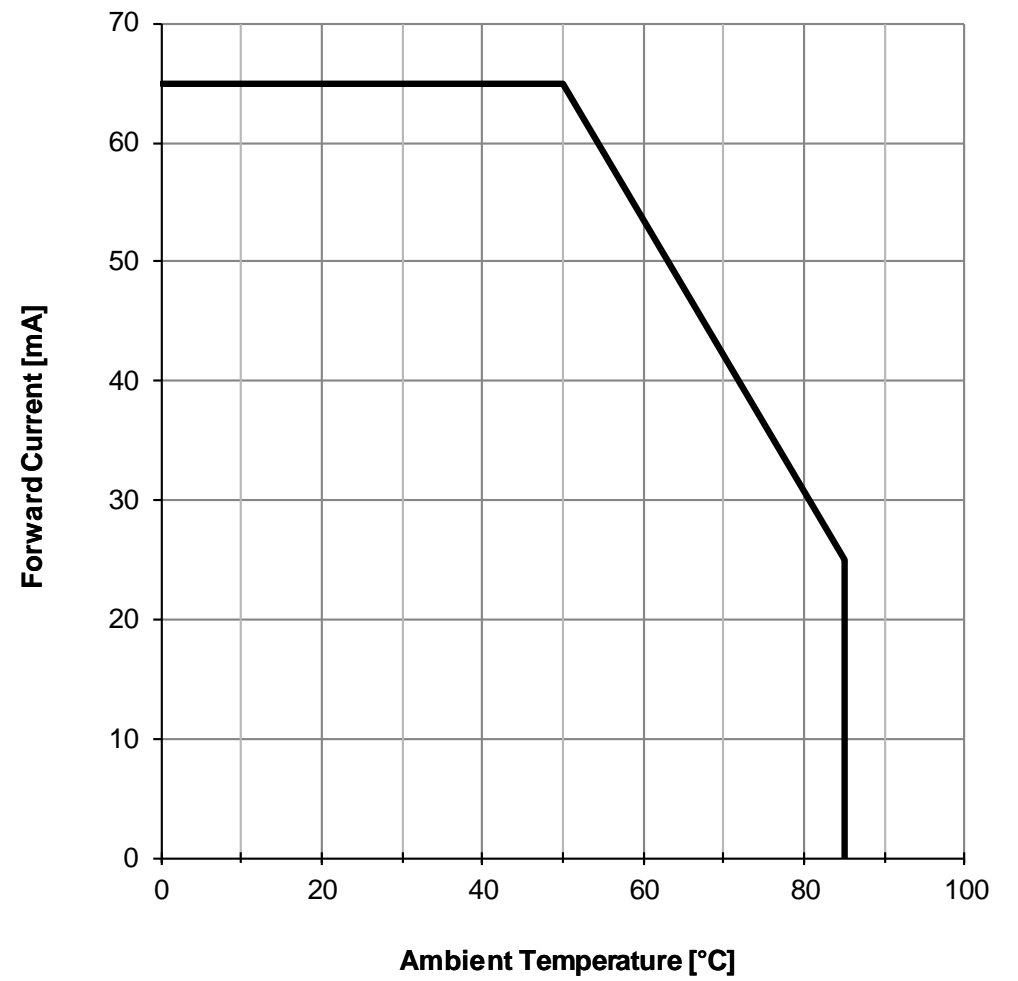

### Forward Current vs. Forward Voltage:

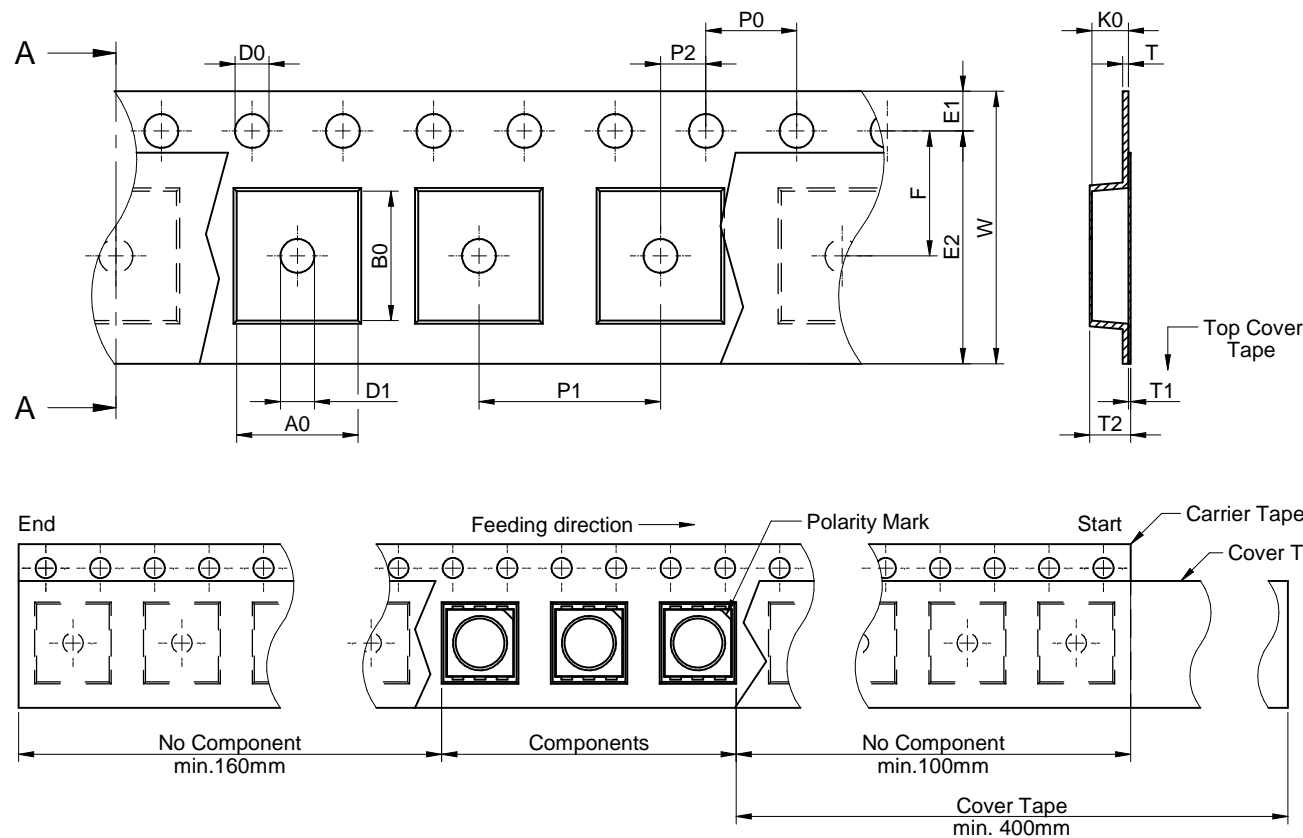

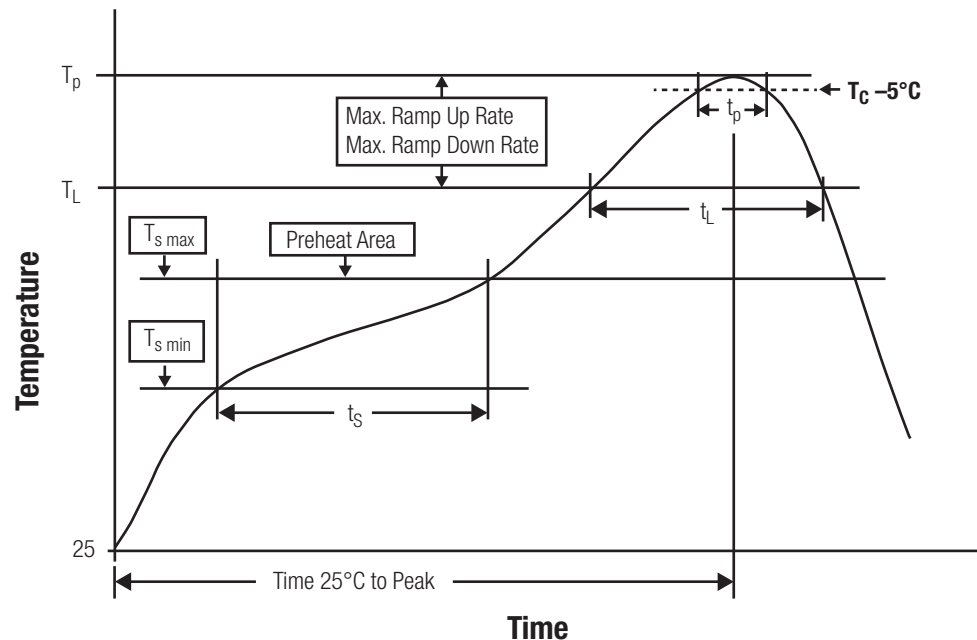

#### Soldering:






