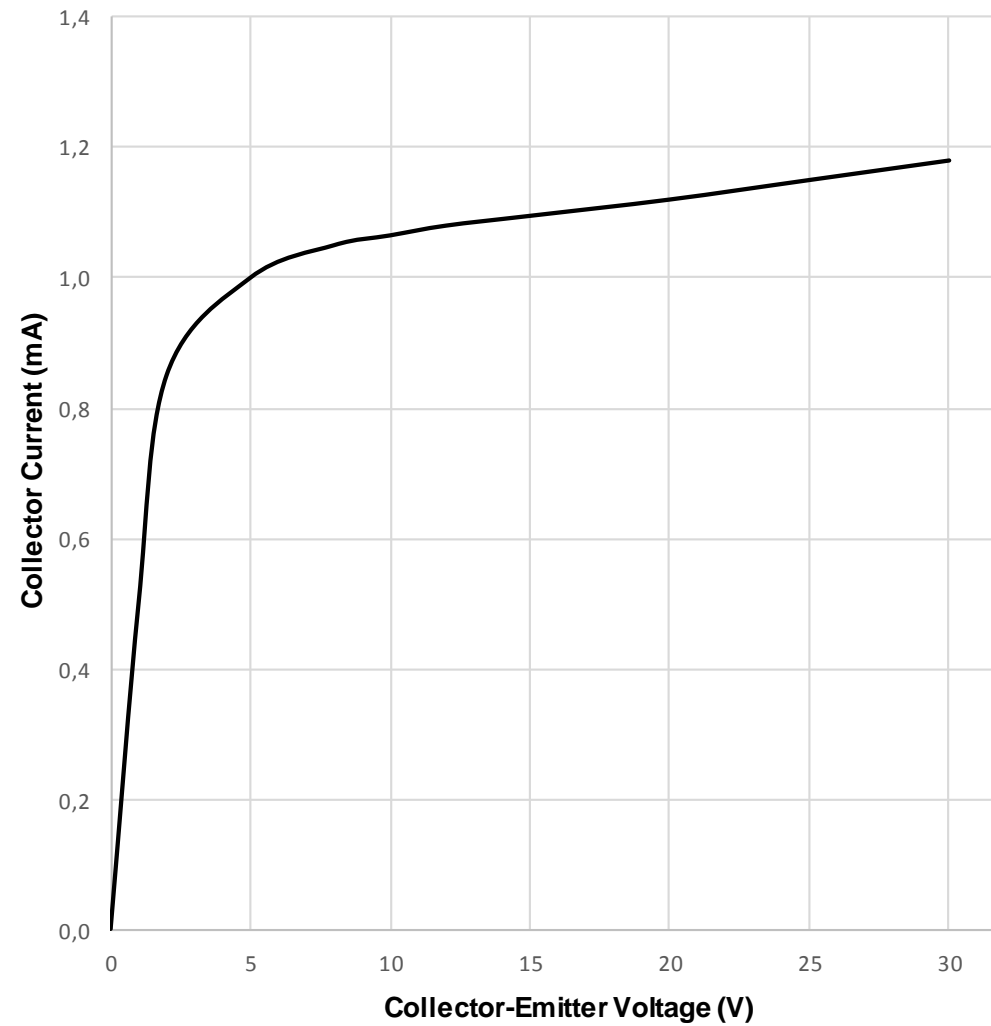
Collector Current vs. Irradiance:

Soldering:






