Photocurrent vs. Irradiance:

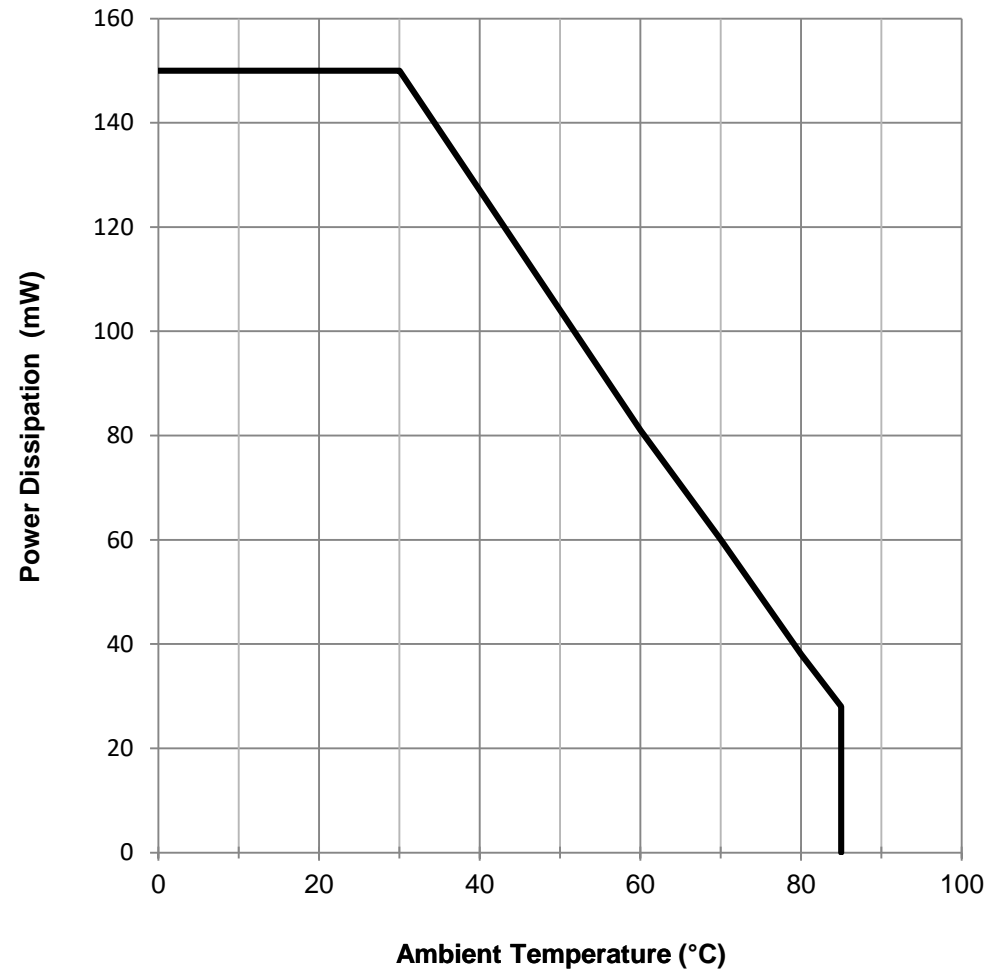




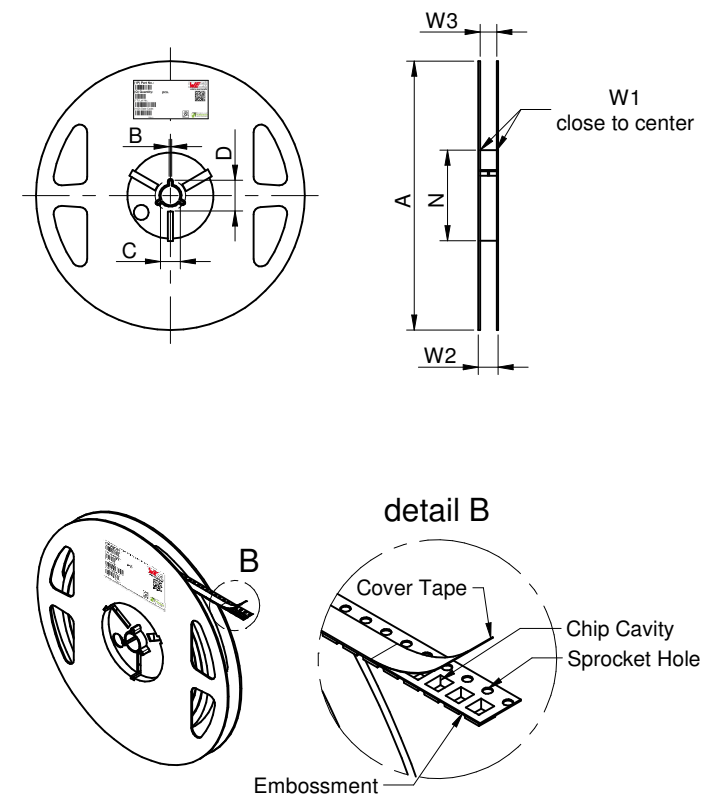
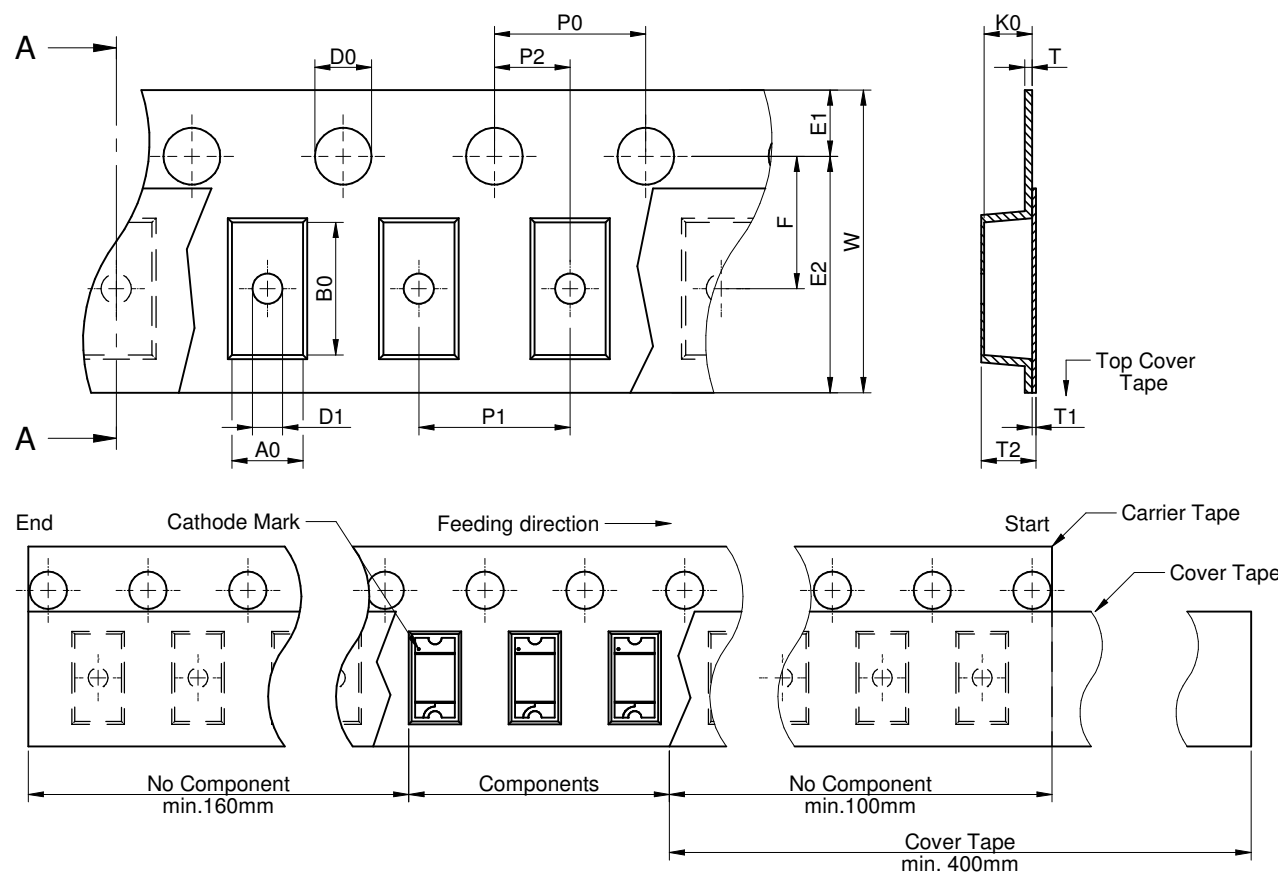
Derating Curve:

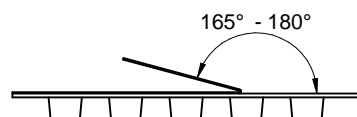

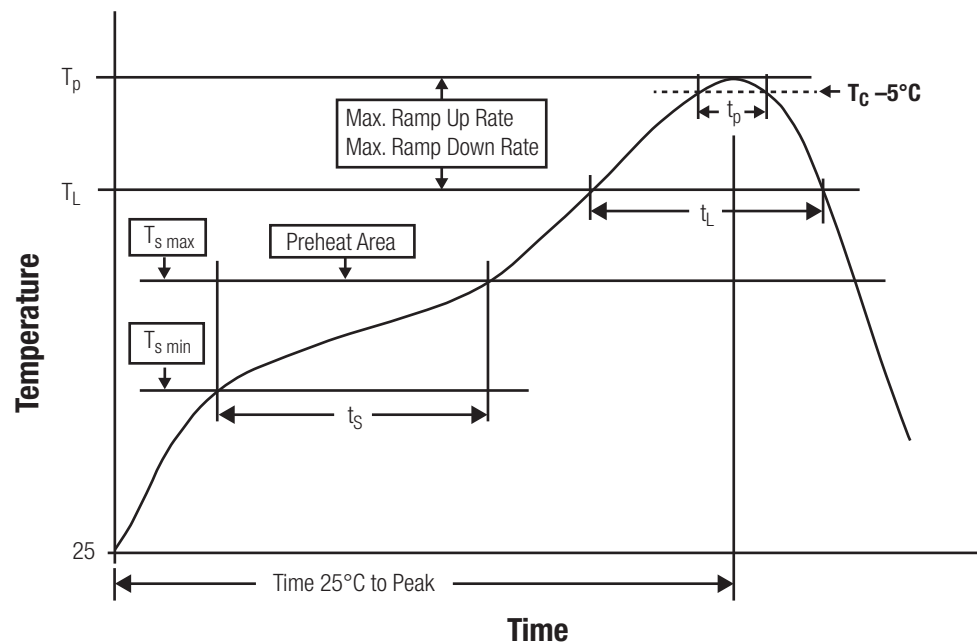

Soldering:




