### Collector Current vs. Irradiance:

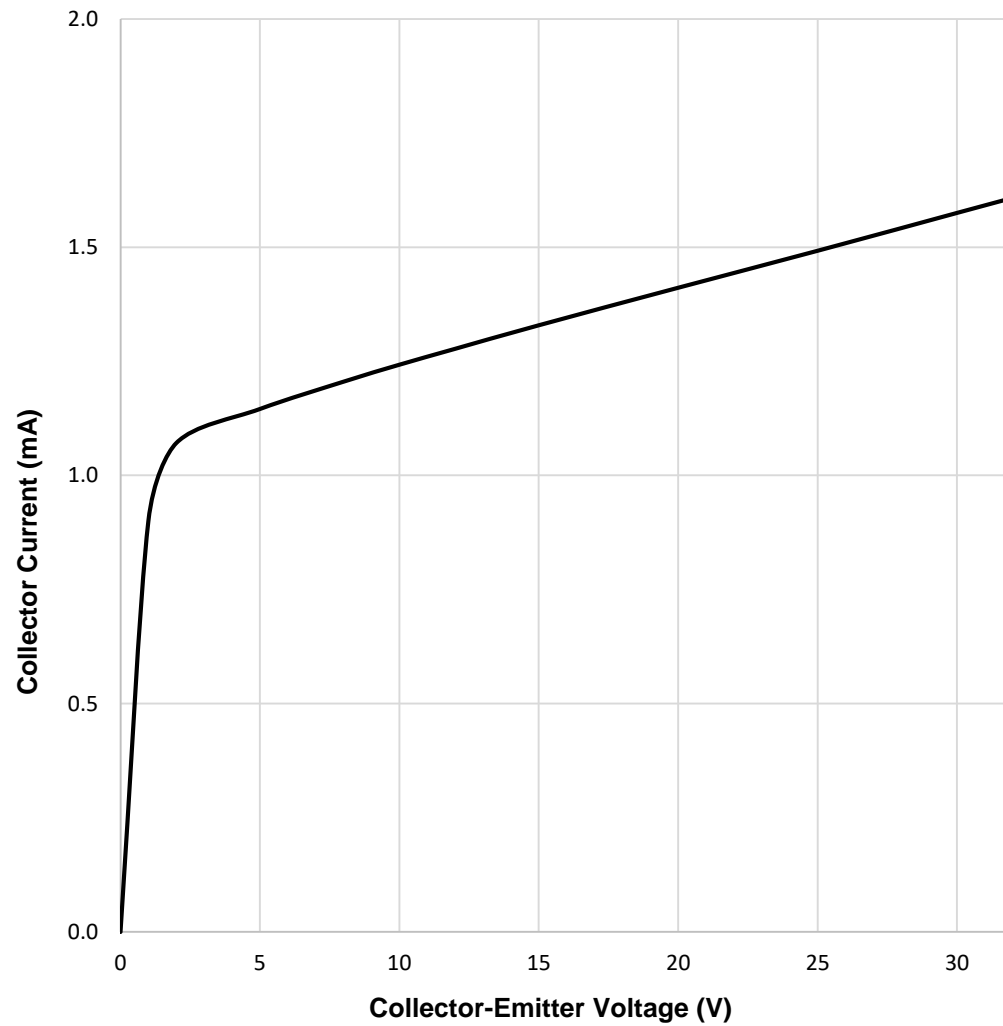

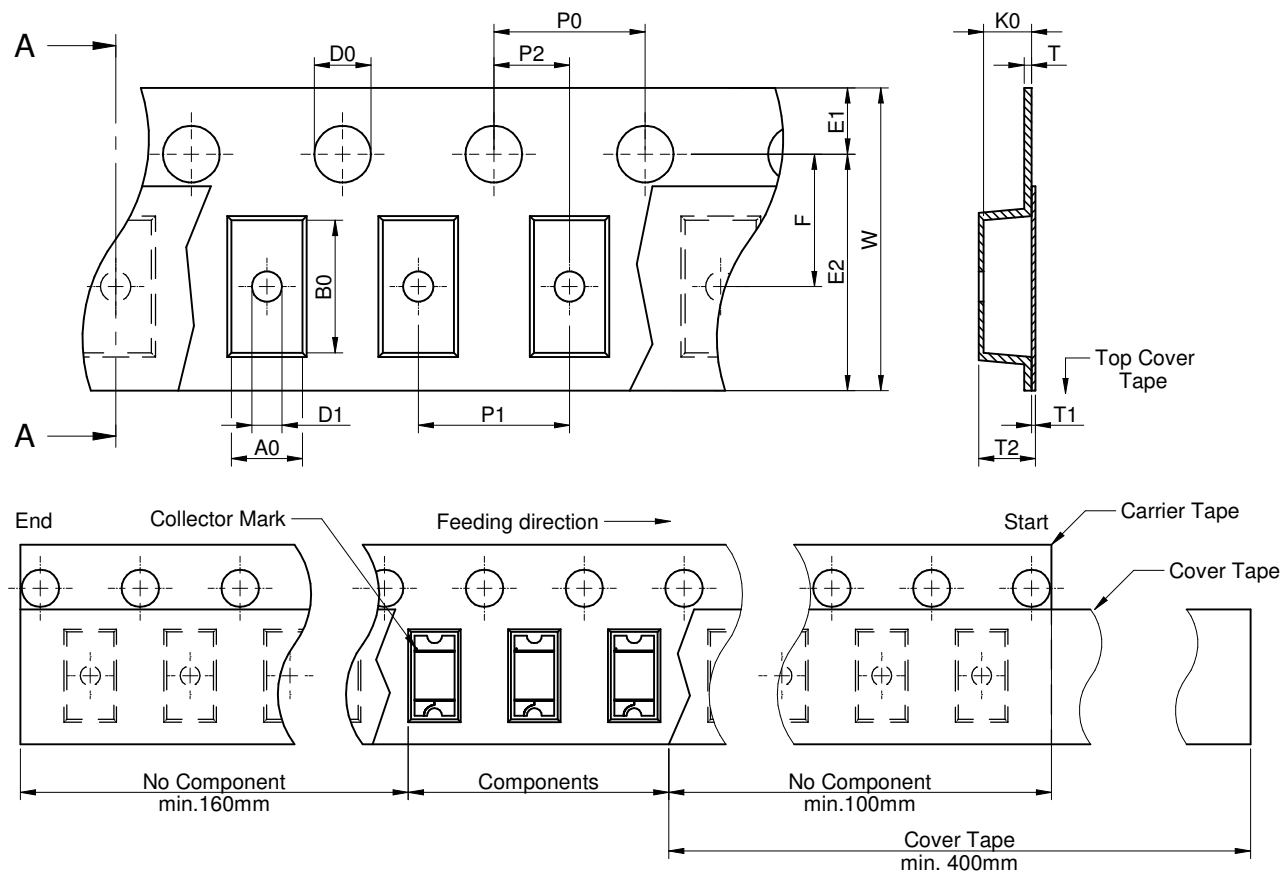

#### Soldering:






