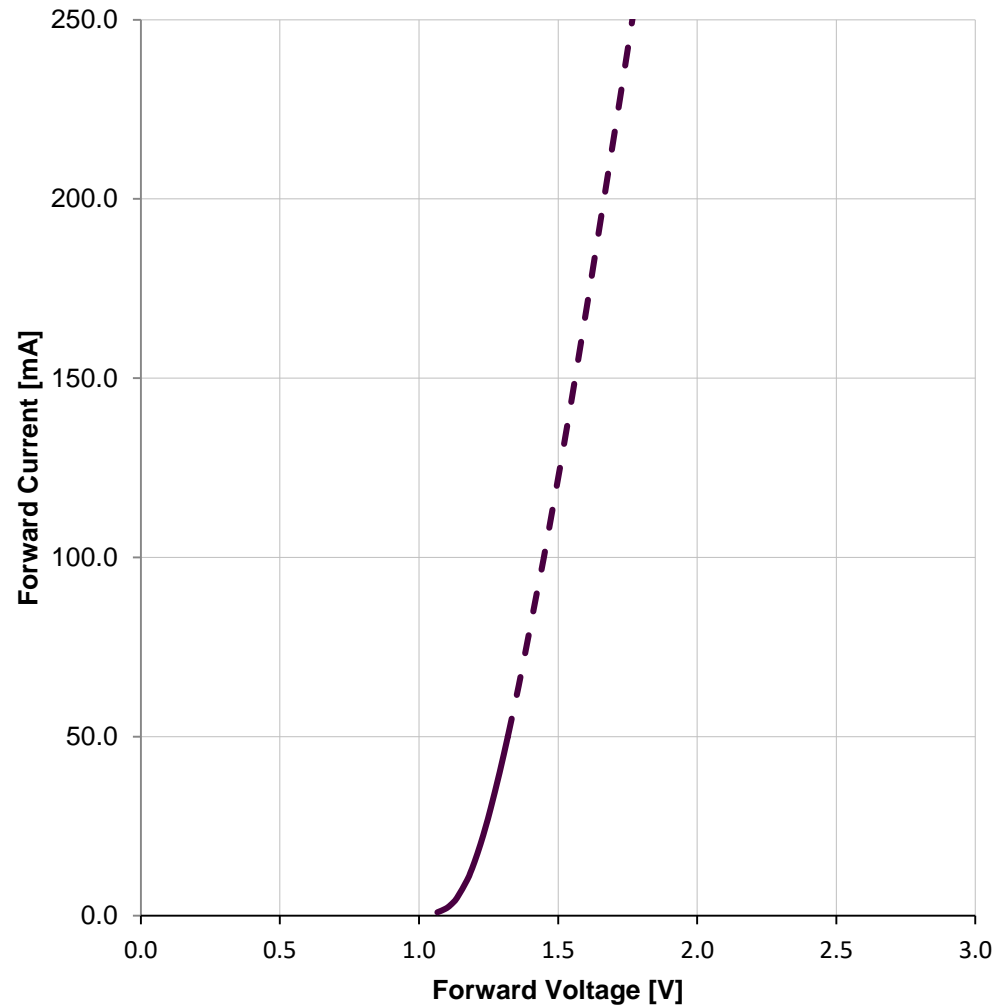


**Relative Radiant Intensity vs. Forward Current:**

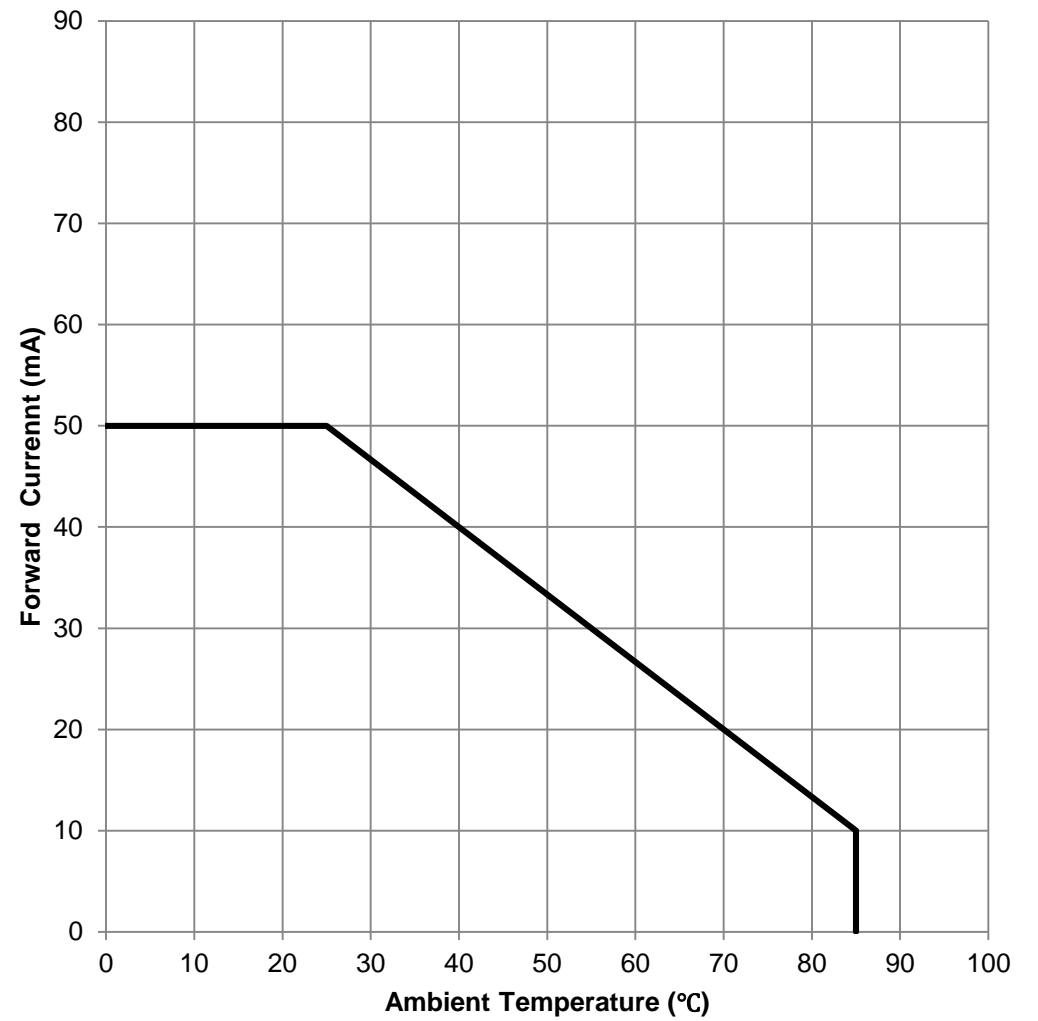

### Forward Current vs. Forward Voltage:



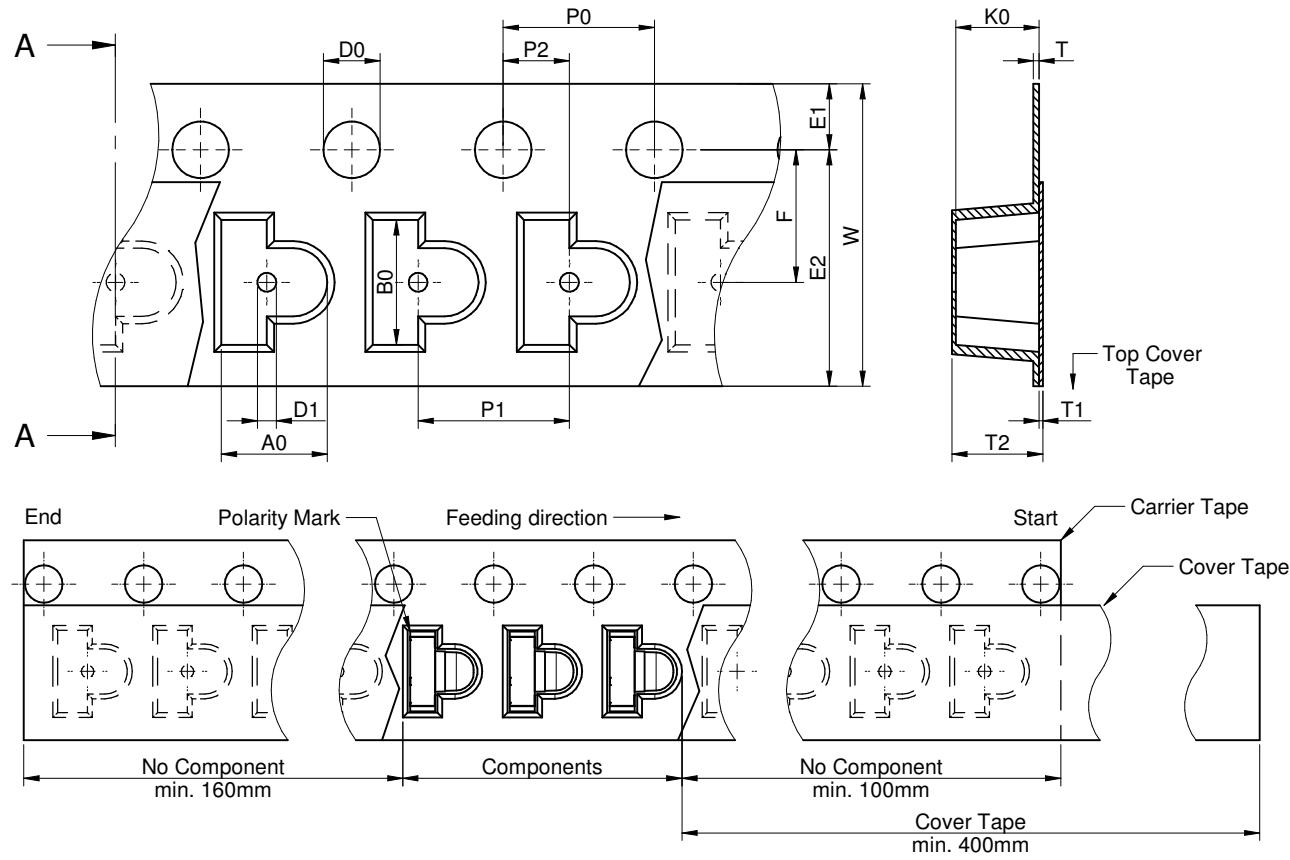
