### Collector Current vs. Irradiance:

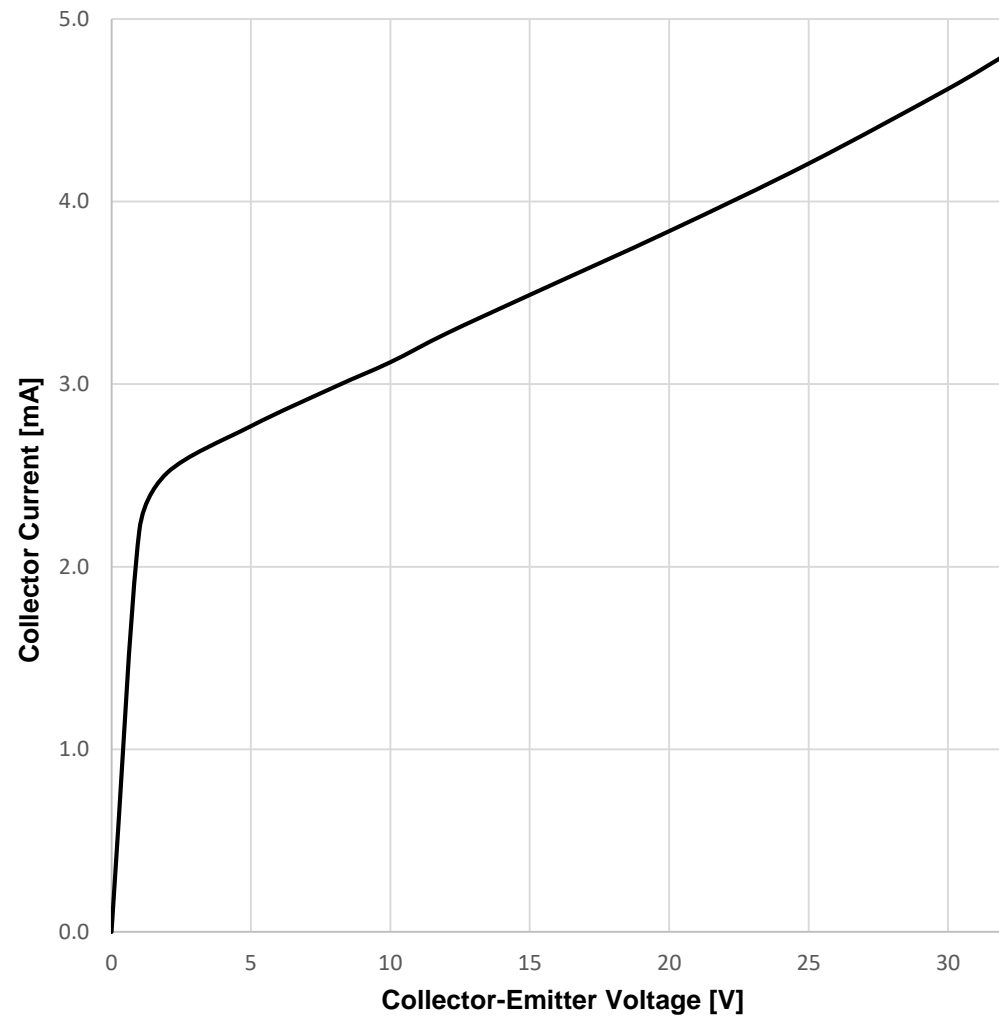

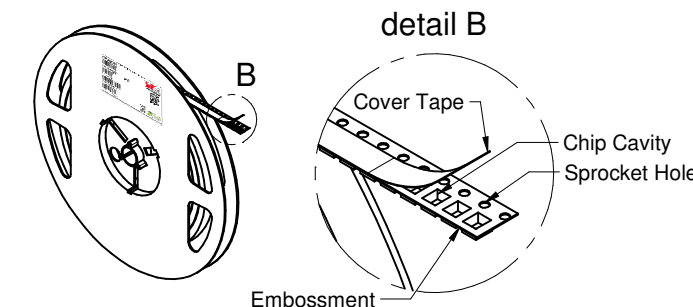
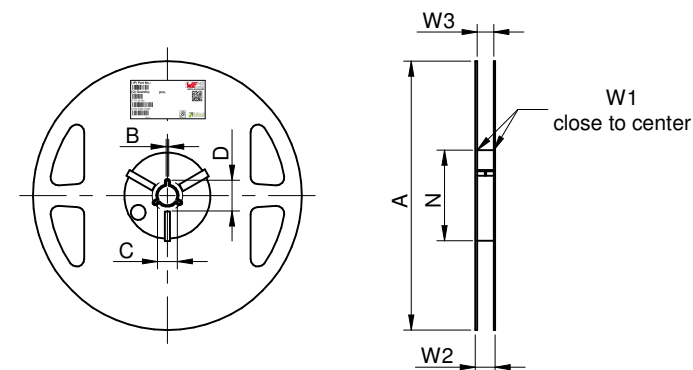
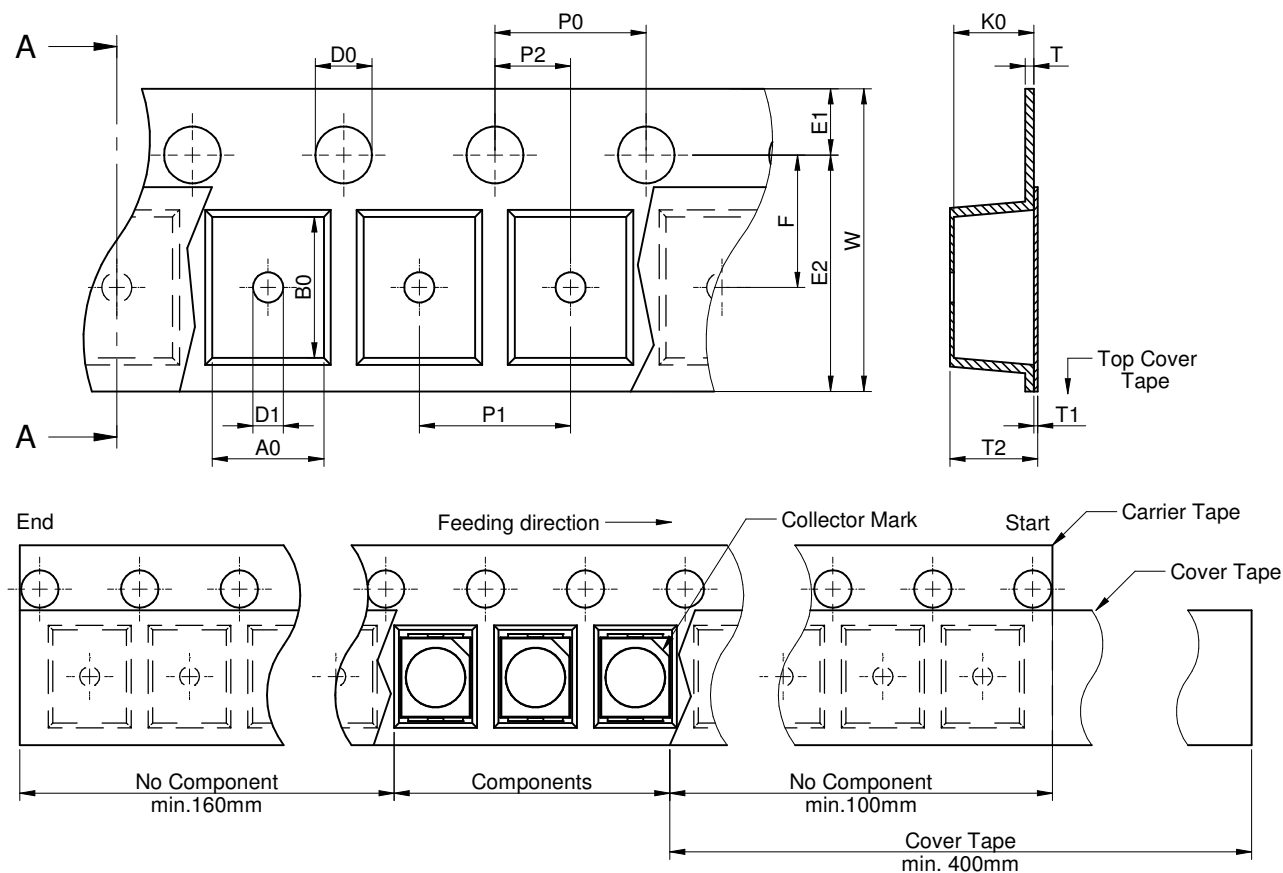
### Derating Curve:

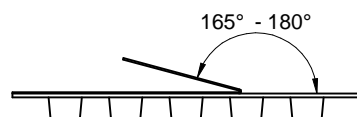




