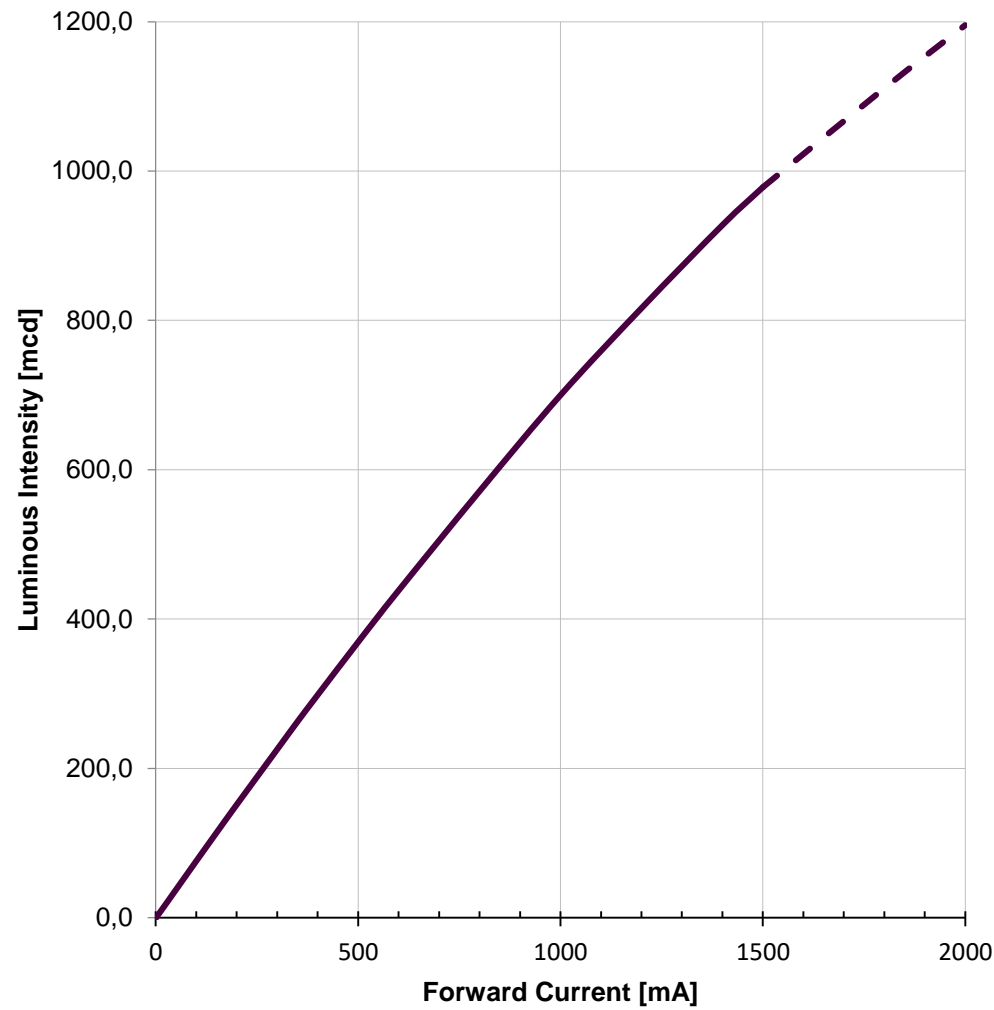


Forward Current vs. Forward Voltage:

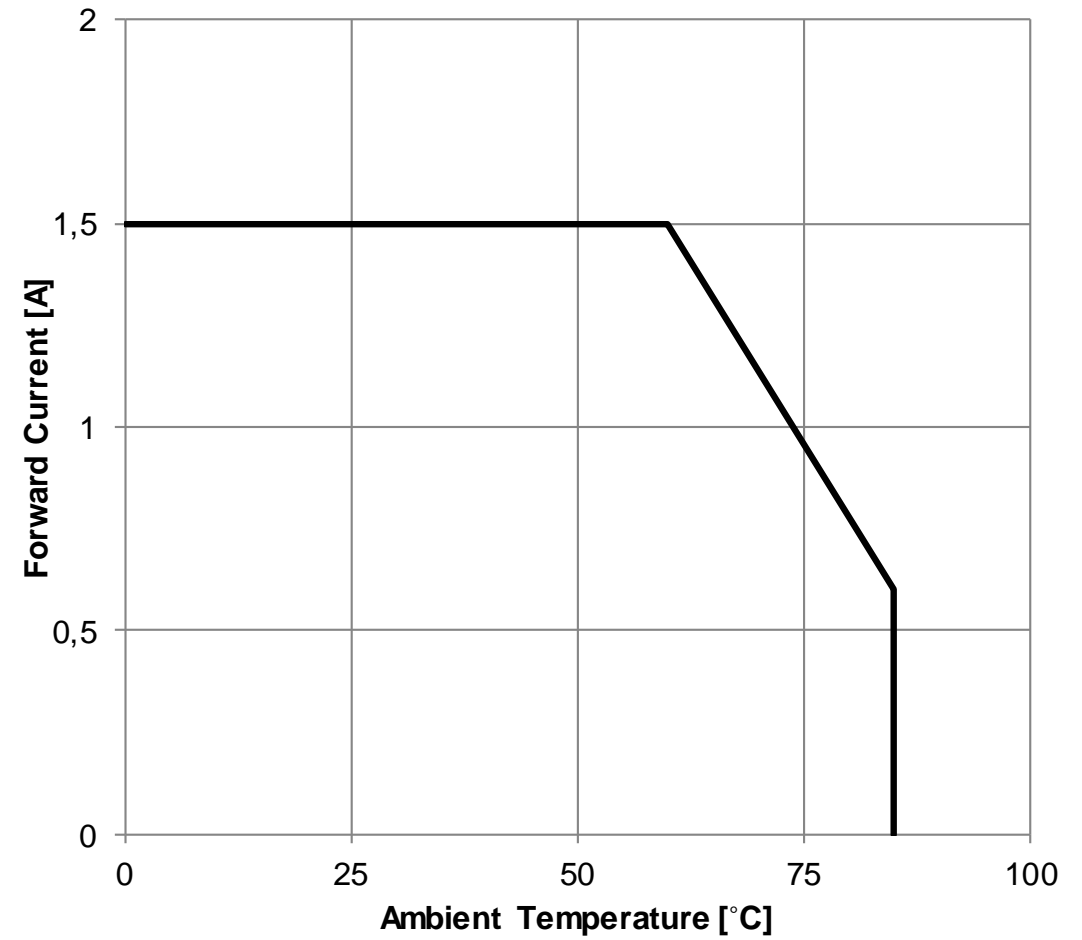

Luminous Intensity vs. Forward Current:



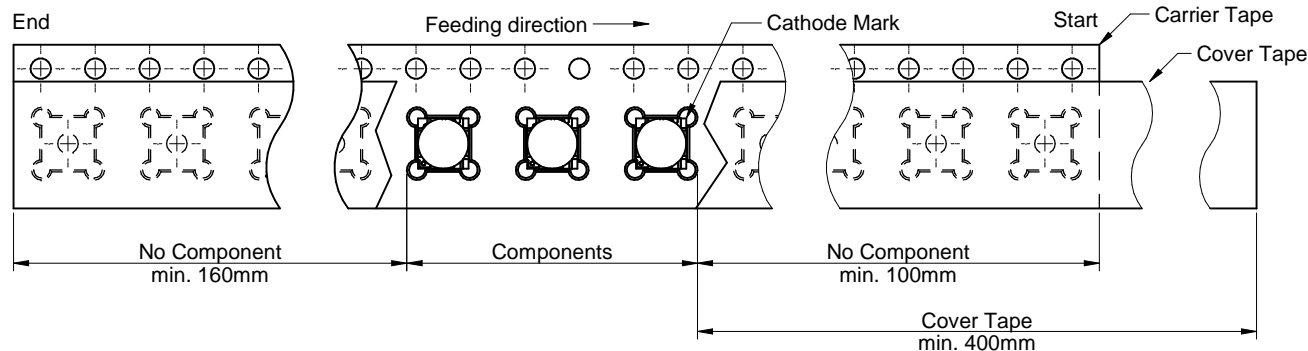
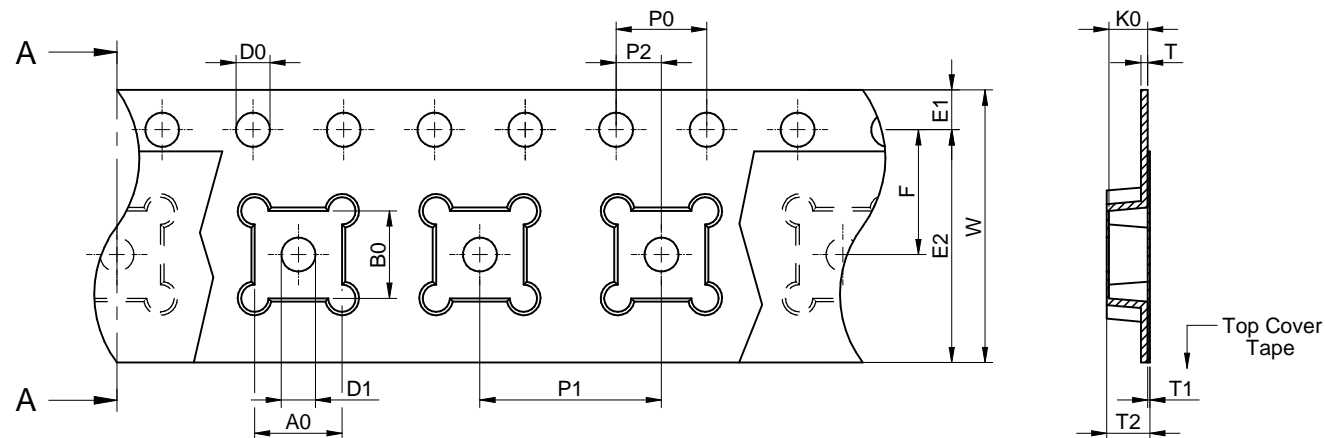

Soldering:






