### Radiant Flux vs. Forward Current:



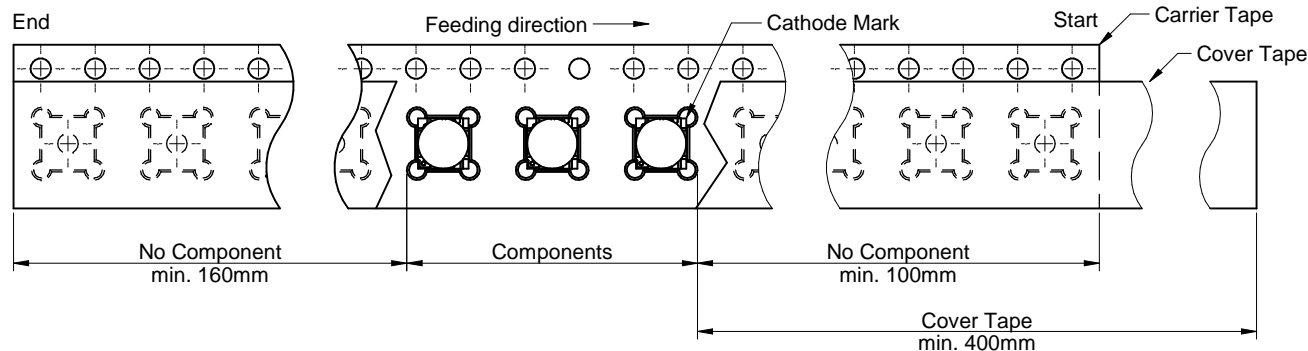
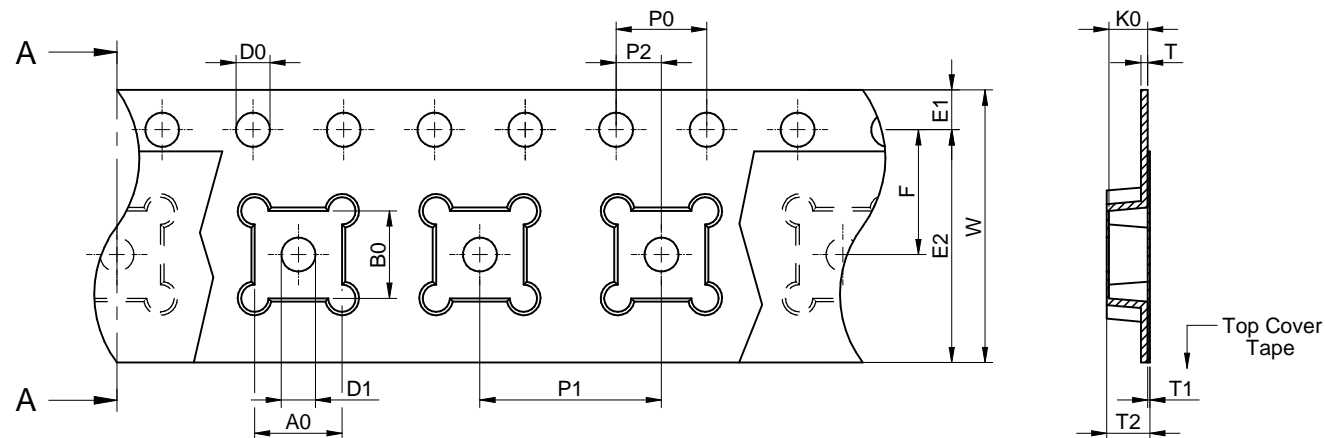
