

Relative Intensity [%]


Luminous Intensity vs. Forward Current:

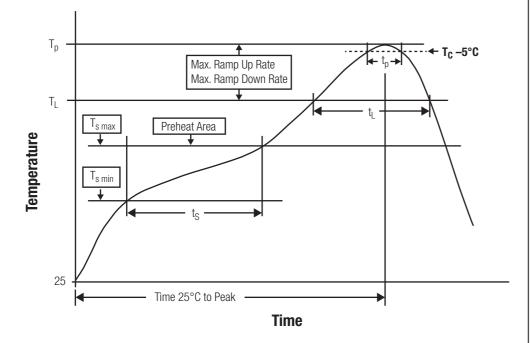
