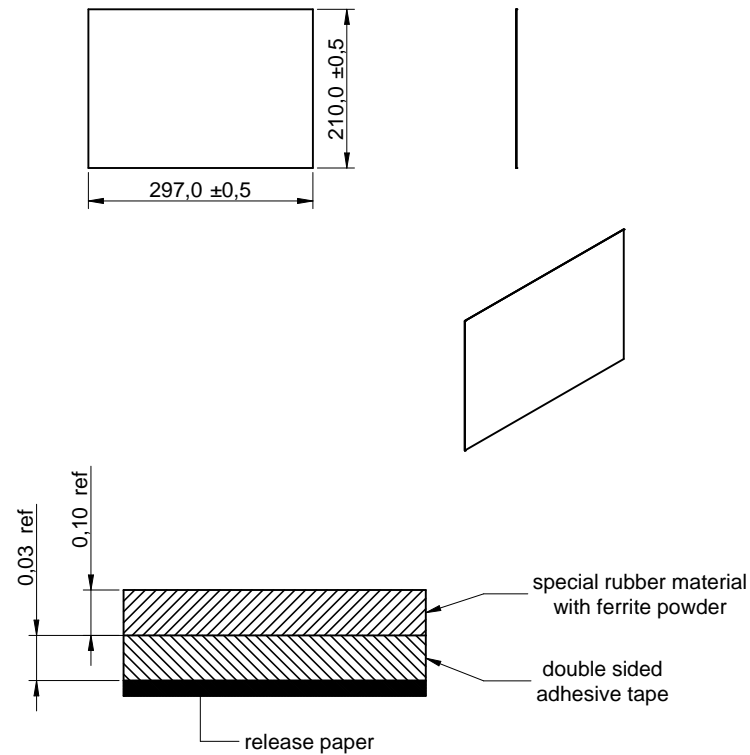

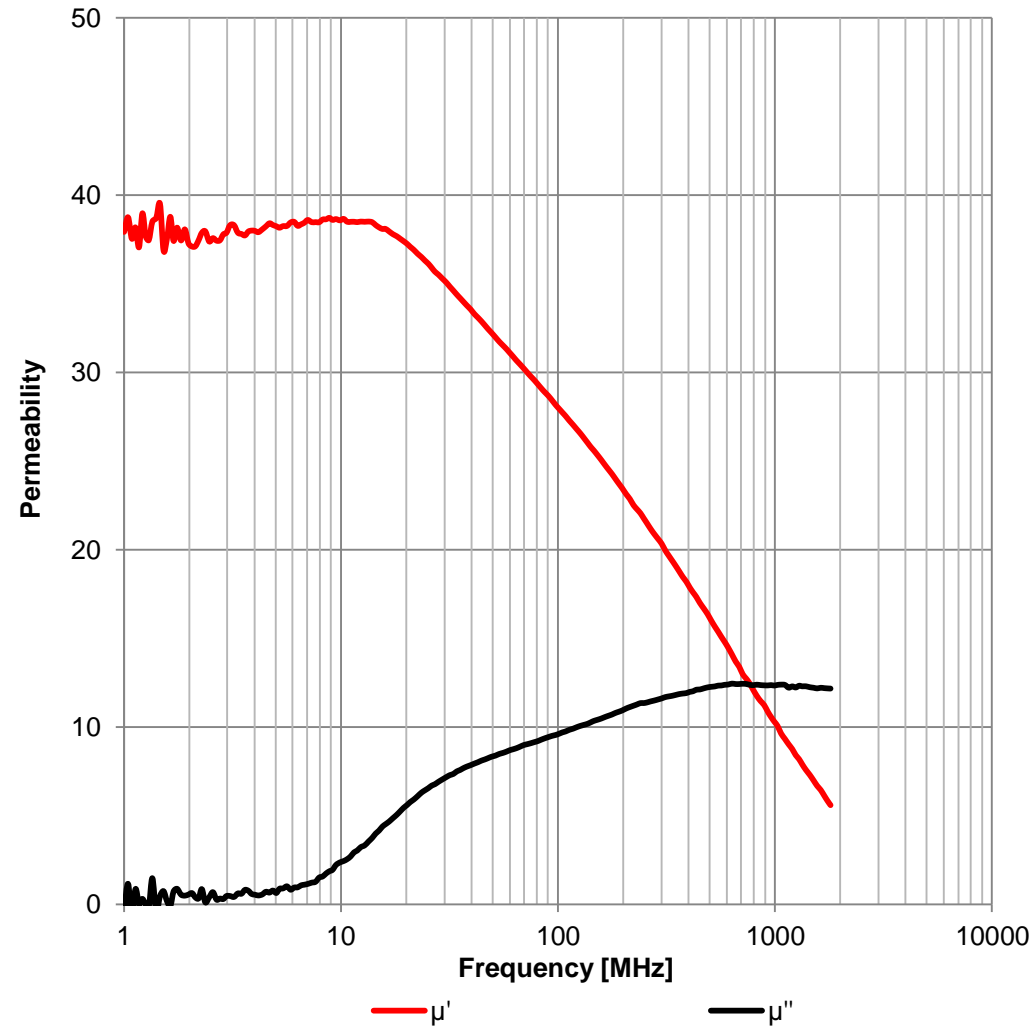

#### Product specific:

#### Cleaning and Washing:



#### Packaging:


