

### **Cleaning and Washing:**

 A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.

- Do not expose the components to direct sunlight.

### Packaging:
