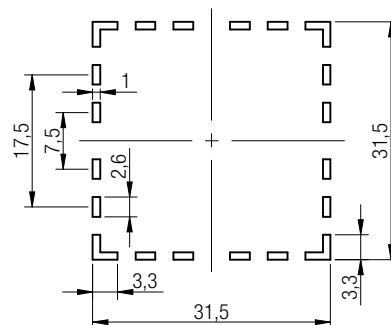


**sectional drawing A-A**



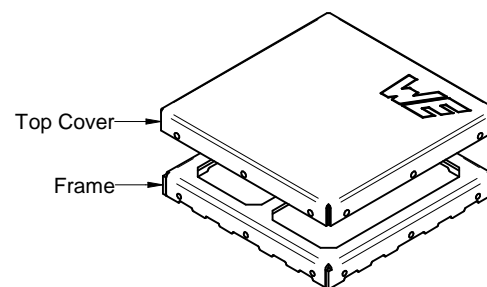



#### Packaging:


