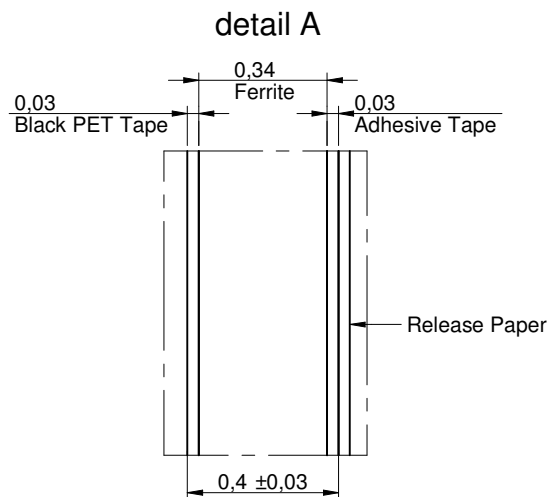
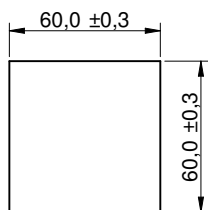

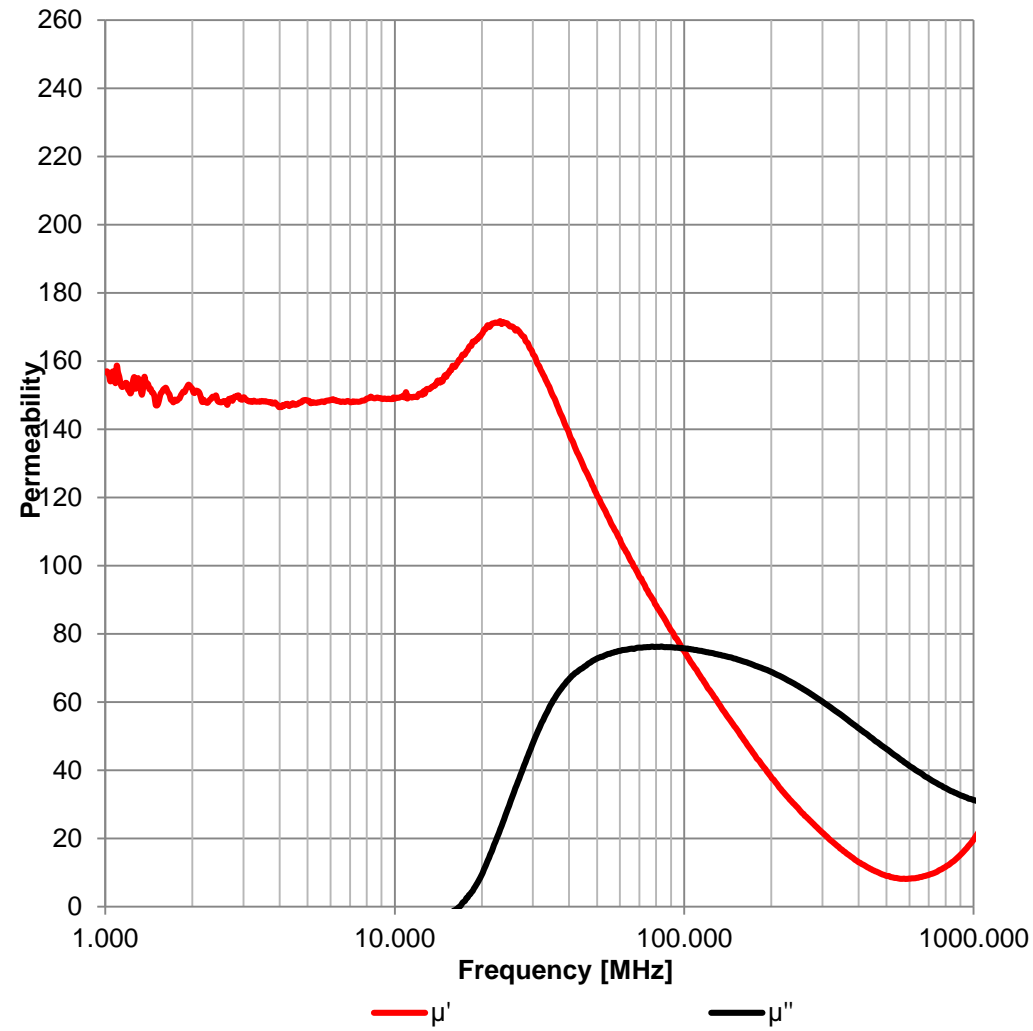

#### Product specific:

- Cleaning and Washing:



#### Packaging:


