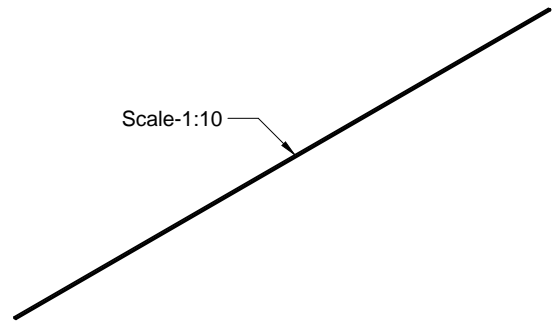
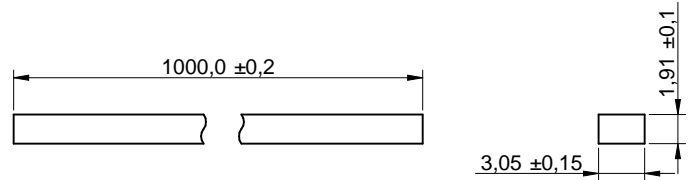



#### Packaging:


